**TO THE CITY COUNCIL**

Dear Councilors:

I transmit herewith for your approval an Order that will amend the Gender Inclusion Ordinance to incorporate best practices regarding gender identity inclusion.

Chapter VI Section 6-11 of the City Code currently requires all city-issued forms that collect information about gender or sex to include a non-binary option ("X") for respondents to select. A combined effort by the Department of Innovation & Technology, the Equity & Inclusion Cabinet, and the People Operations Cabinet has yielded a more comprehensive standard informed directly by research conducted with Boston's LGBTQ+ community and written to foster implementation by City departments and agencies. The amendment modifies Section 6-11 to allow for the use of the latter standard.

Please note that the amendment does not alter the portion of the Gender Inclusion Ordinance that mandates city forms to allow an individual to indicate a chosen name if different from their legal name.

I urge this Honorable body to adopt this Order so the City can incorporate best practices regarding gender identity inclusion.

**AN ORDINANCE AMENDING THE CITY CODE RELATED TO GENDER  
INCLUSION ON CITY FORMS**

**Be it ordained by the City Council of Boston as follows:**


**Section 1.**

City of Boston Code, General Services, Chapter VI, Section 6-11 is hereby amended by striking the paragraph that begins with the words "All existing and future City-issued forms" and inserting in place thereof the following paragraph:

"All existing and future City-issued forms, documents, and certificates that provide for a gender or sex designation, shall do so using language that includes all genders and family structures. All forms shall include an option where an individual may designate their chosen name if different from their legal name."

**Section 2.**

Section 1 of this ordinance shall take effect upon passage.

including the payment of all costs incidental or related thereto (the "Project"), which proposed repair Project would materially extend the useful life of the schools and preserve assets that otherwise are capable of supporting the required educational program, and for which the City of Boston has applied for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of the Public Facilities Department on behalf of Boston Public Schools.

To meet said appropriation the Collector-Treasurer, with the approval of the Mayor, is hereby authorized to borrow said amount under the provisions of Chapter 44 of the General Laws, as amended or supplemented, or any other enabling authority, and from time to time, issue bonds, notes or certificates of indebtedness of the City up to said amount; that this order shall constitute a declaration of official intent of the City pursuant to Treasury Regulations Section 1.150-2(e) to reimburse expenditures for such projects made from funds established for such purpose as permitted by statute from proceeds of debt incurred by the City pursuant to this order; and that pursuant to Section 12(b) of Chapter 643 of the Acts of 1983 as amended, if any part of the proceeds of sale of any bonds or notes or other obligations issued by the City under this order remains unexpended after the work or purpose for which such bonds, notes or other obligations are issued is completed, such proceeds are hereby appropriated and may be applied by the Collector-Treasurer and City Auditor, at the direction of the Mayor, to pay the principal of, and premium and/or interest on such bonds, notes or other obligations or on any debt of the City.

The City of Boston acknowledges that the MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any Project costs the City of Boston incurs in excess of any grant that may be approved by and received from the MSBA on account of the Project shall be the sole responsibility of the City of Boston; Provided further that any grant that the City of Boston may receive from the MSBA for the Project shall not exceed the lesser of (1) 60.42% of eligible, approved project costs, as determined by the MSBA, or (2) the total maximum grant amount determined by the MSBA; and that the amount of borrowing authorized pursuant to this vote shall be reduced by any grant amount set forth in the Project Funding Agreement relating to the Project that may be executed between the City of Boston and the MSBA.





On September 12, 2023, the Boston Landmarks Commission unanimously voted to designate the Nazzaro Community Center in the North End as a Landmark under the provisions of Chapter 772 of the Acts of 1975, as amended.

The Nazzaro Community Center (previously called either the North Bennet Street Public Bath House and Gymnasium or the North End Bath House) was constructed in 1906-1908 and opened in 1910. Designed in 1903 by the Boston-based architectural firm of Maginnis, Walsh and Sullivan, the building is an exceptional example of early 20<sup>th</sup>-century Beaux-Arts Renaissance Revival Style architecture with its detailed ornamentation indicative of the Arts and Crafts movement. The City of Boston constructed the building as one of 12 municipally run bathhouses in response to a public health policy implemented in 1895.

Situated in the heart of the North End section of Boston, the North Bennet Street Public Bath House and Gymnasium with the adjacent Polcari Park at 45 Prince St. (established in 1897 as Prince Street Playground) served the area's growing immigrant population in the early 20th century. The bathhouse operated until the 1970s when it was officially closed, having fallen into a state of neglect. In 1985, the Boston Centers for Youth & Families (BCYF) acquired the building and reopened it as the Nazzaro Community Center.

The Boston Landmarks Commission asks that you give full consideration to the designation of the Nazzaro Community Center in the North End as a Boston Landmark.

### **GENERAL CHARACTERISTICS OF THE SITE:**


The Nazzaro Community Center was designed in 1903 by the noted Boston-based architectural firm of Maginnis, Walsh, and Sullivan, and is an exceptional example of early 20<sup>th</sup>-century Beaux-Arts Renaissance Revival Style architecture with its detailed ornamentation indicative of the Arts and Crafts movement. The building is formally finished on three sides: the façade (southeast), the North Bennet Street side (northeast) elevation, and park-side (southwest) elevation. The community center directly abuts a structure on the northwest elevation of the building. The three-story building rises from a raised basement; it is indicative of palazzo-style architecture and consists of brick and granite construction with terra-cotta ornamentation. A low-pitched deck on a hipped slate roof and two brick chimneys are hidden from the street-level view by an elaborate metal cornice. Each elevation displays aspects of symmetry and is dominated by the third story. The park-side elevation has a tower that extends off the rear of the building; it functions as a stairwell.

The noteworthy sculptor Hugh Cairns was commissioned in 1907 to sculpt the lunette located above the entrance of the vestibule; the bas-relief sculpture represents Boston's connection with land and sea by situating the God Neptune and Mercury on either side of the City insignia, encased in a wreath.

The Nazzaro Community Center was originally known as the North Bennet Street Bathhouse and Gymnasium and later named in honor of Michael A. Nazzaro Jr., a former state representative. The public building was constructed in the early 20th century as part of the City of Boston's efforts to improve the health and well-being of its population, as the combined effects of industrialization, urbanization, and poverty during the 19th century contributed to high rates of endemic and epidemic disease in Boston and throughout the North End. The building continues to be an extraordinary testament to both architectural and social history.

**TO THE CITY COUNCIL**

Dear Councilors:

I hereby transmit for your approval an Ordinance to support public safety as the City doubles down on our public health-led approach to the crises of mental health, substance use, and unsheltered homelessness concentrated in the area of Massachusetts Avenue and Melnea Cass Boulevard.

The Ordinance will establish a prohibition against unsanctioned use of tents, tarps, and similar temporary structures on public property and in the public way which have been shielding much of the dangerous activity in the area and undermining the ability of providers to safely and effectively deliver services. Boston Police would have the authority to enforce on the condition that individuals are offered shelter and transportation to services, as well as storage for personal belongings. This Ordinance is one component of a three-part approach that will also include expanding overnight low-threshold housing and shelter capacity, and a coordinated response operation to return Atkinson Street to standard roadway usage and deliver outreach services citywide to prevent new encampments in other neighborhoods.

Over the last year and a half, we have built up a solid infrastructure of low-threshold supportive housing with treatment, care, and case management for a successful pathway to recovery. Since January 2022, more than 500 people from the Mass and Cass area have been served at the City's low-threshold supportive housing sites, and 149 people have achieved the stability, health, and recovery to move on to permanent housing. The State has also begun to create low-threshold supportive housing modeled after Boston's progress in other municipalities, with six locations so far, and the Suffolk County District Attorney's Office and State Legislature have partnered to significantly expand a diversion program in the court system to facilitate recovery. The Ordinance will help us double down on this coordinated approach by addressing the public safety of patients, workers, and residents in the area so we can continue improving our outreach and services.

I urge your Honorable Body to take swift and urgent action to approve this ordinance in order for City officials and provider partners to finalize preparations and begin implementation well before the colder temperatures of late fall and winter.

### AN ORDINANCE RELATING TO UNLAWFUL CAMPING ON PUBLIC PROPERTY

**WHEREAS:** The humanitarian crisis of homelessness, substance use, and mental health concentrated near Massachusetts Avenue and Melnea Cass Boulevard has been one of the most pressing and complex challenges in the City of Boston for nearly a decade; and

**WHEREAS:** Since January 2022, the City of Boston has achieved substantial progress through a coordinated response focused on public health—building an infrastructure including nearly two hundred units of low-threshold supportive housing; expanded shelter capacity; a case management system; a family reunification program; daily street cleanings; and partnerships with community organizations for public health, outreach, and workforce development to facilitate recovery—that has served more than 500 individuals from the Mass and Cass area in the City’s low-threshold housing sites, with 149 individuals transitioning into permanent housing; and

**WHEREAS:** Unsanctioned temporary structures, including tents and tarps, undermine the City of Boston’s ability to maintain adequate access to public property for individuals of all abilities, an unobstructed path of travel as required by law, and a safe and hazard-free environment for all individuals; and

**WHEREAS:** Tents and tarps are often fire hazards that hinder fire personnel and first responders in the event of an emergency, create visual barriers that can impair the ability of outreach workers and first responders to deliver public health and social services, and that limit access or conceal criminal behavior, which directly impacts public safety and diminishes the Boston Police Department’s ability to respond to individuals in need or directly address criminal activity; and

**WHEREAS:** Any delay to removing these structures presents an immediate potential harm to individuals inside the structures and to members of the public in the vicinity due to the public health and safety issues listed above; and

**WHEREAS:** By restricting unlawful camping on public property, the City seeks to curtail obstacles to public safety and public health in order to enhance the continued

delivery of outreach and services for health, housing, and recovery; *NOW  
THEREFORE*

*Be it ordained by the City Council of Boston as follows:*

**SECTION 1.** City of Boston Code, Ordinances, is hereby amended in *Chapter XVI* by adding the following after the existing Section 16-64:

**16-65 AN ORDINANCE RELATING TO UNLAWFUL CAMPING ON PUBLIC  
PROPERTY**

**16-65.1 Definitions.**

For the purpose of Sections 16-65.2 through 16-65.10, the following definitions shall apply:

"To camp" means to pitch, erect, or occupy a Campsite or to use Camp Materials, or both, for the purpose of, or to facilitate, outdoor sheltering, either temporarily or permanently.

"Campsite" means any place where a tent, tarp, or other temporary structure is established for the purpose of maintaining an outdoor shelter.

"Camp Materials" means items used to establish or facilitate occupancy of a Campsite, including tents, tarps, or other temporary structures, as well as large furniture, stoves, and other cooking instruments.

"City Storage Program Policy" refers to the City's written policy for storage of eligible property.

"Emergency Shelter Space" means a City-authorized location providing temporary shelter or alternative sleeping space practically available to persons experiencing homelessness. Emergency Shelter Space shall be at a shelter, housing accommodation, or alternative sleeping space that maintains policies and procedures for accommodations under the Americans with Disabilities Act.

"Period When Shelter Is Unavailable" means a length of time in which there is no Emergency Shelter Space available to individuals experiencing homelessness in Boston.

## **16-65.2 Purpose**

It is the purpose of this Ordinance to promote public health, public safety, general welfare, and the economic health and well-being of Boston, its workers, visitors, and residents, including individuals experiencing homelessness, by prohibiting unsanctioned camping and the dangerous and unsafe conditions surrounding such Campsites.

The Ordinance seeks to improve access to housing and recovery services by restoring access to public spaces, the public right-of-way, and curtailing the existence of Campsites that shield drug trafficking, human trafficking, weapons, fire hazards, violence and other criminal activity, and that create conditions for large crowds to congregate. It is also the purpose of this Ordinance to protect the rights of individuals related to their personal property and to treat such property with respect and consideration.

This Ordinance shall apply to all Campsites and camping on public property, including, but not limited to streets, sidewalks, and public right-of-ways.

## **16-65.3 Unlawful Camping on Public Property**

It is unlawful for any person to camp or maintain a Campsite or Camp Materials in or on any public property or in the public right-of-way, including but not limited to any street, sidewalk, school or public park, unless specifically authorized or during a Period When Shelter Is Unavailable.

## **16-65.4 Restrictions on Unlawful Camping During A Period When Shelter Is Unavailable**

The prohibition against Campsites and camping shall not apply during a Period When Shelter Is Unavailable.

City officials shall maintain, and regularly revise, a shelter list that is communicated to the Boston Police Department and other City departments for the purpose of identifying available shelter space.

During a Period When Shelter Is Unavailable, or when a Campsite is specifically authorized, a Campsite or use of Camping Materials must comply with existing state and local laws to ensure the public health and safety of those in and around the Campsite.

The Mayor's Office of Housing, in consultation with the Boston Police Department and the Inspectional Services Department, is hereby authorized to promulgate any additional restrictions relative to the time, place, and manner for camping, and density of Campsites, during any Period When Shelter Is Unavailable in order to advance public safety, maintain access to the public right-of-way, and support the effective operation of facilities such as schools, shelters, and health care institutions during such periods.

### **16-65.5 Offer of Shelter**

In the event of a violation of this Ordinance, the City shall provide, or cause to be provided, an offer of available Emergency Shelter Space to an individual experiencing homelessness and, when requested, transportation to the available Emergency Shelter Space.

Each Emergency Shelter Space offered to an individual shall be at a shelter, housing accommodation, or alternative sleeping space that maintains policies and procedures for accommodations under the Americans with Disabilities Act.

### **16-65.6 Storage of Property**

In the event of a violation of this Ordinance, the City shall offer and provide storage for personal belongings consistent with the City Storage Program Policy. The City Storage Program Policy shall provide for the storage of eligible property, define property that is eligible for storage, and provide clear instructions on how individuals may regularly access and recover their belongings.

The City Storage Program Policy will also provide that for property at a Campsite that is not claimed by any person, City staff will assess whether the property is abandoned property or an individual's temporarily unattended property, including through inquiry to individuals in the area and a reasonable attempt to identify the property owner. Property determined to pose an immediate health or safety risk is subject to immediate disposal.

The City shall store temporarily unattended eligible property under the City Storage Program Policy. For temporarily unattended property that is not eligible for City storage, the City will either post notice for 24 hours prior to removal of the unattended property not eligible for City storage or will temporarily store the unattended property and post notice as to how to recover it.

City officials shall provide a written copy of the City Storage Program Policy when providing an offer of storage, which shall be made available in each language that meets a language access need in Boston as most recently determined by the Office of Language and Communications Access.

In the event that an individual chooses to leave the area without their belongings upon learning of a violation of this Ordinance, City staff shall store eligible property in line with the City's Storage Program Policy.

The City shall maintain a feedback system on the City Storage Program through which individuals can complete a form either online or by requesting a physical form from a City employee or agent. These feedback forms can be used to submit general feedback or to submit a claim for reimbursement for lost property.

### **16-65.7 Removal**

Once the City has engaged an individual as described in Section 16-65.5 Offer of Shelter and Section 16-65.6 Storage of Property, and the individual has either accepted or declined the offers, the City shall remove any Campsite and/or Camp Materials not removed by the individual.

### **16-65.8 Notice to Individuals**

Immediately upon passage, the City shall distribute leaflets to individuals and post weather-resistant signs in locations with a concentrated number of Campsites to provide additional actual notice of this Ordinance and the effective date. The leaflet shall contain a written copy of this Ordinance, a written copy of the City Storage Program Policy, and written copies of additional resources.

Upon the effective date of the Ordinance, once the City has engaged an individual as described in Section 16-65.5 Offer of Shelter and Section 16-65.6 Storage of Property, no further notice is required to enforce this Ordinance.

When the City notifies an individual located in any Campsite that a Period When Shelter Is Unavailable has ended, the individual shall have forty-eight (48) hours to remove their Camping Materials.

### **16-65.9 Penalty For Violations**

Individuals in violation of this Ordinance who refuse to remove or allow for removal of the Campsite or Camp Materials as described in Section 16-65.7, or who reestablish a Campsite following removal pursuant to Section 16-65.7, shall be subject to penalties. This Ordinance shall be enforced by the Boston Police Department as well as any sworn law enforcement agency empowered to make an arrest within the jurisdictional boundaries of the City of Boston. Any of the following penalties may apply:

- (a) All enforcement methods authorized by law, including G. L. c. 40, § 21, non-criminal disposition authorized by G. L. c. 40, § 21D, or enforcement authorized by G. L. c. 272, § 59 (Ordinances or Regulations Relating to Streets, Reservations, or Parkways; Alcoholic Beverages; Profanity; Arrest Without Warrant) if the Boston Police or other duly authorized officer on scene determines a violation of G. L. c. 272, § 59 has occurred in their presence;
- (b) The fine for each offense shall be Twenty-Five dollars (\$25.00);
- (c) This Section shall go into effect seven (7) days after the date of passage to permit any individuals located in any Campsite to remove Camping Materials in order to comply with this Ordinance.

#### **16-65.10 Severability**

The provisions in this Ordinance are severable. If any part or provision of this Ordinance is held invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected by such holding and shall continue to have full force and effect.

### RESOLUTION RECOGNIZING OCTOBER AS DOMESTIC VIOLENCE AWARENESS MONTH

**WHEREAS,** Domestic Violence Awareness Month is a time to raise awareness about domestic violence, support survivors, promote prevention efforts, encourage early intervention, and offer support to those affected; *and*

**WHEREAS,** Domestic violence can happen to nearly anyone, as one in four women and one in seven men will experience domestic violence during their lifetime. Certain groups will experience domestic violence at higher rates than others, such as Black women at 2.5x higher than that of white women, and Indigenous women, who experience the highest rates of domestic violence, at five times that of white women; *and*

**WHEREAS,** Gun violence prevention is domestic violence prevention, as the presence of a gun during a domestic violence situation increases the risk of homicide by 500%, and over half of all domestic violence homicides involve guns, and between 2014 - 2019, 59% of mass shootings were domestic related, and in 68% of mass shootings, the shooter either killed an intimate partner/family member or had a prior history of domestic violence; *and*

**WHEREAS,** Domestic violence has severe and long-lasting physical, emotional, and psychological consequences on victims and their communities, and through education, advocacy, and community engagement, we can promote awareness and change attitudes towards domestic violence, ultimately creating a safer and more supportive environment for survivors; *and*

**WHEREAS,** All residents are encouraged to educate themselves about the signs of domestic violence, to offer assistance to those in need, and to help foster a society where domestic violence is not tolerated; ***NOW, THEREFORE BE IT***

**RESOLVED:** That the Boston City Council go on record declaring October as Domestic Violence Awareness Month, and support federal, state, and local initiatives that allocate more resources, funding, and aid for programs and strategies that address domestic violence.

WING O. HOM**

- WHEREAS:** Wing O. Hom was born on January 10, 1924, and resided in Boston, Massachusetts. U.S. Army Private Hom enlisted in the Army in Boston and served in World War II, and in February of 1944, Hom was assigned to B Company, 7th Infantry Regiment, 3rd Infantry Division; *and*
- WHEREAS:** On February 2, 1944, Hom went missing while his unit was engaged in defensive fighting against German Forces near the town of Cisterna di Latina, Italy. After his body was not recovered and he wasn't reported as a prisoner of war, the U.S. War Department declared Hom dead on February 3, 1944; *and*
- WHEREAS:** In 1946, a set of remains were found three miles west of Cisterna. Unable to positively identify the remains, they were interred at the Sicily-Rome American Cemetery; *and*
- WHEREAS:** A U.S. Defense POW/MIA Accounting Agency (DPAA) historian believed that the set of remains could possibly be Private Hom's; *and*
- WHEREAS:** In September 2021, the remains at Sicily-Rome American Cemetery were disinterred and sent to the DPAA laboratory at Offutt Air Force Base, Nebraska. The remains were formally identified on April 6, 2023; *and*
- WHEREAS:** Hom's name is recorded on the Walls of the Missing at Sicily-Rome American Cemetery where a rosette will be placed next to his name indicating he has been accounted for; *and*
- WHEREAS:** After 79 years of war, death, and unmarked burial on foreign soil, the remains of Private Wing O. Hom were laid to rest in Brooklyn on October 11, 2023; *and*
- WHEREAS:** Private Wing O. Hom was posthumously awarded a Purple Heart and a Bronze Star; *AND NOW  
THEREFORE BE IT*
- RESOLVED:** That the Boston City Council honors the heroic service and tremendous sacrifice endured by U.S. Army Private Wing O. Hom on behalf of the American People by designating a Hero Square at the intersection of Beach Street and Hudson Street, in the Chinatown neighborhood of Boston, Massachusetts.

### RESOLUTION SUPPORTING THE BOSTON TRANSPORTATION DEPARTMENT'S EFFORTS TO TRANSFORM NEW EDGERLY ROAD INTO A PEDESTRIAN PLAZA

*WHEREAS,* The predominant road users throughout much of District 8 are pedestrians, and the City is committed to ensuring all modes of transportation are safe, including by enhancing and improving the pedestrian experience and pedestrian safety; *and*

*WHEREAS,* Fatal pedestrian crashes statewide increased by 35 percent between 2021 and 2022 according to a report by WalkBoston (WalkMassachusetts), an organization aimed at making walking safer and easier in Massachusetts to encourage better health, a cleaner environment, and more vibrant communities; *and*

*WHEREAS,* The City's Safety Surge aims to slow traffic on residential streets through installation of zones of speed humps on eligible neighborhood streets, the redesign of intersections for safety, and new guidelines for the City's traffic signals; *and*

*WHEREAS,* Vision Zero Boston is the Boston Transportation Department's commitment to focus the City's resources on proven strategies to eliminate fatal and serious traffic crashes in the city by 2030 by improving safety for all road users including the most vulnerable; *and*

*WHEREAS,* Centering walkability and pedestrian safety means more than just preventing crashes and pedestrian injuries; it also means pedestrian placemaking as a vital component of our transportation infrastructure, and an opportunity to foster community connection; *and*

*WHEREAS,* New Edgerly Road is a small, redundant slip-lane in the East Fenway, that hosts a high volume of pedestrian traffic compared to car traffic and specific traffic counts taken by Councilor Bok's office on a weekday evening found that, within

an hour, 51 individuals accessed the area by car and 413 individuals accessed the area on foot; *and*

*WHEREAS,* The Fenway Civic Association has long advocated for slow streets safety measures on neighborhood streets bounded by Hemenway Street, Massachusetts Avenue, Boylston Street, and Forsyth Way including the pedestrianization of New Edgerly Road; *and*

*WHEREAS,* Councilor Bok and the District 8 Office hosted three successful pedestrian pilots of this space between 2022 and 2023, which, through coordination with neighborhood organizations like the Fenway Civic Association, Fenway Community Development Corporation, and Fenway Community Center saw the street activated as a pedestrian plaza with musical performances, art installations, food, and games for hundreds to enjoy *and*

*WHEREAS,* Councilor Bok and the District 8 Office gathered public feedback on the proposed pedestrianization of New Edgerly Road that illuminated robust community support as demonstrated by over 100 letters of support for the proposal sent to Chief Jascha Franklin-Hodge and the majority of survey respondents outlining a preference for permanent pedestrianization of New Edgerly Road; *and*

*WHEREAS,* The abutting businesses and properties have been involved in the conversation to transform this roadway into a pedestrian plaza with the Boston Transportation Department and the District 8 Council Office and have been supportive of the effort; *and*

*WHEREAS,* Transforming this street space to plaza space would enhance the adjacent Harry Ellis Dickson Park, which the Fenway Civic Association has been the caretaker of since 2010, raising thousands of dollars for its care, implementing irrigation features, cleaning the public artwork, and collaborating with neighboring businesses to ensure the park is accessible and provides respite for neighbors; *and*

*WHEREAS,* Whereas permanent pedestrianization of New Edgerly Road is 1) widely supported by residents of the East Fenway; 2) expressly requested by the neighborhood civic association; and 3) perfectly aligned with the City's transportation goals; *NOW, THEREFORE BE IT*

*ORDERED:* That the Boston City Council recognize the efforts of the community and the Boston Transportation Department in supporting the permanent pedestrianization of New Edgerly Road.

**<sup>1</sup>Section 17E of Chapter 452 of the Acts of 1948 (as amended):**

*The mayor from time to time may make to the city council in the form of an ordinance or loan order filed with the city clerk such recommendations as he may deem to be for the welfare of the city. The City Council shall consider each ordinance or loan order so presented and shall either adopt or reject the same within sixty days after the date when it is filed as aforesaid. If such ordinance or loan order is not rejected within sixty days, it shall be in force as if adopted by the city council unless previously withdrawn by the mayor.*

**In effect after October 29, 2023,** Message and order for your approval an Ordinance to support public safety as the City doubles down on our public health-led approach to the crises of mental health, substance use, and unsheltered homelessness concentrated in the area of Massachusetts Avenue and Melnea Cass Boulevard. ### 2 - Section 17F of Chapter 452 of the Acts of 1948 (as amended):

*The city council may at any time request from the mayor specific information on any municipal matter within its jurisdiction, and may request his presence to answer written questions relating thereto at a meeting to be held not earlier than one week from the date of the receipt of said questions, in which case the mayor shall personally, or through a head of a department or a member of a board, attend such meeting and publicly answer all such questions. The person so attending shall not be obliged to answer questions relating to any other matter.*

### ***<sup>3</sup>Section 22 of Chapter 190 of the Acts of 1982:***

*Every order of the city council approving a petition to the general court pursuant to Clause (1) of Section 8 of Article 2 of the amendments to the Constitution of the Commonwealth shall be presented to the mayor who shall forthwith consider the same, and, within fifteen days of presentation, either approve it, or file with the city council a statement in detail of his reasons for not approving the same, including any objection based on form, on content, or both; provided, that no such order shall be deemed approved or in force unless the mayor affixes his signature thereto.*

## *Matters in Committee*

---

The following matters were previously filed with the City Council and have been referred to a committee. Matters in committee can be brought back before the City Council pursuant to City Council Rule 24. The following *definitions* describe different types of matters in committee:

- Ordinances:*** Local laws enacted by the Boston City Council and the Mayor that become part of the City Code of Ordinances.
- Loan Orders:*** Authorization for the City of Boston to incur debt and expend money for projects, purchases, or other obligations.
- Orders:*** Directives that authorize action. Orders are legally binding but are not part of the City Code of Ordinances.
- Home Rule Petitions:*** Requests for special acts that concern a particular municipality. Home Rule Petitions require approval of the Boston City Council and Mayor, as well as passage by the state legislature.
- Order for a Hearing:*** A formal request sponsored by a councilor that a committee of the Boston City Council conduct a hearing about a particular matter, issue, or policy that impacts the City of Boston. An Order for a Hearing is not a law and is not voted on by the City Council. The only action concerning an Order for a Hearing that can be taken at a City Council meeting is the administrative action of placing it on file.
- Legislative Resolution:*** A recommendation concerning policy issues that may urge action on particular matters. Legislative resolutions have no legal effect. Legislative resolutions represent a particular position or statement by a Councilor, Councilors, or the City Council as a whole.


