A regular meeting of the City Council of the City of Boston was held in the Christopher A. Iannella Chamber, City Hall on Wednesday, June 4, 2025 at 12:08 PM.

President Louijeune in the Chair. All councilors present.

Jullianne Doherty Lee, Executive Director of the Mayor's Office of LGBTQ+ Advancement, delivered the invocation and the meeting was opened with the pledge of allegiance.

The Chair moved to adopt the minutes from the May 21, 2025 meeting. Motion Prevailed.

1132 Message and order authorizing the City of Boston to accept and expend the amount of One Million Dollars (\$1,000,000.00) in the form of a grant, for the Federal FY25 Nutrition Services Incentive Program, awarded by the U.S. Department of Health and Human Services, passed through the MA Executive Office of Elder Affairs, to be administered by the Age Strong Commission. The grant will fund the Age Strong Commission's nutrition program that delivers meals to homes of older adults and at congregate sites in the City of Boston.

The rules were suspended; the order was passed.

1133 Message and order authorizing the City of Boston to accept and expend the amount of Five Hundred Fifty Thousand Dollars (\$550,000.00) in the form of a grant awarded by the Cummings Foundation. The grant will fund the City of Boston's violence prevention work including activations and events, community outreach, block parties and the Youth Options Unlimited program, and other efforts consistent with the City's summer safety plan and Plan to End Violence.

On motion of Councilor Coletta Zapata, the report was accepted; the ordinance was passed; yeas 11, not present 2 (Mejia, Worrell).

Councilor Worrell, on behalf of the Committee on Ways and Means, submitted the following:

0822 On the message and order, approving the Annual Appropriation and Tax Order for FY2026, the committee submitted a report recommending that the order ought to pass in a new draft.
The report was accepted, the order was passed in a new draft; yeas 13.

0823 On the message and order, approving the Annual Appropriation for the School Department for FY2026, the committee submitted a report recommending that the order ought to pass.
The report was accepted, the order was passed; yeas 11, nays 2 (Mejia, Murphy).

0824 On the message and order, approving an appropriation of Forty Million Dollars (\$40,000,000.00) to the Other Post-Employment Benefits (OPEB) Liability Trust Fund authorized under Chapter 32B, §20, as added by Chapter 479 of the Acts of 2008. The latest available OPEB actuarial valuation as of June 30, 2023 estimated the City's unfunded liability at \$2.68 billion, the committee submitted a report recommending that the order ought to pass.
The report was accepted, the order was passed.

0825 On the message and order, approving an appropriation of Five Million Dollars (\$5,000,000.00) from the City's Capital Grant fund to address the impact of transportation network services on municipal roads, bridges, and other transportation infrastructure or any other public purpose substantially related to the operation of transportation network services in the city. Such funds will be transferred and credited to the Capital Grant Fund from revenue received from the Commonwealth Transportation Infrastructure Enhancement Trust Fund, the committee submitted a report recommending that the order ought to pass.
The report was accepted, the order was passed.

- 0826** On the message and order, approving an appropriation order in the amount of Three Million Five Hundred Thousand Dollars (\$3,500,000.00) from Surplus Property Disposition Fund, credited to the Capital Fund for planning, design, and construction, for Dorchester Field House, General Parks Improvements, Restroom Facility Improvements at the Boston Common, and the Municipal Animal Shelter, the committee submitted a report recommending that the order ought to pass.
The report was accepted, the order was passed.
- 0827** On the message and order, approving an appropriation order in the amount of Five Million Dollars (\$5,000,000.00) from the Parking Facility Fund, credited to the Capital Fund for planning, design, maintenance and construction, for the parking facilities, the committee submitted a report recommending that the order ought to pass.
The report was accepted, the order was passed.
- 0828** On the message and order, approving an appropriation order in the amount of Two Hundred Sixty-Six Million One Hundred Thousand Dollars (\$266,100,000.00) for various capital improvement purposes for city departments including the Boston Center for Youth and Families, Boston Housing Authority, Boston Planning and Development Agency, Boston Public Library, Innovation and Technology, Environment, Fire, Mayor's Office of Housing, Office of Arts and Culture, Parks and Recreation, Police, Property Management, Public Health Commission, Public Works, and the Transportation Department, the committee submitted a report recommending the order ought to be read once and passed; yeas 11, nays 2 (Breadon, Mejia).
Assigned for further action.
- 0829** On the message and order, approving an appropriation order in the amount of One Hundred Ninety-Six Million Nine Hundred Thousand Dollars (\$196,900,000.00) for various capital improvements purposes for the Boston Public Schools, the committee submitted a report recommending the order ought to be read once and passed; yeas 11, nays 2 (Breadon, Mejia).
Assigned for further action.
- 0830** On the message and order, authorizing the City of Boston to enter into one or more leases, lease-purchase or installment sales agreements in Fiscal Year 2026 in an amount not to exceed Forty Million Dollars (\$40,000,000.00). These funds are to be used by various City departments for the acquisition of equipment in furtherance of their respective governmental functions. The list of equipment includes: computer equipment (hardware and software), motor vehicles and trailers, ambulances, firefighting equipment, office equipment, telecommunications equipment, photocopying equipment, medical equipment, school and educational equipment, school buses, parking meters, street lighting installation, traffic signal equipment and equipment functionally related to, and components of the foregoing, the committee submitted a report recommending the order ought to be read once and passed; yeas 13.
Assigned for further action.

- 0831** On the message and order, authorizing a limit for the Boston Public Schools Revolving Fund for Fiscal Year 2026 to support the maintenance and repair for BPS facilities, including custodial and utility costs for extended building time, floor refinishing, landscaping and building repairs. Receipts from Lease, Permit for Use and Parking Fees for BPS facilities will be deposited in the fund. BPS facilities will be the only unit authorized to expend from the fund and such expenditures shall not exceed Two Million Dollars (\$2,000,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.
- 0832** On the message and order, authorizing a limit for the Boston Public Schools Revolving Fund for the Fiscal Year 2026 for Boston Public School Transportation costs, including bus and public transportation costs. This revolving fund shall be credited with revenue received by Boston Public School Department for the provision of transportation to groups and entities for field trips and activities other than transportation to and from school. Receipts and resulting expenditures from this fund shall not exceed One Hundred Fifty Thousand Dollars (\$150,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.
- 0833** On the message and order, authorizing a limit for the Boston Public Schools Revolving Fund for Fiscal Year 2026 to repair and purchase Boston Public Schools computer technology, including computers, mobile devices, and instructional software. This revolving fund shall be credited with any and all receipts from equipment sales and repair fees for Boston Public School technology. Receipts and resulting expenditures from this fund shall not exceed Two Million Dollars (\$2,000,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.
- 0834** On the message and order, authorizing a limit for the Mayor's Office of Tourism Revolving Fund for Fiscal Year 2026 to purchase goods and services to support events and programming on and around City Hall Plaza to advance tourism and promote participation in public celebrations, civic and cultural events. This revolving fund shall be funded by receipts from payments for the use of City Hall Plaza pursuant to City of Boston Code, Ordinance, 11-7.14. The Mayor's Office of Tourism will be the only unit authorized to expend from the fund and such expenditures shall be capped at One Hundred Fifty Thousand (\$150,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.

- 0835** On the message and order, authorizing a limit for the Environment/Conservation Commission Revolving Fund for the Fiscal Year 2026 for the purpose of securing outside consultants including engineers, wetlands scientist, wildlife biologists or other experts in order to aid in the review of proposed projects to the Commission, per the City's ordinance protecting local wetland and promoting climate change adaptation. The revolving fund shall be funded by receipts from fees imposed by the Commission for the purpose of securing outside consultants. The Environment Department will be the only department authorized to expend from the fund and such expenditures shall be capped at Fifty Thousand Dollars (\$50,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.
- 0836** On the message and order, authorizing a limit for the Distributed Energy Resource Revolving Fund for Fiscal Year 2026 to facilitate the purchase of offsets of greenhouse gas emissions which shall be associated with a portion of the electricity consumed by the City annually; and to operate, maintain, monitor and expand the City's existing solar arrays and Boston Public Schools' combined heat and power facilities. This revolving fund shall be credited with any and all receipts from the sale of renewable and alternative energy certificates and demand response program revenues produced by combined heat and power units located at Boston Public Schools sites and solar renewable energy certificates produced by the City's photovoltaic arrays. Receipts and resulting expenditures from this fund shall not exceed One Hundred Fifty Thousand Dollars (\$150,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.
- 0837** On the message and order, authorizing a limit for the Boston Centers for Youth and Families (BCYF) Revolving Fund for Fiscal Year 2026 to pay salaries and benefits of employees and to purchase supplies and equipment necessary to operate the City Hall Child Care. This revolving fund shall be credited with any and all receipts from tuition paid by parents or guardians for children enrolled at the center. Receipts and resulting expenditures from this fund shall not exceed Nine Hundred Thousand Dollars (\$900,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.
- 0838** On the message and order, authorizing a limit for the Law Department Revolving Fund for Fiscal Year 2026 to purchase goods and services for repairs to city property. This revolving fund shall be funded by receipts from recoveries for damages to city property caused by third parties. The Law Department will be the only unit authorized to expend from the fund and such expenditures shall be capped at Three Hundred Thousand Dollars (\$300,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.

- 0839** On the message and order, authorizing a limit for the Boston Police Department Revolving Fund for Fiscal Year 2026 to pay salaries and benefits of employees and to purchase supplies and equipment necessary to operate the Police Department Fitness Center. Revenue for this fund is derived from monthly membership fees. Receipts and resulting expenditures from this fund shall not exceed One Hundred Twenty-Five Thousand Dollars (\$125,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.
- 0840** On the message and order, authorizing a limit for the Boston Police Department Revolving Fund for Fiscal Year 2026 to support the Canine Unit's training program for officers and police dogs from non-City of Boston law enforcement agencies. The Special Operating Division will charge tuition and other fees to outside law enforcement agencies for the Canine Unit. The tuition and other fees by outside agencies will be used to purchase training equipment, certify instructors, update facilities and provide funds for other training needs not otherwise budgeted. The Special Operations Division will be the only unit authorized to expend from the fund and such expenditures shall be capped at One Hundred Twenty-Five Thousand Dollars (\$125,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.
- 0841** On the message and order, authorizing a limit for the Mayor's Office of Arts and Culture Revolving Fund for Fiscal Year 2026 to purchase goods and services to support public art to enhance the public realm throughout the City of Boston. This revolving fund shall be funded by receipts from easements within the public way granted by the Public Improvement Commission. The Mayor's Office of Arts and Culture will be the only unit authorized to expend from the fund and such expenditures shall be capped at Eight Hundred Thousand Dollars (\$800,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.
- 0842** On the message and order, authorizing a limit for the Mayor's Office of Arts and Culture Revolving Fund for Fiscal Year 2026 to purchase goods and services to support the operation of the Strand Theatre. This revolving fund shall be funded by receipts from rental fees for the use of the Strand Theatre. The Mayor's Office of Arts and Culture will be the only unit authorized to expend from the fund and such expenditures shall be capped at Three Hundred Thousand Dollars (\$300,000.00), the committee submitted a report recommending that the order ought to pass.
The report was accepted; the order was passed.

Pursuant to Section 53F 3/4 of Chapter 44 of the General Laws, the funds may be used to support PEG access services, to monitor compliance with the cable franchise agreement, and for preparation of renewal of the franchise license, the committee submitted a report recommending that the order ought to pass.

0845 On the message and order, authorizing the appropriation of One Million Three Hundred Thousand Dollars (\$1,300,000.00) from the income of the George Francis Parkman Fund.
