WHEREAS: By law, the authority to grant exemptions under this section shall expire after two (2) years of acceptance unless extended by City Council vote; and

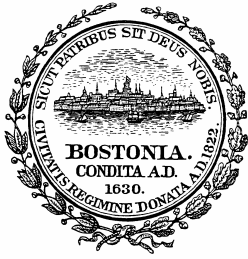
WHEREAS: The City renewed the program in Fiscal Years 2014, 2016, 2018; and 2020, and

WHEREAS: The exemption cannot be continued in Fiscal Year 2022 if the City Council does not vote to extend the program; be it therefore

ORDERED: That pursuant to Section 5(56) of Chapter 59 of the General Laws, the City of Boston shall extend the local option that offers members of the Massachusetts National Guard and reservists on active duty in foreign countries a real and personal property tax exemption up to 100% of the total tax assessed for an additional period of two (2) years beginning in Fiscal Year 2022.

REPORT OF COMMITTEE CHAIR

December 3, 2021

Dear Councilors:

The Committee on Ways and Means was referred the following docket for consideration:

Docket #1210, Message and order authorizing the City of Boston to extend the local option first adopted in 2012 that offers members of the Massachusetts National Guard and reservists on active duty in foreign countries a real and personal property tax exemption of up to 100% of the total assessed.

This matter was sponsored by Mayor Michelle Wu and referred to the Committee on December 1, 2021. The Committee held a public hearing on this docket on December 3, 2021.

Summary of Legislation

Docket #1210 would authorize the City of Boston to adopt a local option that allows the City to provide a property tax exemption up to 100% to homeowners who are active members of the National Guard or Military Reserve serving in a foreign country during the fiscal year. Initially adopted in 2012, Massachusetts General Laws requires City Council action to extend this tax relief program every two years.

Information Received at Hearing

Commissioner Nicholas Arieniello of the Assessing Department for the City of Boston testified at the hearing in support of the docket. He explained that passage of this docket would reauthorize the City of Boston to grant a property tax exemption of up to 100 percent to qualifying homeowners. Qualifying homeowners include members Massachusetts National Guard and reservists that have served overseas during the past fiscal year. He explained that this program has been reauthorized by the Council every two years since its initial adoption in 2012. In FY21, there have been no tax exemptions processed through this program compared to seven exemptions which were issued in FY20.

The Commissioner discussed spreading awareness for this and other tax relief programs through the Assessing Department which includes information provided by the Taxpayer Referral Assistance Center, notices sent out with third quarter tax bills, information available online, and coordination with the Veterans Services Department.

Committee Chair Recommended Action

As Chair of the Committee on Ways and Means, I recommend moving the listed docket from the Committee to the full Council for discussion and formal action. At that time, my recommendation to the full Council will be that the matter **OUGHT TO PASS**.







Required Fiscal Year 2023 Appropriation: **\$403,678,138**

This Commission is hereby furnishing you with the amount to be appropriated for your retirement system for Fiscal Year 2023 which commences July 1, 2022.

Attached please find summary information based on the present funding schedule for your system and the portion of the Fiscal Year 2023 appropriation to be paid by each of the governmental units within your system. Once again, we used the Early Retirement Incentive (ERI) bases determined previously, however the amortization period for each was extended to FY27. The ERI column also includes adjustments made due to the 2010 legislation regarding Boston teachers (credits for the crossover payment and additional FY11 payment) and the 2009 legislation regarding retired sheriffs of Suffolk County.

The figures in this memorandum and the attachments reflect the Board's current funding schedule plus the additional amortization of the cost of increasing the COLA base to \$15,000.

The current schedule is due to be updated by Fiscal Year 2023.

Six members, by statute, are appointed by the Mayor from a pool of applicants recommended by civil rights advocacy groups, youth organizations, neighborhood associations, and members of the Boston community with knowledge of law enforcement; *and*

WHEREAS: The Office of Police Accountability and Transparency Ordinance, City of Boston Code, Ordinances, Chapter XII, Section 12-6.8, states that the Mayor will appoint three members from three nominees per seat submitted by the Boston City Council; *NOW*

THEREFORE BE IT:

ORDERED: That the Boston City Council shall receive applications from interested persons which shall include a brief statement of the reasons for their interest and suitability as a member of the Civilian Review Board; *AND BE IT FURTHER*

ORDERED: That the appropriate committee of the Boston City Council hold a working session to review applications for the Civilian Review Board. Members of the Boston City Council shall come to a consensus on the nine nominees which will be submitted to the Mayor for consideration.

REPORT OF COMMITTEE CHAIR

November 29, 2021

Dear Councilors:

The Committee on Public Safety and Criminal Justice was referred the following docket for consideration:

Docket #0967, order regarding Civilian Review Board nominations.

This docket was sponsored by Councilors Matt O'Malley and Andrea Campbell, and was referred to the Committee on September 15, 2021.

Summary of Legislation

Docket #0967 was filed in furtherance of the City Council's obligations under City of Boston Code, Ordinances, Section 12-17.8, establishing a Civilian Review Board within the Office of Police Accountability and Transparency (OPAT) in the City of Boston. The City Council is charged with submitting nine nominations to the Mayor for appointment to three of the nine seats on the Civilian Review Board.

The Civilian Review Board consists of nine total members: six appointed by the Mayor from a pool of applicants recommended by civil rights advocacy groups, youth organizations, neighborhood associations, and members of the Boston community with knowledge of law enforcement; and three appointed by the Mayor from a pool of nine nominees submitted by the Boston City Council. Under the ordinance, Board members must be Boston residents, not current members of law enforcement, and the Board must include at least one member between the ages of 18-21. Board members each serve a term of three years (though initial appointees will serve staggered terms of 1, 2, and 3 years), and Board members cannot serve more than two consecutive three-year terms. Each member will be paid one hundred dollars per hour for their service, not to exceed fifty thousand dollars per year.

The duties of the Board as laid out by the ordinance include conducting an independent inquiry or investigation where necessary, into complaints made against the Boston Police Department (BPD); resolving complaints or matters not within the scope of review of the Internal Affairs Oversight Panel (IAOP); at the Board's discretion, reviewing, investigating and making recommendations with regard to allegations of disparate treatment by BPD in recruiting, hiring, promotion, discipline and termination of members of BPD; periodically evaluating alternative options and/or improvements to the civil service examination process; making recommendations

to the Police Commissioner regarding reviewed complaints or other matters before the Board; and convening at least once per quarter.

City Council Process for Nominations

The OPAT legislation charges the City Council with nominating three people for each of three seats the Mayor will fill with a City Council nomination. The City Council decided to proceed with an open process, through which any member of the public could apply for consideration for nomination. On July 21, 2021, the City Council opened to the public an applications portal, which ran through September 20, 2021. The City Council received 81 eligible applications. A working session was held on this docket on Friday, November 19, 2021.

Committee Chair Recommended Action

After thorough consideration of the 81 applications received by the City Council and the thoughtful recommendations of Council colleagues, as Chair of the Committee on Public Safety and Criminal Justice, I recommend forwarding the following nine nominees to the Mayor for consideration of appointment to the Civilian Review Board of the Office of Police Accountability and Transparency:



ORDER RELATIVE TO THE ADOPTION OF CLASSIFICATION IN THE CITY OF BOSTON IN FISCAL YEAR 2022

- WHEREAS,** The residents of Boston led the successful effort to amend our state Constitution to allow Classification for the purpose of taxation; *and*
- WHEREAS,** Boston was again at the forefront of the Legislature's enactment of Chapter 169 of the Acts of 2007, providing further relief to residential taxpayers; *and*
- WHEREAS,** Since adoption of the Constitutional Amendment, this Council has established a policy of utilizing Classification to tax residential properties at the lowest level permitted by state statute; *and*
- WHEREAS,** The Council has historically approved a residential exemption at the maximum level of savings for homeowners, which is thirty-five percent (35%) of Class One-Residential parcels per Chapter 59, section 5C, as amended; *and*
- WHEREAS,** The Classification policy and the Council's annual action to declare a residential exemption in the greatest amount permitted by the General Laws has resulted in substantial protection and savings for homeowners from the effects of revaluation; *and*
- WHEREAS,** Action in this regard for Fiscal Year 2022 must be taken prior to certification of the tax rate by the Department of Revenue; ***NOW, THEREFORE BE IT***
- ORDERED:** That pursuant to the General Laws, Chapter 40, section 56, the residential factor in the City of Boston for Fiscal Year 2022 shall be the minimum residential factor as determined by the Commissioner of Revenue pursuant to Massachusetts General Laws, Chapter 58, Section 1A; ***AND, BE IT FURTHER***
- ORDERED:** That pursuant to the General Laws, Chapter 59, section 5C, as amended, a residential exemption in the amount of value equal to thirty-five percent (35%) of the average assessed value of all Class One-Residential parcels in the City of Boston be, and hereby is, approved for Fiscal Year 2022.

**ORDER FOR A HEARING ON THE STATUS OF EARLY EDUCATION
AND CHILDCARE WORKERS**

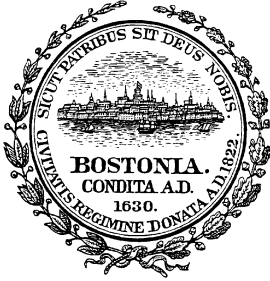
- WHEREAS,** During the COVID-19 pandemic, the childcare industry lost nearly 350,000 workers nationwide and as of September of 2021 are still 126,000 workers short, roughly 88% of its pre-pandemic levels; *and*
- WHEREAS,** Childcare workers have returned to work at far fewer rates compared to other industries, including restaurants that have rebounded to around 92% of pre-pandemic staffing levels; *and*
- WHEREAS,** The loss of childcare workers is not just a nationwide issue as Boston saw an 11% drop in the number of seats available for children since the end of 2017, and had permanently lost 13% of its licensed childcare programs that were open pre-pandemic, according to a study published by the Boston Opportunity Council; *and*
- WHEREAS,** There are many reasons why childcare workers are not returning to work, from inadequate pay to risk of exposure to COVID to poor benefits; *and*
- WHEREAS,** An article published by the Economic Policy Institute found that the median hourly wage for child care workers is \$10.31, 39.3 percent below the \$17.00 median hourly wage of workers in other occupations and that only around 15% of childcare workers receive health benefits; *and*
- WHEREAS,** According to the US Bureau of Labor Statistics, the average yearly salary for a childcare worker is just \$25,460, below the poverty line for a family of four; *and*
- WHEREAS,** Around 60% of all childcare workers have at least some college education, meaning that, in many cases, in addition to struggling to make ends meet, many childcare workers are also struggling to pay off student debt; *and*
- WHEREAS,** The loss of childcare workers impacts not only the childcare industry, but all industries as around 1.7 millions mothers across the country have not yet returned to the workforce in order to take care of their children; *and*

WHEREAS, It is important to explore this workforce development issue to find ways for the City to take action to ensure that every family has access to childcare and every childcare worker receives a livable wage. **NOW THEREFORE BE IT**

ORDERED: That the appropriate committee of the Boston City Council hold a hearing on the status of early education and childcare workers. Representatives from the City of Boston, including the Mayor's Office of Workforce Development, as well as advocates, including SEIU 509 Family Child Care Providers, and any other interested parties are encouraged to attend.

WHEREAS: **Matthew Morris** sustained serious injuries while in the performance of his duties, and as a result is incapacitated from further service as a police officer; the Boston City Council hereby

PETITIONS, That the following bill for a special law be enacted for **Matthew Morris**

Section 1. Notwithstanding the provision of any general or special law or rule or regulation to the contrary, and in order to promote the public good, the State-Boston Retirement Board is hereby authorized and directed to increase the accidental disability retirement allowance payable to Matthew Morris, a retired officer of the City of Boston who, as a result of injuries sustained while in the performance of his duties on October 12, 2016, is totally and permanently disabled from further service as a police officer.

Section 2. The total annual amount of pension payable to Matthew Morris shall be equal to the regular rate of compensation which would have been paid had he continued in service as a police officer of the City of Boston at the grade held by him at the time of his retirement. The additional benefits granted in this act shall be funded and administered by the Boston Retirement Board, consistent with and subject to chapter 32 of

the General Laws, except section 8 and 91A of said chapter 32 shall not apply. All amounts paid under this act shall be nontaxable.

(a) Such increase in retirement shall become effective commencing on the date for which he received an accidental disability retirement from the State-Boston Retirement Board.

(b) Upon enactment, the State-Boston Retirement Board shall forthwith pay to said Matthew Morris the amount credited to him as accumulated total deductions in the annuity savings fund of the State-Boston Retirement Board. Said Matthew Morris shall be entitled to receive indemnification for all hospital, medical and related expenses that have been or may be incurred after the date of his retirement as a result of said injuries, pursuant to the provisions of Chapter 41 of the General Laws.

Section 3.

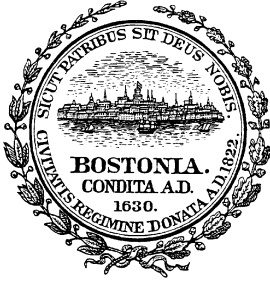
Upon the Death of Matthew Morris, should his wife survive him, the State-Boston Retirement Board shall pay to her, so long as she remains unmarried, an annuity in the amount of three-fourths of the amount of the pension payable to him, per month, at the time of his death. If said wife remarries, the City shall pay, in lieu of the aforesaid annuity to her, an annuity of \$550.00 dollars per month to her. In the event that both Matthew Morris and his wife die before their children reach the age of eighteen (18) or twenty-two (22), as provided herein, the payments that would otherwise be made to Matthew Morris pursuant to Section 2 shall be payable, in equal shares, to each child under the age of eighteen (18); provided, however, that payments shall continue to the age of twenty-two (22) for any child who is enrolled as a full-time student.

This act shall take effect upon passage.

(b) Upon enactment, the State-Boston Retirement Board shall forthwith pay to said Richard Cintolo the amount credited to him as accumulated total deductions in the annuity savings fund of the State-Boston Retirement Board. Said Richard Cintolo shall be entitled to receive indemnification for all hospital, medical and related expenses that have been or may be incurred after the date of his retirement as a result of said injuries, pursuant to the provisions of Chapter 41 of the General Laws.

Section 3.

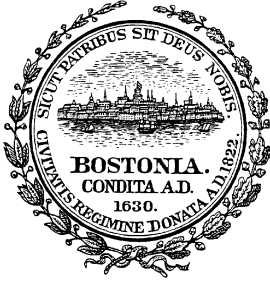
Upon the Death of Richard Cintolo, should his wife survive him, the State-Boston Retirement Board shall pay to her, so long as she remains unmarried, an annuity in the amount of three-fourths of the amount of the pension payable to him, per month, at the time of his death. If said wife remarries, the City shall pay, in lieu of the aforesaid annuity to her, an annuity of \$550.00 dollars per month to her. In the event that both Richard Cintolo and his wife die before their children reach the age of eighteen (18) or twenty-two (22), as provided herein, the payments that would otherwise be made to Richard Cintolo pursuant to Section 2 shall be payable, in equal shares, to each child under the age of eighteen (18); provided, however, that payments shall continue to the age of twenty-two (22) for any child who is enrolled as a full-time student.

BE IT ORDERED, That a petition to the General Court, accompanied by a bill for a special law relating to the City of Boston to be filed with an attested copy of this order be, and hereby is, approved under Clause 1 of Section 8 of Article II, as amended, of the Articles of Amendment to the Constitution of the Commonwealth of Massachusetts, to the end that legislation be adopted precisely as follows, except for clerical or editorial changes of form only:

**PETITION FOR A SPECIAL LAW RE: AN ACT REGARDING THE DISABILITY
PENSION FOR SCOTT O'BRIEN**

WHEREAS: **Scott O'Brien** sustained serious injuries while in the performance of his duties, and as a result is incapacitated from further service as a police officer; the Boston City Council hereby

PETITIONS, That the following bill for a special law be enacted for **Scott O'Brien**

Section 1. Notwithstanding the provision of any general or special law or rule or regulation to the contrary, and in order to promote the public good, the State-Boston Retirement Board is hereby authorized and directed to increase the accidental disability retirement allowance payable to Scott O'Brien, a retired officer of the City of Boston who, as a result of injuries sustained while in the performance of his duties on January 16, 2004, is totally and permanently disabled from further service as a police officer.

Section 2. The total annual amount of pension payable to Scott O'Brien shall be equal to the regular rate of compensation which would have been paid had he continued in service as a police officer of the City of Boston at the grade held by him at the time of his retirement. The additional benefits granted in this act shall be funded and administered by the Boston Retirement Board, consistent with and subject to chapter 32 of

the General Laws, except section 8 and 91A of said chapter 32 shall not apply. All amounts paid under this act shall be nontaxable.

(a) Such increase in retirement shall become effective commencing on the date for which he received an accidental disability retirement from the State-Boston Retirement Board.

(b) Upon enactment, the State-Boston Retirement Board shall forthwith pay to said Scott O'Brien the amount credited to him as accumulated total deductions in the annuity savings fund of the State-Boston Retirement Board. Said Scott O'Brien shall be entitled to receive indemnification for all hospital, medical and related expenses that have been or may be incurred after the date of his retirement as a result of said injuries, pursuant to the provisions of Chapter 41 of the General Laws.

Section 3.

Upon the Death of Scott O'Brien, should his wife survive him, the State-Boston Retirement Board shall pay to her, so long as she remains unmarried, an annuity in the amount of three-fourths of the amount of the pension payable to him, per month, at the time of his death. If said wife remarries, the City shall pay, in lieu of the aforesaid annuity to her, an annuity of \$550.00 dollars per month to her. In the event that both Scott O'Brien and his wife die before their children reach the age of eighteen (18) or twenty-two (22), as provided herein, the payments that would otherwise be made to Scott O'Brien pursuant to Section 2 shall be payable, in equal shares, to each child under the age of eighteen (18); provided, however, that payments shall continue to the age of twenty-two (22) for any child who is enrolled as a full-time student.

Section 4

This act shall take effect upon passage.

2 - Section 17F of Chapter 452 of the Acts of 1948 (as amended):

The city council may at any time request from the mayor specific information on any municipal matter within its jurisdiction, and may request his presence to answer written questions relating thereto at a meeting to be held not earlier than one week from the date of the receipt of said questions, in which case the mayor shall personally, or through a head of a department or a member of a board, attend such meeting and publicly answer all such questions. The person so attending shall not be obliged to answer questions relating to any other matter.

Home Rule Petitions Not Responded to by the Mayor³

³Section 22 of Chapter 190 of the Acts of 1982:

Every order of the city council approving a petition to the general court pursuant to Clause (1) of Section 8 of Article 2 of the amendments to the Constitution of the Commonwealth shall be presented to the mayor who shall forthwith consider the same, and, within fifteen days of presentation, either approve it, or file with the city council a statement in detail of his reasons for not approving the same, including any objection based on form, on content, or both; provided, that no such order shall be deemed approved or in force unless the mayor affixes his signature thereto.

Matters in Committee

The following matters were previously filed with the City Council and have been referred to a committee. Matters in committee can be brought back before the City Council pursuant to City Council Rule 24. The following *definitions* describe different types of matters in committee:

- Ordinances:*** Local laws enacted by the Boston City Council and the Mayor that become part of the City Code of Ordinances.
- Loan Orders:*** Authorization for the City of Boston to incur debt and expend money for projects, purchases, or other obligations.
- Orders:*** Directives that authorize action. Orders are legally binding but are not part of the City Code of Ordinances.
- Home Rule Petitions:*** Requests for special acts that concern a particular municipality. Home Rule Petitions require approval of the Boston City Council and Mayor, as well as passage by the state legislature.
- Order for a Hearing:*** A formal request sponsored by a councilor that a committee of the Boston City Council conduct a hearing about a particular matter, issue, or policy that impacts the City of Boston. An Order for a Hearing is not a law and is not voted on by the City Council. The only action concerning an Order for a Hearing that can be taken at a City Council meeting is the administrative action of placing it on file.
- Legislative Resolution:*** A recommendation concerning policy issues that may urge action on particular matters. Legislative resolutions have no legal effect. Legislative resolutions represent a particular position or statement by a Councilor, Councilors, or the City Council as a whole.


