## REPORT OF COMMITTEE CHAIR

September 25, 2024

Dear Councilors,

The Committee on Strong Women, Families, and Communities was referred the following docket for consideration:

*Docket #0907, Message and order authorizing the City of Boston to accept and expend the amount of Fifty Thousand Dollars (\$50,000.00) in the form of a grant, Childhood Obesity Prevention and Environmental Health Sustainability, awarded by the United States Conference of Mayors to be administered by the Office of Early Childhood Development. The grant will fund and support programs that engage community members and promote or stimulate behavior change in Childhood Obesity Prevention and environmental health and sustainability.*

This docket was sponsored by Mayor Michelle Wu and referred to the Committee on June 5 2024.

*Docket #1106, Message and order authorizing the City of Boston to accept and expend the amount of One Hundred Sixty-Five Thousand Dollars (\$165,000.00) in the form of a grant, for the Mayor's Office of Human Services' Connect, Learn and Explore Initiative, awarded by Boston Children's Hospital to be administered by the Office of Human Services. The grant will fund youth sports and swim activities in partnership with Boston Public Schools*

*Docket #1109, Message and order authorizing the City of Boston to accept and expend the amount of Twenty-Two Thousand Five Hundred Dollars (\$22,500.00) in the form of a grant, for the Child Care Licensing Support grant, awarded by the United Way to be administered by the Office of Early Childhood. The grant will fund stipends for individuals who have completed the Family Childcare Licensing Support Training and have opened their businesses.*

*Docket #1172, Message and order authorizing the City of Boston to accept and expend the amount of One Hundred Thousand Dollars (\$100,000.00) in the form of a grant, for the Senior's Save Program grant, awarded by the Boston Charitable Trust Fund to be administered by the Mayor's Office of Housing. The grant will fund the heating system replacement program for eligible senior citizen homeowners in Boston.*

*Docket #1176, Message and order authorizing the City of Boston to accept and expend the amount of Eleven Thousand Six Hundred Dollars (\$11,600.00) in the form of a grant for the Escrow-Mitigation Activities, awarded to the City of Boston to be administered by the Boston Center for Youth and Families. The grant will fund to pay contractors for mitigation activities.*

*Docket #1281* authorizes the City to accept and expend \$461,143.00 in the form of a grant, for the *Federal FY25 Title III-A Administration grant* awarded by the U.S. Department of Health and Human Services, passed through the MA Executive Office of Elder Affairs, to be administered by the Age Strong Commission

*Docket #1283* authorizes the City to accept and expend \$177,271.00 in the form of a grant, for the *Federal FY25 Title III- Ombudsman Program*, awarded by the U.S. Department of Health and Human Services, passed through the MA Executive Office of Elder Affairs, to be administered by the Age Strong Commission.

*Docket #1284* authorizes the City to accept and expend \$84,058.00 in the form of a grant, for the *Federal FY25 Title III-D Disease Prevention and Health Promotion*, awarded by the U.S. Department of Health and Human Services, passed through the MA Executive Office of Elder Affairs, to be administered by the Age Strong Commission.

## Information Received at Hearing

The Committee held a hearing on Monday, September 23, 2022, to discuss various grants to be administered by the Office of Human Services, Office of Early Childhood, Mayor's Office of Housing, and the Age Strong Commission. The Committee heard testimony on behalf of the Administration from panelists which included Kristin McSwain, Senior Advisor and Director of the Office of Early Childhood; José Massó, Chief of Office of Human Services; Karen Rebaza, Director of Boston Home Center within the Mayor's Office of Housing; and Emily Shea, Age Strong Commissioner.

Chief Massó testified on *Dockets #1106* and *#1176*, explaining that *Docket #1106* will support collaborations between the Human Services Cabinet and Boston Public Schools to ensure all young people know how to swim and that *Docket #1176* will fund continued mitigation efforts specific to the Piping Plover population.

Director McSwain testified on *Dockets #0907* and *#1109*, explaining that *Docket #0907* will Childhood Obesity Prevention by funding the expansion of sports programming for youth, targeting 3-6 years olds and that *Docket #1109* will go towards the City's childcare entrepreneurship fund which supports family child care providers who want to start a business.

Director Rebaza testified on *Docket #1172*, explaining that the grant will support the Senior Save Program to replace failing or insufficient heating systems for eligible senior citizen homeowners.

Commissioner Shea testified on *Dockets #1276*, *#1278*, *#1279*, *#1280*, *#1281*, *#1283*, and *#1284*. It was explained that *Docket #1278* is awarded to the Commission each year for being the City of Boston's 'agency on aging' and funds a number of the Department's staff, among other programming initiatives. The Commissioner explained that *Dockets #1276*, *#1279*, *#1280*, *#1281*, *#1283*, and *#1284* are Title III grants that will be used to support programs that support older adults, including nutrition services, supportive services, caregiver support, disease prevention, and health promotion.

Specifically, it was explained that *Docket #1276*, Title III C funding, will support congregate meal sites for older adults, as well as the citywide Meals on Wheels program for older adults; *Docket #1279*, Title III B funding, will support older adult programming through community partnerships; *Docket #1280*, Title III E funding, will support the Family Caregiver Program, which supports people caring for family members over the age of 60, or people over the age of 60 caring for younger family members; *Docket #1281*, Title III A funding, will cover administrative expenses related to aging services; *Docket #1283* granted under the Title III Ombudsman Program, will fund community partnerships to provide support services at long term care facilities; and finally, *Docket #1284*, Title III D funding, will support evidence-based healthy aging programs for disease prevention and health promotion.

Councilors inquired about the SHINE program, the Ombudsman program, and swim programs for youth aged 3-6 years old. The Administration explained that the SHINE program is not funded by the City but by federal and state sources and further assured the Committee that the Governor's recent veto of \$1M did not defund the SHINE program completely. Regarding the Ombudsman program, the Administration explained that the program is coordinated by Ethos, a nonprofit organization with volunteers assigned to different long-term care facilities who go around monthly to connect with the residents. Finally, regarding swim programs for children aged 3-6, the Administration explained that this past summer, the City offered three programs, reaching 100 children across the City, with plans to expand the program in the future.

## Summary of Amendments

*Dockets #1276, #1279, #1280, #1281, #1283, and #1284* were amended to accurately reflect dollar amounts granted. The grants as filed reflected the anticipated dollar amount the Age Strong Commission expected to receive based on various factors, but the grant amounts have since been confirmed. 
