Dear Councilors:

I transmit herewith for your approval a home rule petition to the General Court entitled "Petition for a Special Law Re: An Act Relative to Creation of a Branch of the Boston Public Library (BPL) within an Affordable Housing Development in the Dorchester Section of the City of Boston."

Through this special act, the Boston Redevelopment Authority, d/b/a The Boston Planning & Development Agency (BPDA) seeks to ground lease BPDA-owned vacant land at 555- 559 Columbia Road to a developer selected via a Request for Proposals process who will participate in a redevelopment of the BPDA land using city and state funds to fund the development of affordable housing. This project will also create a shell and core space within it that would be conveyed to the Boston Public Library at cost, to allow BPL to build out the space as the new Uphams Corner branch library in Dorchester. Creating the branch library within a larger affordable housing development is a way to achieve two much-needed public purposes within one development. This redevelopment necessitates certain exemptions from the Commonwealth's contract procurement and award laws. Although there have been reforms to the state statutes regarding filed sub-bids under Ch. 149, the changes are insufficient to allow for the selected developer to move forward in a redevelopment effort of this kind. Without passage, the project must adhere to an extremely structured filed sub-bid process, with separate General Contractor and subcontractor selection. These exemptions will not compromise a fair and transparent process because the BPDA's selected developer and the BPL must still adhere to the stringent regulations of its public funding sources.

This model has been utilized successfully by several agencies who have applied for similar legislation. R-1, the BPDA's first development project of affordable housing with a branch library space project in Chinatown, was passed in December 2022. The Boston Housing Authority (BHA) has filed similar legislation for BHA housing located at Whittier Street, Orient Heights, Bromley Heath, Mission Main, Orchard Gardens, Maverick Gardens, West Broadway Homes, and Old Colony, Washington Beech, Franklin Hill, Amory Street, and Lenox-Camden family developments.

I urge your Honorable Body to support this special act so that we can make this redevelopment effort a reality for the Uphams Corner neighborhood in Dorchester and its people who have been waiting for a new branch library.

WHEREAS, The Boston Planning & Development Agency seeks to participate in a redevelopment to create affordable housing that includes shell and core space for a branch library in Upham's Corner in Dorchester. This redevelopment necessitates certain exemptions from the Commonwealth's contract procurement and award laws; and

WHEREAS, Participating in the redevelopment will increase the supply of affordable housing in the neighborhood, as well as provide space for a long-awaited branch library, furthering the aims of the Commonwealth's housing and community service initiatives; and

WHEREAS, The exemptions will not contravene the legislative intent behind the affected procurement and public contract laws because the additional regulation and public oversight that accompanies the Boston Public Library's funding sources minimizes the risk of unfair competition and misuse of taxpayer funds.

NOW THEREFORE BE IT ORDERED,

That a petition to the General Court, accompanied by a bill for a special law relating to the Boston Planning & Development Agency and the Boston Public Library to be filed with an attested copy of this order be, and hereby is, approved under Clause 1 of Section 8 of Article II, as amended, of the Articles of Amendment to the Constitution of the Commonwealth of Massachusetts, to the end that legislation be adopted precisely as follows, except for clerical or editorial changes of form only:

PETITION FOR A SPECIAL LAW RE:

AN ACT RELATIVE TO THE CREATION OF A BRANCH OF THE BOSTON PUBLIC LIBRARY WITHIN AN AFFORDABLE HOUSING DEVELOPMENT IN THE DORCHESTER SECTION OF THE CITY OF BOSTON

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. Construction and development activity related to redevelopment by the developer selected by the Boston Planning & Development Agency of subsidized affordable housing, including space for a branch library to be procured by the Boston Public Library, to be built on BPDA-owned land under a ground lease, or any part thereof, shall not be subject to any general or special law related to the procurement and award of contracts for the planning, design, construction management, construction, reconstruction, installation, demolition, maintenance, or repair of buildings by a public agency, but shall be subject to sections 26 to 27H, inclusive, of chapter 149 of the General Laws. Contracts for the construction, reconstruction, alteration, remodeling, or repair of any publicly owned public works that service this project and would otherwise be subject to section 39M of chapter 30 of the General Laws shall be subject to said section 39M if the redevelopment of the project is funded in part by state or federal government low-income housing tax credit, grant, or loan, or pursuant to the issuance of tax-exempt bonds authorized by general law. A conveyance of the project, whether by leasehold or fee estate, to an urban redevelopment corporation organized under chapter 121A of the General Laws or to a nonprofit state and federally tax-exempt corporation organized for the purpose of revitalizing the project, shall be subject to chapter 30B of the General Laws to the extent that the project is conveyed to an entity that is not owned, controlled, or managed by the Boston Public Library on the date of the conveyance.

SECTION 2. This act shall take effect upon its passage.

Dear City Councilors:

I am writing this letter in regard to the FY 2024 budget that has taken effect. Specifically, I am informing the Council that the funds intended in an override vote to increase salaries for one labor union through an intra-departmental shift will not be used for that purpose. That purpose violates the City Charter because it inserts the Council into collective bargaining negotiations.

Section 17G of the Boston City Charter prohibits the Council from participating in labor matters and the making of contracts. State law - M.G.L. ch. 150E - is equally clear that third parties are excluded from participating in that bargaining process.

The \$584,896 that the Council voted for in this veto override represents the exact sum that the Municipal Police Patrolmen's Association (MPPA) has requested in the salary benchmarking negotiations between the City and the Union. Both the City and the Union agree that MPPA salaries should be adjusted, but the parties have yet to reach agreement on the size of the increase.

There is no other interpretation of this override vote than as a directive from the City Council to the Administration to adopt the MPPA's specific salary increase demands in bargaining, which is a clear cut violation of the City Charter and state law. I am grateful for my colleagues' impulse to advocate for our City workers, but the Council cannot use the budget-making process to dictate collective bargaining, especially when it has a role in voting to appropriate funds for settled contracts after negotiations are completed.

My Administration is dedicated to reaching a fair deal with all our municipal unions. All of our labor partners deserve the fairness and respect that comes with a settled contract, and we must follow the proper processes to carry out collective bargaining to reach these contracts. I look forward to your support on any supplemental appropriations to fund future agreements.

**An Ordinance Amending City of Boston Code, Ordinances, Chapter XII,
Section 12-19, Immigrant Advancement for Public Health and Welfare**

- WHEREAS,*** The City of Boston has over 690,000 residents, of which 29% are foreign-born and many are the children of immigrants, 15% of residents have limited English proficiency, and 35% speak a language other than English at home; *and*
- WHEREAS,*** Boston has historically been home to dozens of immigrant groups, and continues to be a place where many relocated in pursuit of new opportunities, many of which are fleeing violence and political and economic instability in their countries of origin; *and*
- WHEREAS,*** With the expiration of Title 42 in May of 2023, Boston has been experiencing a sharp increase in immigration. We need to assure new immigrants feel welcomed and safe here; *and*
- WHEREAS,*** Immigrant residents as well as new arrivals need access to information and resources. We need to ensure all department communication is shared with our immigrant community in a language they understand so that they can receive the assistance they need; *and*
- WHEREAS,*** The City of Boston needs to conduct research on immigrants and speakers of languages other than English, including, but not limited to, obstacles to accessing City programs, benefits, and services, and on socioeconomic trends related to such persons, in order to be effectively responsive; *and*
- WHEREAS,*** The Mayor created an Office of Immigrant Advancement, but this Office was never codified into law, giving the people of Boston an opportunity to define for themselves how they would like to see the City serve our immigrant population; *and*
- WHEREAS,*** The City of Boston reaffirms its commitment to being a welcoming City by officially establishing an Office within its charter dedicated to immigrants; ***NOW THEREFORE BE IT***

ORDERED: That the City of Boston Code, Chapter XII, is amended by adding the following new section and subsections:

SECTION 1

12-19.1 Purpose.

The City City recognizes that a large percentage of its inhabitants were born abroad or are the children of parents who were born abroad and that the well-being and safety of the City is put in jeopardy if the people of the City do not seek medical treatment for illnesses that may be contagious, do not cooperate with the police when they witness a crime or do not avail themselves of City services to educate themselves and their children. It is therefore desirable that the City promote the utilization of City services by all its residents, including foreign-born inhabitants, speakers of foreign languages and undocumented immigrants.

12-19.2 Establishment of the Office of Immigrant Advancement.

There shall be established in the City of Boston the Office of Immigrant Advancement (hereafter known as the Office) which shall be under the charge of an Officer known as the Director of Immigrant Advancement (hereafter called the Director). The Office shall be headed by a Director, who shall be appointed by the Mayor.

The Office shall also ensure that any service provided by a City agency shall be made available to all immigrants who are otherwise eligible for such service to the same extent such service is made available to citizens unless such agency is required by law to deny eligibility for such service.

12-19.3 Director Responsibilities.

The Director, or designee, of the Office shall have the power and the duty to:

1. advise and assist the Mayor in developing and implementing policies designed to assist immigrants and speakers of languages other than English in the City , in consultation with the Office of the Office of Language and Communication Access with respect to language accessibility;
2. enhance the accessibility of City programs, benefits, and services to immigrants and speakers of languages other than English by establishing outreach programs in conjunction with other City agencies and the council to inform and educate immigrants and speakers of languages other than English of relevant City programs, benefits, and services;
3. perform policy analysis and make recommendations concerning immigrant affairs; and
4. perform such other duties and functions as may be appropriate to pursue the policies set forth in this section.

The Director, or such other Office or agency as the Mayor may designate, shall have the power and the duty to:

1. conduct research and advise the Mayor on challenges faced by immigrants and speakers of languages other than English, including, but not limited to, obstacles to accessing City programs, benefits, and services, and on socioeconomic trends related to such persons;

2. consult with relevant City departments on implementation of sections of the charter and the administrative code that are relevant to immigrants;
3. participate in interdepartmental efforts, as appropriate, relating to the handling of confidential information about individuals held by City agencies and those contracting with City departments;
4. solicit community and stakeholder input regarding the activities of the Office, including but not limited to the Office's consultations with relevant agencies on implementation of sections of the charter and the administrative code that are relevant to immigrants.

12-19.4 Reporting Requirements.

- a. All City departments shall cooperate with the Office and provide information and assistance as requested; provided, however, no information that is otherwise required to be provided pursuant to this section shall be disclosed in a manner that would violate any applicable provision of federal, state, or local law relating to the privacy of information or that would interfere with law enforcement investigations or otherwise conflict with the interests of law enforcement.
- b. The Office shall provide to the City Council and post on the Office's website a report regarding the City's immigrant population and the activities of the Office during the previous calendar year, including, but not limited to the following information, where such information is available:
 1. The size and composition of such population, including, but not limited to demographic information, socio-economic markers, and estimates of the immigration status held by members of such population, if any;
 2. Information regarding the needs of such population including, but not limited to, social services, legal services, housing, public benefits, education, and workforce development needs;
 3. Information regarding barriers faced by such population in accessing such services, and recommendations on how the City could address such barriers;
 4. Information and metrics relating to each programmatic initiative of the Office, including initiatives that are conducted in partnership with other Offices or agencies, including but not limited to:
 - a. total program capacity, disaggregated by service type;
 - b. number of intakes or program eligibility screenings conducted;
 - c. number of individuals served, disaggregated by service type.
 - d. number of matters handled, and aggregate data on the outcomes achieved, disaggregated by service type; and
 - e. with respect to legal services initiatives, number of cases accepted for legal advice and full representation, as well as the number of cases referred to other legal services providers, disaggregated by service and case type, and aggregate

data on the outcomes achieved in cases accepted for full representation during the reporting window.

SECTION 2.

Severability. The provisions of this ordinance are severable, and if any provision, or portion thereof, should be held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such unconstitutionality or invalidity will not affect the remaining provisions, which will remain in full force and effect.

SECTION 3. Effective Date.

This ordinance shall be effective within six months of passage.

Be it ordained by the City Council of Boston, as follows:

That the City of Boston Code be amended as follows:

Section 1. CBC 2-8.3 For the conduct of the affairs of the City Council there shall be, in addition to the City Clerk, a Central Staff Director and other such subordinate officers as may be appointed by a majority of the City Council from time to time. Such Central Staff Director and subordinate officers shall perform such duties as the Council may provide by order from time to time, and they shall receive an annual salary determined by Council order from within the salary ranges below:

The City Council President may designate a Central Staff member to serve in the capacity of Deputy Central Staff Director and may award stipends.

For the conduct of the affairs of the City Council, in addition to the Central Staff Director and subordinate officers provided for, there shall be administrative assistants and secretaries to be appointed from time to

time by the City Council. Each Councilor's office shall receive Three Hundred Forty One Thousand Five Hundred (\$341,500) Dollars per year and the President's office shall receive Four Hundred Thousand (\$400,000) Dollars per year to pay such salaries according to the rules of the City Council.

Central Staff salary ranges and allocations for Councilors' offices shall be reviewed, at minimum, every two years, and may be updated more frequently at the Council President's discretion.

AN ORDINANCE ESTABLISHING AN AFFORDABLE HOUSING DEMOLITION PERMIT FEE BY AMENDING THE CITY OF BOSTON CODE, ORDINANCES, CHAPTER XVIII, SECTION 18-1.2, "B" FEES AND CHARGES, REGARDING BUILDING AND DEMOLITION PERMITS

WHEREAS, Development in growing communities across Boston has continued to move at a rapid pace, yet the abundance of development has not yielded opportunities for affordable living in these neighborhoods; *and*

WHEREAS, Historically neighborhoods like East Boston and Mattapan consist of single-family, two-family, and multi-family residential structures, and it is vital that the City of Boston is able to maintain buildings of historic significance that contribute to neighborhood character, while investing in various funnels of funding for the creation of affordable housing; *and*

WHEREAS, The rapid pace of new development in Boston has adversely impacted the aesthetic of the neighborhood as many family homes are being demolished and replaced by structures of multiple units that do not embody the history of each unique Boston neighborhood; *and*

WHEREAS, The current demolition permit fee structure only includes a small primary fee of fifty (\$50.00) dollars plus an additional ten (\$10.00) dollars for each thousand (\$1,000.00) dollars of the fair cost of the work authorized by such permit as determined by said Commissioner; *and*

WHEREAS, Furthermore, the fee structure does not address smaller residential buildings and does not take into account the significance that such buildings hold over the character of the neighborhood. It also does not contribute to any resources that supply investments in affordable housing opportunities; *and*

WHEREAS, Having a demolition permit fee structure that specifically relates to smaller residential buildings will encourage the preservation of such buildings and will contribute to the aesthetic quality and character of the neighborhood, while also providing resources to mend Boston's affordable housing crisis. **NOW, THEREFORE,**

Be it ordained by the City Council of Boston as follows:

Section 1.

The City of Boston Code, Ordinances, Chapter XVIII, Section 18-1.2, “B” Fees and Charges, Subsection 27, Building and Demolition Permit, is hereby amended by adding the following provisions after the first sentence:

Definitions

For the purposes of this section, the term:

- A. “Single-family residential structure” shall be defined as any structure constructed with the original intent of housing one family, regardless of current status of occupancy, current number of units, or modifications to original floor plans. This shall include, but is not limited to:
 - a. Single-family attached structures
 - b. Single-family detached structures
- B. “Two-family residential structure” shall be defined as any structure constructed with the original intent of housing two separate families within independent, joined units, regardless of current status of occupancy, current number of units, or modifications to original floor plans. This shall include, but is not limited to:
 - a. Duplexes
 - b. Condominiums
 - c. Townhouses
 - d. Two-family semi-detached structures
- C. “Affordable Housing, or Low Income Housing” shall mean housing for those persons and families whose annual income is less than 80 percent of the areawide median income.
- D. “Low or moderate income housing for seniors” shall mean housing for those persons having reached the age of 60 or over who would qualify for low or moderate income housing. Moderate income housing shall mean housing for those persons and families whose annual income is less than 100 percent of the areawide median income.
- E. “Areawide median income” shall be the areawide median income as determined by the United States Department of Housing and Urban Development. Affordable housing shall include low and moderate income housing for individuals and families, including low and moderate income senior housing as defined in section 8.12.2.

Any person or entity granted a permit under this code for demolition of a single-family residential structure, or two-family residential structure, shall pay a housing demolition fee of: 1) fifteen thousand dollars (\$15,000.00) for the demolition of any single-family detached residential structure, or 2) for the demolition of any multi-family, single-family attached, or two-family residential structure, either fifteen thousand dollars (\$15,000.00) or five thousand dollars (\$5,000.00) for each unit in the structure, whichever amount is more. The fee imposed pursuant

to this Subsection shall be in addition to the demolition permit fee established from time to time by the City Council and all other applicable fees and charges. The demolition fee funds received pursuant to the fee imposed by this Chapter shall be deposited directly into the Neighborhood Housing Trust (NHT).

(A) Specific Applicability Rules. Notwithstanding the general requirement set forth in Subsection (A) of this Section, the fee shall not apply under the following circumstances.

1. If the applicant and the City enter into an agreement for the provision of "affordable housing or low income housing" as defined in Section 18-1.2 of this Chapter in conjunction with the demolition that would otherwise be the subject of Subsection (A) of this Section. Any such agreement shall require prior City Council approval and shall specifically set forth the applicability of this Subsection.
2. If the Director determines, pursuant to regulations enacted by the City Council, that the building or structure replacing the building or structure that is the subject of the demolition permit constitutes "affordable housing or low income housing" as defined in Section 18-1.2 of this Chapter.
3. If the Director or any other City department head, or their respective designees, orders a demolition for any reason, including, but not limited to, nuisance, public safety, building collapse, flooding, or fire hazard, this fee shall not apply, regardless of whether the demolition work is performed by a public or private entity. (C) General Applicability. Imposition of the fee provided for by Subsection (A) of this Section shall not apply to any demolition for which a perfected application for the demolition permit was on file with the City on or before the effective date hereof.

Section 2.

The provisions of this ordinance are severable and if any provision, or portion thereof, should be held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect the remaining provisions, which remain in full force and effect.

Section 3.

The provisions of this ordinance shall be effective immediately upon passage.

WHEREAS, The Boston Fire Department's cadet program, which started in 2023, is a civilian paid and benefited position within the Boston Fire Department This program is a two year commitment for those with interest in pursuing a career as a firefighter and is modeled after the BPD cadet program; *and*

WHEREAS, Both cadet programs have identical requirements to apply. You need to be between the ages of 18-25 before the first date of employment, have a high school diploma or GED, be a current resident of the City of Boston and have maintained residency for the last five (5) years and have a valid Massachusetts Drivers License and a good driving record; *and*

WHEREAS, The starting salary of a Boston Police Cadet is \$28K. The starting salary of a Boston Fire Cadet is 31K. The Massachusetts State Police Cadets get paid between \$38-\$40k per year.

WHEREAS, The Boston Police Cadets deserve the same pay as the Boston Fire Cadets; **NOW, THEREFORE BE IT**

ORDERED: That the appropriate committee of the Boston City Council holds a hearing to address the disparity in pay between the two cadet programs and to make sure we are paying our cadets a fair wage. Representatives from the Mayor's Office, Boston Police Department, Boston Fire Department,, and other interested parties shall be invited to attend.

WHEREAS, Under the leadership of Ways and Means Chair Representative Aaron Michlewitz, the state legislature passed H.5103, “An act to reduce traffic fatalities.” This law grants new petitioning power to City officials on matters of pedestrian safety; *and*

WHEREAS, The City of Boston maintains its Vision Zero standards for Traffic Fatalities, a strong commitment to eliminating fatal and serious traffic crashes in the city by 2030; *and*

WHEREAS, Whereas pedestrian deaths across Massachusetts increased by 35% in 2022 with Boston having the highest number of pedestrian deaths across the state; *and*

WHEREAS, The Back Bay Fens is a highly trafficked pedestrian space in the City of Boston frequented by residents and visitors alike; *and*

WHEREAS, The Fens is currently flanked by two DCR Parkway, Park Drive and The Fenway, that host multiple traffic lanes, inadequate safety measures at pedestrian crossings, and a natural traffic speed that exceeds the posted 30 mph speed limit, imposing an acutely dangerous situation for pedestrians; *and*

WHEREAS, Whereas these DCR Parkway were in the top 5% of pedestrian/vehicular and cyclist/vehicular conflicts between 2011 and 2020; *and*

WHEREAS, According to the World Health Organization, a 5% cut in average speed can reduce the number of fatal crashes by as much as 30%; **NOW, THEREFORE BE IT**

RESOLVED: That the Boston City Council supports and requests that the Commissioner of DCR reduces the speed limit for the parkways adjacent to The Fens from 30 mph to the citywide standard of 25 mph, in order to improve pedestrian safety and access to one of Boston’s most and beloved parks as part of the City’s ongoing mission to ensure the safety of pedestrians across the whole of Boston.

RESOLUTION TO FORMALIZE BOSTON CITY COUNCIL'S SUPPORT OF ENDING LEGACY ADMISSIONS IN INSTITUTIONS OF HIGHER LEARNING

- WHEREAS,** Access to educational opportunities supports individual health, wellness, and economic vitality while enhancing community safety, productivity, and innovation; *and*
- WHEREAS,** The City of Boston is home to both world-renowned colleges and universities as well as an increasingly diverse population; *and*
- WHEREAS,** Universities and colleges have a vested interest in not only promoting diversity, but also correcting past wrongs and inactions relating to slavery, colonization, and racial discrimination; *and*
- WHEREAS,** The Supreme Court of the United States has found that “College admissions are zero-sum. A benefit provided to some applicants but not to others necessarily advantages the former group at the expense of the latter” (Students for Fair Admissions, Inc. v. President and Fellows of Harvard College, 600 U.S. ____ (2023)); *and*
- WHEREAS,** Harvard University’s use of admission preferences for athletes, legacies, donors, and children of faculty (ALDC’s) provides White students with a significant advantage, with 43% of White admittees having ALDC preference compared to less than 16% of students of Color; *and*
- WHEREAS,** One review indicated that as many as 75% of ALDC students would not have been granted admission to Harvard were it not for their privileged status; *and*
- WHEREAS,** ALDC status has been found to provide an admissions boost equivalent to 160 additional points on the SAT, making them three times as likely to gain admission than their non-legacy peers.; *and*

WHEREAS, The Massachusetts State House is currently considering legislation that would ban the practice of preferencing Legacy and Donor-related students at all public or private certificate- or degree-granting college, junior college, or university; *and*

WHEREAS, The City of Boston and its institutions have a vested interest in addressing and remedying the harms of the past through proactive measures, ***NOW THEREFORE BE IT***

RESOLVED: That the City Council assembled hereby proclaims its support for the end of legacy and donor preferencing in the higher education admissions process and encourages both State action on relevant legislation and institutional action to voluntarily eliminate said preferences.

The city council may at any time request from the mayor specific information on any municipal matter within its jurisdiction, and may request his presence to answer written questions relating thereto at a meeting to be held not earlier than one week from the date of the receipt of said questions, in which case the mayor shall personally, or through a head of a department or a member of a board, attend such meeting and publicly answer all such questions. The person so attending shall not be obliged to answer questions relating to any other matter.

*Home Rule Petitions Not Responded to by the Mayor*³

³*Section 22 of Chapter 190 of the Acts of 1982:*

Every order of the city council approving a petition to the general court pursuant to Clause (1) of Section 8 of Article 2 of the amendments to the Constitution of the Commonwealth shall be presented to the mayor who shall forthwith consider the same, and, within fifteen days of presentation, either approve it, or file with the city council a statement in detail of his reasons for not approving the same, including any objection based on form, on content, or both; provided, that no such order shall be deemed approved or in force unless the mayor affixes his signature thereto.

Matters in Committee

The following matters were previously filed with the City Council and have been referred to a committee. Matters in committee can be brought back before the City Council pursuant to City Council Rule 24. The following *definitions* describe different types of matters in committee:

- Ordinances:*** Local laws enacted by the Boston City Council and the Mayor that become part of the City Code of Ordinances.
- Loan Orders:*** Authorization for the City of Boston to incur debt and expend money for projects, purchases, or other obligations.
- Orders:*** Directives that authorize action. Orders are legally binding but are not part of the City Code of Ordinances.
- Home Rule Petitions:*** Requests for special acts that concern a particular municipality. Home Rule Petitions require approval of the Boston City Council and Mayor, as well as passage by the state legislature.
- Order for a Hearing:*** A formal request sponsored by a councilor that a committee of the Boston City Council conduct a hearing about a particular matter, issue, or policy that impacts the City of Boston. An Order for a Hearing is not a law and is not voted on by the City Council. The only action concerning an Order for a Hearing that can be taken at a City Council meeting is the administrative action of placing it on file.
- Legislative Resolution:*** A recommendation concerning policy issues that may urge action on particular matters. Legislative resolutions have no legal effect. Legislative resolutions represent a particular position or statement by a Councilor, Councilors, or the City Council as a whole.

A long-time New Yorker, Cecilia held a PhD in Asian Art History from New York University. She served in many roles during her accomplished career, including curatorial and teaching roles at New York's Metropolitan Museum of Art, Boston's Museum of Fine Arts, Harvard University, Boston College, and Brandeis University. Cecilia's contributions and impact on the community were truly exceptional, and her loss leaves a void that will be vastly experienced. Your legacy as a trailblazer, scholar, and lover of arts will be cherished. Rest in peace, Cecilia Levin.
