

August 30, 2023

A regular meeting of the City Council of the City of Boston was held in the Christopher A. Iannella Chamber, City Hall on Wednesday, August 30, 2023 at 12:04 P.M.

President Flynn in the Chair. All Councilors present.

Grand Rabbi Y.A. Korff, Chaplain for the Boston Fire and Police Departments, delivered the invocation and the meeting was opened with the pledge of allegiance to the flag.

President Flynn moved to adopt the minutes from the August 9, 2023 meeting. Motion Prevailed.

On the message and ordinance, referred on August 30, 2023, Docket #1373, to support public safety as the City doubles down on our public health-led approach to the crises of mental health, substance use, and unsheltered homelessness concentrated in the area of Massachusetts Avenue and Melnea Cass Boulevard, the committee submitted a report recommending the ordinance ought to pass in a new draft. The report was accepted; the ordinance was passed in a new draft; yeas 9, nays 3(Arroyo, Baker, Lara), present 1(Mejia).

Referred to the Committee on Government Operations.

1374 Councilor Lara called Docket #1374, message and order authorizing the City of Boston through its Mayor's Office of Housing to apply for, accept and expend, the FFY23 Continuum of Care grant from the U.S. Department of Housing and Urban Development in the amount not to exceed Fifty Million Dollars (\$50,000,000.00). The funds will be used to support programs that provide services and housing to persons experiencing homelessness, from the Committee on Housing and Community Development.

Hearing no objection, the matter was before the body. On motion of Councilor Lara, the order was passed; yeas 12. Referred to the Committee on Housing and Community Development.

Councilor Lara called Docket #1375, message and order authorizing the City of Boston to accept and expend the amount of Twenty-Five Million Dollars (\$25,000,000.00) in the form of a grant, for the Commonwealth Builder Program, awarded by the Massachusetts Housing Partnership to be administered by the Mayors Office of Housing. The grant will fund the creation of workforce homeownership units and long-term availability of those units to eligible moderate-income households, from the Committee on Housing and Community Development.

Hearing no objection, the matter was before the body.

On motion of Councilor Lara, the order was passed; yeas 12.

Referred to the Committee on Housing and Community Development.

- 1376 On the message and order, referred on August 30, 2023, Docket #1376, authorizing the City of Boston to accept and expend the amount of One Million Dollars (\$1,000,000.00) in the form of a grant for Securing the Cities continuation grants, awarded by the United States Department of Homeland Security to be administered by the Police Department, the committee submitted a report recommending the order ought to pass. The report was accepted; the order was passed; yeas 12. Referred to the Committee on Public Safety & Criminal Justice.
