A regular meeting of the City Council of the City of Boston was held in the Christopher A. Iannella Chamber, City Hall on Wednesday, July 9, 2025 at 12:05 PM.

President Louijeune in the Chair. All councilors present

Father Michael Della Penna, Saint Leonard of Port Maurice Parish, delivered the invocation and the meeting was opened with the pledge of allegiance.

The Chair moved to adopt the minutes from the June 25, 2025 meeting. Motion prevailed.

- 1345 Message and order authorizing the City of Boston to accept and expend the amount of Six Hundred Forty-Four Thousand Four Hundred Fifty-Eight Dollars (\$644,458.00) in the form of a grant, for the US Inflation Reduction Act, awarded by the USDA Forest Service Urban and Community Forestry to be administered by the Office of Workforce Development. The grant will fund to grow an accessible, inclusive, and resilient urban forest. Referred to the Committee on Environmental Justice, Resiliency, and Parks.
