# APPROVAL OF THE OCTOBER 22, 2025 CITY COUNCIL MEETING MINUTES

# COMMUNICATIONS FROM HER HONOR, THE MAYOR:

Message and order for your approval an order to reduce the FY26 appropriation for the Reserve for Collective Bargaining by Nine Hundred Seventy-Seven Thousand Seven Hundred Forty-Nine Dollars (\$977,749.00) to provide funding for the Boston Public Schools for the FY26 increases contained within the collective bargaining agreements between the Boston Public School Committee and the City of Boston and the Administrative Guild, SEIU Local 888.

- Message and order for a supplemental appropriation order for the Boston Public School Department for FY26 in the amount of Nine Hundred Seventy-Seven Thousand Seven Hundred Forty-Nine Dollars (\$977,749.00) to cover the cost items contained within the collective bargaining agreements between the Boston Public School Committee and the Administrative Guild, SEIU Local 888. The terms of the contract are September 1, 2024 through August 31, 2027. The major provisions of the contracts include base wage increases of 2% and the flat amounts of \$250, \$900, and \$850 to be given in September of each fiscal year of the contract term. The contract also supports increased opportunities for professional development and mentoring.

I transmit herewith a supplemental appropriation order for the Boston Public Schools Department for FY26 in the amount of nine hundred seventy-seven thousand, seven hundred forty-nine dollars (\$977,749) to cover the FY26 cost items contained within the collective bargaining agreements between the School Committee of the City of Boston and the Administrative Guild, SEIU Local 888. FURTHER ORDERED: This includes the payment of all costs incidental or related thereto (the "Project"), which proposed repair Projects would materially extend the useful life of the schools and preserve assets that otherwise are capable of supporting the required educational program, and for which the City may be eligible for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of the Public Facilities Department on behalf of Boston Public Schools; and that to meet said appropriation the Collector-Treasurer be, and hereby is, authorized under the provisions of Chapter 44 of the General Laws, as amended or supplemented, or any other enabling authority, to issue from time to time, with the approval of the Mayor, bonds, notes or certificates of indebtedness of the City up to said amount, which debt issued hereunder may bear interest at variable rates, as the Collector-Treasurer shall select, be redeemable at the option of the holder thereof, at such price or prices and under such conditions as may be fixed by the Collector-Treasurer with the approval of the Mayor prior to the issuance thereof and contain terms that cause the interest thereon to be subject to federal income taxation; that this order shall constitute a declaration of official intent of the City pursuant to Treasury Regulations Section 1.15 0-2(e) to reimburse expenditures for such Projects made from funds established for such purpose as permitted by statute from proceeds of debt incurred by the City pursuant to this Order; and that pursuant to Section 12(b) of Chapter 643 of the Acts of 1983, as amended, if any part of the proceeds of sale of any bonds or notes or other obligations issued by the City under this Order remains unexpended after the work or purpose for which such bonds, notes or other obligations are issued is completed, such proceeds are hereby appropriated and may be applied by the Collector-Treasurer and City Auditor, at the direction of the Mayor, to pay the principal of, and premium and/or interest on such bonds, notes or other obligations or on any debt of the City. The City acknowledges that the MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any Project costs the City incurs in excess of any grant approved by and received from the MSBA on account of the Project shall be the sole responsibility of the City, and that the amount of borrowing authorized pursuant to this vote shall be reduced by any grant amount set forth in the Project Funding Agreement relating to the Project that may be executed between the City and the MSBA.



**RE: Text Amendment to Boston Zoning Code** 

Dear Chief Shen,

Please note I am writing to inform you that at this week's Boston City Council meeting, I will propose a text amendment to the Boston Zoning Code relative to adult entertainment in the area of Chinatown, Downtown Boston, and the Bay Village - to essentially change adult entertainment from an "allowed use" to a "conditional use". It's critical that the people of Chinatown and communities of color be treated with respect, that they receive a thorough community process and a voice in what takes place in their community. I am respectfully requesting the Planning Department's help in this endeavor.

In the 1960s, the term "Combat Zone" was given to an area for Downtown and Chinatown, which primarily included Washington Street, Boylston Street, and Kneeland Street. At present, only a few adult entertainment venues remain. However, under current zoning, it is my understanding that proponents are not required to undergo a full community process seeking variances in the neighborhood, and at a subsequent hearing at the Zoning Board of Appeal (ZBA), other than for the Groundwater Conservation Overlay District (GCOD).

This was the case in June, when a change of use at 27-29 Stuart Street appeared before the ZBA and the application was only required to have a hearing regarding GCOD. At that time, I requested a deferral of this case to allow for a public process and provide an opportunity for neighbors in Downtown Boston, Chinatown, and Bay Village to offer feedback on this nearby project.

In my opinion, this text amendment should have been addressed decades ago. With ongoing concerns regarding public process, public safety, and quality of life from neighbors, it's critical that all establishments go through a full ZBA community process moving forward. I firmly believe that my constituents in Chinatown, Downtown Boston, and the Bay Village deserve a voice in what takes place in their community. - **WHEREAS,** Bostonians deserve a City government that is grounded in transparency, and accountable to the people; and
- **WHEREAS,** Rather than bringing in costly outside counsel to address concerns as they arise, a City Inspector General will bring permanent, proactive, independent oversight of all Boston's City departments; and
- WHEREAS, Inspectors General have been appointed at some level or public agency in 34 different states, including the Commonwealth of Massachusetts, and in cities, including Chicago, Detroit, Washington, D.C., New Orleans, Baltimore, New York City, Philadelphia, and Richmond; and
- **WHEREAS,** An independent Inspector General will be able to identify mismanagement and waste, and address and oversee complaints made against Boston City departments; and
- WHEREAS, The office of the independent Inspector General will enhance accountability and transparency between City departments and the Boston City Council; NOW, THEREFORE BE IT
- ORDERED: That a petition to the General Court, accompanied by a bill for a special law relating to the City of Boston to be filed with an attested copy of this Order be, and hereby is, approved under Clause One (1) of Section Eight (8) of Article Two (2), as amended, of the Amendments to the Constitution of the Commonwealth of Massachusetts, to the end that legislation be adopted precisely as follows, except for clerical or editorial changes of form only:

PETITION FOR A SPECIAL LAW RE: AN ACT TO AMENDING THE OPERATIONS OF THE CITY OF BOSTON FINANCE COMMISSION TO ESTABLISH THE COMMISSION OF INSPECTORS GENERAL ON FINANCIAL OVERSIGHT

<u>SECTION 1.</u> Section 17 of Chapter 486 of the Acts of 1909 is hereby amended by striking the paragraph in its entirety and inserting the following section:-

SECTION 17. Appointment of the Boston Finance and Oversight Commission. In the City of Boston there shall be a Commission consisting of 5 persons, inhabitants of and qualified voters in the City of Boston, who shall have been such for at least 3 years prior to the date of their appointment. Members shall serve without compensation and be individuals with experience or expertise in auditing, administrative law, accounting, investigations, performance measurements, public policy, community engagement, or other relevant expertise. Members shall be appointed by the Governor, with one member appointed for the term of 5 years, one member for 4 years, one member for 3 years, one member for 2 years, and one member for 1 year, and thereafter as the terms of office expire in each year one member for a term of 5 years. Vacancies in the Commission shall be filled for the unexpired term by the Governor. The members of said commission may be removed by the Governor for cause.

<u>SECTION 2.</u> **Section 18 of Chapter 486 of the Acts of 1909** is hereby amended by striking the paragraph in its entirety and inserting the following section: -

**SECTION 18.** *Duties of the Commission.* The Commission shall appoint an Inspector General following a majority vote of its members who shall serve a 5-year term. The Commission shall consider candidates who meet qualifications such as expertise in accounting, auditing, financial analysis, independent government oversight, law, management analysis, public administration, investigation, criminal justice administration, or other appropriate fields. The Inspector General must hold or obtain a nationally recognized certification as a Certified Inspector General.

Additional duties of the Commission shall include reviewing reports produced by the Inspector General upon request; monitoring the implementation of recommendations and providing feedback to the Inspector General; initiating a nationally recognized Quality Assurance Review ("peer review") every 3 years; coming before the City Council upon request; reviewing the annual budget proposed by the Inspector General.

<u>SECTION 3.</u> **Section 19 of Chapter 486 of the Acts of 1909** is hereby amended by striking the paragraph in its entirety and inserting the following section: -

**SECTION 19.** *Duties of the Inspector General.* The Inspector General shall have the authority to: conduct investigations on all matters related to the finances of the City, including appropriations, debt, loans, taxation, expenditures, bookkeeping, and Administration, particularly concerning fraud, waste, abuse, mismanagement that require examination to ensure transparency, efficiency, accountability, responsibility, integrity, and compliance with applicable laws; as well as to review the policies, practices, and procedures related to these matters to identify areas for improvement.

The Inspector General shall foster investigative, educational, auditing, evaluative, preventative, and contract monitoring procedures to improve the delivery of City services, strengthen accountability, and enhance operational effectiveness, all while adhering to professional standards for Offices of Inspector General, such as those established by the AIG. To facilitate its work, the Inspector General shall engage directly with constituents as necessary to gather information for investigations, reviews, or recommendations and shall take appropriate steps to build public awareness of its purpose, processes, and procedures for receiving complaints.

The Inspector General shall have the authority to initiate investigations based on complaints from employees, residents, and business owners or, at its discretion, to address inefficiencies, waste, misconduct, abuse, or mismanagement in City operations, services, and programs.

The Inspector General shall prepare and publish an annual report of the Commission and file it with the City Clerk. The annual report may include recommendations regarding program weakness, contracting irregularities, or other institutional problems discovered by the Inspector General. The annual report shall be made available publicly online by March 1st of each year. The Inspector General shall appear in front of the City Council annually and upon request.

<u>SECTION 4.</u> **Section 20 of Chapter 486 of the Acts of 1909** is hereby amended by striking the paragraph in its entirety and inserting the following section: -

**SECTION 20.** *Employment of Experts.* The Commission shall upon request of the Inspector General, employ a number of Deputy Investigators to carry out and support the work and purposes of the Commission. The Commission will present said request to the Mayor for their review and all investigators thereafter employed shall receive stipends as determined by the Mayor commensurate with their duties and/or expenses. Employed staff shall collectively possess the knowledge, skills, and experience needed to accomplish the Commission's mission, duties, and responsibilities.

<u>SECTION 5.</u> **Section 21 of Chapter 486 of the Acts of 1909** is hereby amended by striking the paragraph in its entirety and inserting the following section: -

**SECTION 21.** *Powers of the Commission and Enforcement.* For the purpose of enabling the said commission to perform the duties and carry out the objects herein contemplated by this act, the Commission, by and through the Inspector General, is hereby empowered to inspect all City records and inquire into the management of the business of said City, and to inform itself as to the manner and methods in which the same is or has been conducted and is further authorized to summon witnesses pursuant to M.G.L c.233 s. 8.

Subject to any applicable law, auditing, investigative, and evaluative files of the Commission containing privileged or legally protected information shall be confidential and shall not be divulged to any person or agency except to the United States Attorney, the Massachusetts Attorney General, or Suffolk County District Attorney's Office, State Inspector General, or as otherwise required by law. The Commission shall implement internal safeguards to restrict access to ensure confidentiality and limit confidential auditing, investigative, and evaluative files to authorized personnel only. Subject to Public Records law, names and identities of individuals making complaints and information protected under law will not be disclosed without the individual's written consent unless required by law or judicial processes.

No person employed by, under contract to, or any agent of the City of Boston shall either directly or indirectly, take or threaten to take, direct others to take, recommend, or approve any personal action against any individual or employee as reprisal for making a complaint, testifying before, or disclosing information to the Commission and their staff. Upon notification of such a claim, the Inspector General may conduct an investigation in accordance with this Chapter.

The Mayor, the City Council, the Commission, and any governmental or quasi-governmental entity head shall not prevent, impair, or prohibit the Inspector General from initiating, carrying out, or completing any audit, investigation, review, or evaluation. Any covered entity that willfully and without justification or excuses obstructs an investigation of the Inspector General by withholding documents or testimony is subject to forfeiture of office, discipline, debarment, or any other applicable penalty.

Anyone who knows of or receives a complaint regarding misconduct, malfeasance, misfeasance, conflicts of interest, acceptance of bribes or gratuities, fraud, waste, or abuse of office should immediately report all relevant information or refer such complaint to the Commission. It should be the duty of every covered entity to cooperate with the Inspector General in any investigation pursuant to this Chapter, including the prompt provision to the Inspector General any information, document, report, record, account, or other material requested by the Inspector General in connection with an investigation, audit, review, or evaluation.

The Inspector General may not hold any elected City office until two (2) years after leaving the position and may not have worked for the City as an employee or

elected official within two (2) years of appointment. During their term, the Inspector General may not engage in an occupation for profit, except for teaching, subject to the approval of the Commission, or hold any other government office outside the duties of the Inspector General. The Inspector General shall not solicit votes or raise monetary or in-kind contributions for any candidate for an elective office. The Inspector General may be removed for cause. All employees of the commission are subject to M.G.L. 268A.

When the Inspector General has reason to believe they must recuse themselves from a matter, the Inspector General shall refer such matter to the appropriate investigatory or law enforcement agency.

#### SECTION 6.

The provisions of this act are severable and if any provision, or portion thereof, should be held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect the remaining provisions, which remain in full force and effect.

#### SECTION 7.

This act shall take effect upon its passage.

SECTION 1. Section 17 of Chapter 486 of the Acts of 1909 is hereby amended by striking the paragraph in its entirety and inserting the following section:

SECTION 17. Appointment of the Boston Inspector General Oversight Commission. In the City of Boston there shall be a Commission consisting of 5 persons, inhabitants of and qualified voters in the City of Boston, who shall have been such for at least 3 years prior to the date of their appointment. Members shall serve without compensation and be individuals with experience or expertise in auditing, administrative law, accounting, investigations, measurements, public policy, community engagement, or other relevant expertise. Members shall be appointed by the Governor, with one member appointed for the term of 5 years, one member for 4 years, one member for 3 years, one member for 2 years, and one member for 1 year, and thereafter as the terms of office expire in each year one member for a term of 5 years. Vacancies in the Commission shall be filled for the unexpired term by the Governor. The members of said commission may be removed by the Governor for cause. Such cause may include substantial neglect of duty, gross misconduct or conviction of a crime. The reasons for removal of a commission member shall be stated in writing and shall include the basis for such removal. Such writing shall be sent to the clerk of the City of Boston, the Boston City Council, and the Mayor at the time of the removal and shall be deemed to be a public document.

SECTION 2. Section 18 of Chapter 486 of the Acts of 1909 is hereby amended by striking the paragraph in its entirety and inserting the following section:

**SECTION 18.** Duties of the Commission. The Commission shall appoint an Inspector General following a majority vote of its members. The appointed Inspector General shall serve for a term of five years. The person so appointed shall be selected without regard to political affiliation and solely on the basis of integrity and demonstrated ability in accounting, auditing, financial analysis, law, management analysis, public administration, investigation or criminal justice administration.

In case of a vacancy in the position of Inspector General, their successor shall be appointed in the same manner for the unexpired term. No person shall be appointed for more than two five-year terms.

The person so appointed may be removed from office, for cause, by a majority vote of the Commission. Such cause may include substantial neglect of duty, gross misconduct or conviction of a crime. The reasons for removal of the inspector general shall be stated in writing and shall include the basis for such removal. Such writing shall be sent to the clerk of the City of Boston, the Boston City Council, and the Mayor at the time of the removal and shall be deemed to be a public document. The Commission shall annually set the salary of the Inspector General. The Inspector General must hold or obtain a nationally recognized certification as a Certified Inspector General within one (1) year of their hiring date.

Additional duties of the Commission may include supporting the Inspector General in conducting investigations, including but not limited to collecting data, conducting interviews, writing and reviewing reports; monitoring the implementation of recommendations and providing feedback to the Inspector General; conduct a performance review of the Inspector General every 2 years; coming before the City Council upon request; review, amend, and approve the annual budget proposed by the Inspector General.

No member of the Commission shall hold, or be a candidate for, any elected public office while an officer or employee, or for three years thereafter, nor shall they hold office in any political party or political committee, or participate in any political campaign of any candidate for public office while an officer or employee.

SECTION 3. Section 19 of Chapter 486 of the Acts of 1909 is hereby amended by striking the paragraph in its entirety and inserting the following section:

SECTION 19. Duties of the Inspector General. The Inspector General shall have the authority to investigate any and all business of the City of Boston, including but not limited to: conduct investigations on all matters related to the finances of the City or the county of Suffolk, including appropriations, debt, loans, taxation, expenditures, bookkeeping, and Administration, particularly concerning fraud, waste, abuse, mismanagement that require examination to ensure transparency, efficiency, accountability, responsibility, integrity, and compliance with applicable laws; as well as to review the policies, practices, and procedures related to these matters to identify areas for improvement. Whenever any pay roll, bill, or other claim against the city is presented to the mayor, city auditor, or the city treasurer, they shall, if the same seems to them to be of doubtful validity, excessive in amount, or otherwise contrary to the city's interest, refer it to the Commission,

which shall immediately investigate the facts and report thereon; and pending said report payment shall be withheld.

SECTION 5. Section 22 of Chapter 486 of the Acts of 1909 is hereby added by inserting following section:

SECTION 22. Appropriation for the Support of the Commission. The City shall

annually appropriate an amount of money sufficient for the support the operation and administration of the Commission; provided, however, that said city shall not be required to provide more money for the support of the Commission than is appropriated. The Inspector General shall present their recommended budget to the Commission and place it on record with the City Clerk by 1st Wednesday in February prior to the beginning of such fiscal year to be presented by the Mayor with the annual operating budget. In acting on appropriations for Commission costs, the Mayor and city council shall approve the total amount of the appropriations requested by the Commission, and may increase the total requested amount but neither the mayor nor the city council shall allocate appropriations among accounts or place any restriction on such appropriations. Each fiscal year appropriation shall be no less than previous year unless recommended by either the Inspector General or the Commission votes to accept lower funding.

The appropriation of said city shall establish the total appropriation for the support of the Commission, but may not limit the authority of the Commission to determine expenditures within the total appropriation; provided, however, that if the city auditor determines that Commission expenditures in any fiscal year are projected to be in excess of total budgeted expenditures for that fiscal year, as supported by appropriation and other available funding, then the Commission shall not reallocate or transfer funds from any item in the budget for that fiscal year to fund any such projected additional expenditures.

The Inspector General shall not approve the appointment of any person except to a budgeted position. The Inspector General, with the advice and consent of the Commission may apply for and receive state and federal funds in order to fulfill the duties and responsibilities of the office.

#### SECTION 6.

The provisions of this act are severable and if any provision, or portion thereof, should be held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect the remaining provisions, which remain in full force and effect.

#### SECTION 7.

This act shall take effect 120 days after passage.

#### REPORT OF COMMITTEE CHAIR

The Committee on Government Operations was referred the following docket for consideration:

Docket #0145, Petition for a Special Law Re: To establish the Commission of Inspectors General on Financial Oversight.

This matter was sponsored by Councilors Julia Mejia and Brian Worrell and was referred to the Committee on January 8, 2025.

Summary of Legislation

**Docket** #0145, is a home rule petition that seeks to amend the special acts that establish and enable the Boston Finance Commission in order to modernize and strengthen its structure, powers, and oversight capacity. The petition creates a new position of Inspector General, appointed by and accountable to the Commission, to lead investigations into fraud, waste, abuse, and mismanagement across all City departments and related agencies. Together, these changes are designed to transform the Boston Finance Commission into a more robust, well-supported, and empowered oversight body capable of providing sustained, independent accountability in municipal operations. As filed, the proposed petition does so in the ways described below.

Under Section 1, the petition renames the Boston Finance Commission to the "Boston Finance and Oversight Commission" and fixes its size at five (5) people who must be inhabitants of and qualified voters in the City of Boston for at least three (3) years prior to appointment. Under the petition, members are appointed by the Governor with staggered initial terms and five (5) year terms thereafter, and will serve without compensation. Under the petition, the Governor has the authority to remove members of the Commission for cause, and in the case of vacancies, is responsible for appointing members to fill unexpired terms.

Under Section 2, the Commission is empowered to appoint an Inspector General (IG) in the City of Boston for a five (5) year term, following a majority vote of the Commission. The petition specifies that the IG shall have experience in areas such as "accounting, auditing, financial analysis, independent government oversight, law, management analysis, public administration, investigation, criminal justice administration, and must hold or obtain a nationally recognized certification as a Certified Inspector General. Additional duties of the Commission under this section include: reviewing IG reports upon request, monitoring the implementation of recommendations, providing the IG with feedback, initiating a nationally recognized Quality Assurance Review every three (3) years, appearing before the Council "upon request, and reviewing the annual budget proposed by the Inspector General.

Under Section 3, the IG is authorized to conduct investigations on all matters related to the finances of the City, based on complaints from employees, residents, or business owners, or even at its own discretion to

address inefficiencies, waste, misconduct, abuse, or mismanagement. This section charges the IG with fostering efficient contract monitoring procedures to improve the delivery of City services, as well as engaging with constituents and building public awareness around the IG's procedures for receiving complaints. Finally, the section requires the IG to prepare and publish an annual report to be made publicly available by March 1st each year and states that the IG shall also appear in front of the City Council annually and upon request.

Under Section 4, upon the IG's request, the Commission is tasked with employing a number of Deputy Investigators with the requisite knowledge, skills, and experience necessary to support the IG in its work. This section specifies that such Deputy Investigators shall receive stipends as determined by the Mayor commensurate with duties/expenses.

Under Section 5, the Commission, by and through the Inspector General, is hereby empowered to inspect all City records, inquire into City business management, and "summon witnesses pursuant to M.G.L c.233 s. 8. Further, this section prevents the Mayor, City Council, and/or any other governmental/quasi governmental entity from obstructing such investigations and requires investigation cooperation on the behalf of all covered entities. This section also contains provisions to ensure confidentiality in investigations and prevent retaliation against anyone who files a complaint. Finally, to prevent undue influence, this section restricts the IG from engaging in other profit occupations (except approved teaching opportunities), requires the IG recuse themselves from investigations when necessary and specifies that the IG may not hold any elected City office until two (2) years after leaving the position nor may the IG have worked for the City or held any elected City office within two (2) years of appointment.

#### Information Received at Hearing

The Committee held a working session on June 5, 2025, to discuss Docket #0145. This working session was held in addition to multiple discussions held on a similar Docket assigned to the Committee in 2024 (Docket #0645, an ordinance establishing the office of Inspector General within the City of Boston). At the working session, Councilors reviewed the language of the petition, which reflects input from the State Inspector General, the National Association of Inspectors General, and the current Executive Director of the Boston Finance Commission. Discussion centered on naming conventions for the new body, with suggestions ranging from "Commission of Inspectors General" to "Finance and Oversight Commission," aiming to capture a mandate that extended beyond financial audits to encompass broader city operations. Councilors also discussed explicitly defining the commission's jurisdiction to include city departments, quasi-public agencies, and affiliated entities such as the Boston Water and Sewer Commission, the Economic Development and Industrial Corporation, and the Boston Public Health Commission.

The working session also focused heavily on funding and staffing provisions to ensure sustainability without violating the City Charter with respect to budgetary earmarks. Councilors proposed language modeled on other city commissions that would require an annual appropriation sufficient to fulfill the body's duties while granting the Inspector General authority comparable to that of a department head to hire staff and contract short-term experts. Additional discussion addressed whistleblower protections, transparency requirements, and balancing public access to records with the confidentiality of ongoing investigations. Councilors agreed that the goal was to create a modernized oversight structure capable of identifying inefficiencies, preventing misconduct, and promoting fiscal integrity across all areas of municipal government. The Committee concluded the session with plans to refine remaining language

issues in order to advance a final version that delivers strong, independent, and credible oversight, consistent with the public's expectations for accountability and ethical governance.

#### Summary of Amendments

The petition, as amended, strikes and replaces language under the ORDERED clause to allow the legislature to make reasonable amendments to the language of the petition, where necessary, within the scope of the petition's general objective. As amended, the ORDERED clause reads as:

"That a petition to the General Court, accompanied by a bill for a special law relating to the City of Boston to be filed with an attested copy of this Order be, and hereby is, approved under Clause One (1) of Section Eight (8) of Article Two (2), as amended, of the Amendments to the Constitution of the Commonwealth of Massachusetts, to the end that legislation be adopted precisely as follows, provided that the Legislature may reasonably vary the form and substance of the requested legislation within the scope of the general public objective in this petition."

The petition, as amended, strikes and replaces the title of the petition: "The Commission of Inspectors General on Financial Oversight." As amended, the title reads as:

" PETITION FOR A SPECIAL LAW RE: AN ACT TO AMENDING THE OPERATIONS OF THE CITY OF BOSTON FINANCE COMMISSION TO ESTABLISH THE BOSTON INSPECTOR GENERAL OVERSIGHT COMMISSION"

The petition, as amended, strikes and replaces language under Section 1, striking from the title of 'Section 17' "finance and" and replacing it with "Inspector General." As amended, the title of 'Section 17' under Section 1 reads as:

"Section 17. Appointment of the Boston Inspector General Oversight Commission"

The petition, as amended, inserts the following language at the end of Section 1 to clarify the meaning of "for cause" within the context of the petition.

"Such cause may include substantial neglect of duty, gross misconduct or conviction of a crime. The reasons for removal of a commission member shall be stated in writing and shall include the basis for such removal. Such writing shall be sent to the clerk of the City of Boston, the Boston City Council, and the Mayor at the time of the removal and shall be deemed to be a public document."

The petition, as amended, inserts language under Section 2 regarding the removal of the IG and the requirement that the IG obtain a nationally recognized certification within 1 year of appointment. Language is also inserted to this section to prohibit members of the Commission from participating in political campaigns or holding elected office while appointed and for three (3) years after appointment to the Commission. The petition, as amended, also strikes and inserts language under Section 2 rewording the provisions regarding the IG's appointment and selection criteria as well as those concerning additional duties of the commission, striking the requirement to initiate a quality assurance review that is "nationally recognized." As amended, Section 2 reads as:

"SECTION 2. Section 18 of Chapter 486 of the Acts of 1909 is hereby amended by striking the paragraph in its entirety and inserting the following section:

SECTION 18. Duties of the Commission. The Commission shall appoint an Inspector General following a majority vote of its members. The appointed Inspector General shall serve for a term of five years. The person so appointed shall be selected without regard to political affiliation and solely on the basis of integrity and demonstrated ability in accounting, auditing, financial analysis, law, management analysis, public administration, investigation or criminal justice administration.

In case of a vacancy in the position of Inspector General, their successor shall be appointed in the same manner for the unexpired term. No person shall be appointed for more than two five-year terms.

The person so appointed may be removed from office, for cause, by a majority vote of the Commission. Such cause may include substantial neglect of duty, gross misconduct or conviction of a crime. The reasons for removal of the inspector general shall be stated in writing and shall include the basis for such removal. Such writing shall be sent to the clerk of the City of Boston, the Boston City Council, and the Mayor at the time of the removal and shall be deemed to be a public document. The Commission shall annually set the salary of the Inspector General. The Inspector General must hold or obtain a nationally recognized certification as a Certified Inspector General within one (1) year of their hiring date.

Additional duties of the Commission may include supporting the Inspector General in conducting investigations, including but not limited to collecting data, conducting interviews, writing and reviewing reports; monitoring the implementation of recommendations and providing feedback to the Inspector General; conduct a performance review of the Inspector General every 2 years; coming before the City Council upon request; review, amend, and approve the annual budget proposed by the Inspector General.

No member of the Commission shall hold, or be a candidate for, any elected public office while an officer or employee, or for three years thereafter, nor shall they hold office in any political party or political committee, or participate in any political campaign of any candidate for public office while an officer or employee."

The petition, as amended, strikes and inserts language under the first three paragraphs of Section 3. The petition inserts language to clarify that the IG has the authority to issue subpoenas and investigate any and all City business, based on complaints from the Mayor, City Council, City vendors, grant recipients, employees of the City or agencies thereof, contracted personnel, in addition to residents, and business owners, and that the City may withhold payments when a claim has been filed with the Commission, until a report is made thereon. The petition also inserts language requiring the IG recuse themselves when necessary. The petition strikes language requiring the IG adhere to standards "such as those established by the AIG." As amended, the amended paragraphs of Section 3 read as:

"SECTION 19. Duties of the Inspector General. The Inspector General shall have the authority to investigate any and all business of the City of Boston, including but not limited to: conduct investigations on all matters related to the finances of the City or the county of Suffolk, including appropriations, debt, loans, taxation, expenditures, bookkeeping, and Administration, particularly concerning fraud, waste, abuse, mismanagement that require examination to ensure transparency, efficiency, accountability,

responsibility, integrity, and compliance with applicable laws; as well as to review the policies, practices, and procedures related to these matters to identify areas for improvement. Whenever any pay roll, bill, or other claim against the city is presented to the mayor, city auditor, or the city treasurer, they shall, if the same seems to them to be of doubtful validity, excessive in amount, or otherwise contrary to the city's interest, refer it to the Commission, which shall immediately investigate the facts and report thereon; and pending said report payment shall be withheld.

The Inspector General shall foster investigative, educational, auditing, evaluative, preventative, and contract monitoring procedures to improve the delivery of City services, strengthen accountability, and enhance operational effectiveness, all while adhering to professional standards for Offices of Inspector General. To facilitate its work, the Inspector General shall engage directly with constituents as necessary to gather information for investigations, reviews, or recommendations and shall take appropriate steps to build public awareness of its purpose, processes, and procedures for receiving complaints.

The Inspector General shall have the authority to initiate investigations based on complaints from the Mayor, City Council, City vendors, grant recipients, employees of the City or agencies thereof, contracted personnel, residents, and business owners or, at its discretion, to address inefficiencies, waste, misconduct, abuse, or mismanagement in City operations, services, and programs. The Inspector General shall have the power to issue subpoenas. When the Inspector General has reason to believe they must recuse themselves from a matter, the Inspector General shall refer such matter to the appropriate investigatory or law enforcement agency."

The petition, as amended, strikes Section 4 in its entirety and replaces it with an amended version of Section 5, described below. Section 5 of the petition is renumbered to be Section 4. The new Section 4, is amended by inserting language into the sixth paragraph related to the prohibition of the IG holding any employment positions with the city. As amended, the sixth paragraph of the new Section 4 reads as:

"The Inspector General may not hold any elected City office until two (2) years after leaving the position and may not have worked as a City of Boston employee, with an exception made for the existing Executive Director of the Finance Commission, or for a Boston elected official within two (2) years of appointment. During their term, the Inspector General may not engage in an occupation for profit, except for teaching, subject to the approval of the Commission, or hold any other government office outside the duties of the Inspector General. The Inspector General shall not solicit votes or raise monetary or in-kind contributions for any candidate for an elective office. All employees of the commission are subject to M.G.L. 268A."

The petition, as amended, inserts a new Section, Section 5, regarding appropriations for the support of the Commission. As amended, Section 5 reads as:

"SECTION 22. Appropriation for the Support of the Commission. The City shall annually appropriate an amount of money sufficient for the support the operation and administration of the Commission; provided, however, that said city shall not be required to provide more money for the support of the Commission than is appropriated. The Inspector General shall present their recommended budget to the Commission and place it on record with the City Clerk by 1st Wednesday in February prior to the beginning of such fiscal year to be presented by the Mayor with the annual operating budget. In acting on

appropriations for Commission costs, the Mayor and city council shall approve the total amount of the appropriations requested by the Commission, and may increase the total requested amount but neither the mayor nor the city council shall allocate appropriations among accounts or place any restriction on such appropriations. Each fiscal year appropriation shall be no less than previous year unless recommended by either the Inspector General or the Commission votes to accept lower funding.

The appropriation of said city shall establish the total appropriation for the support of the Commission, but may not limit the authority of the Commission to determine expenditures within the total appropriation; provided, however, that if the city auditor determines that Commission expenditures in any fiscal year are projected to be in excess of total budgeted expenditures for that fiscal year, as supported by appropriation and other available funding, then the Commission shall not reallocate or transfer funds from any item in the budget for that fiscal year to fund any such projected additional expenditures.

The Inspector General shall not approve the appointment of any person except to a budgeted position. The Inspector General, with the advice and consent of the Commission may apply for and receive state and federal funds in order to fulfill the duties and responsibilities of the office."

Finally, the petition as amended strikes and replaces language under Section 7, to effectuate the petition 120 following its passage, as opposed to upon its passage.

#### Committee Chair Recommended Action

As Chair of the Committee on Government Operations, I recommend moving the listed docket from the Committee to the full Council for discussion and formal action. At this time, my recommendation to the full Council will be that this matter **OUGHT TO PASS IN A NEW DRAFT.**

The Committee on Planning, Development, and Transportation was referred the following dockets for consideration:

Docket #1353, Message and order for the confirmation of the reappointment of Norm Stembridge as a member of the Zoning Board of Appeal, for a term expiring May 1, 2028.

Docket #1354, Message and order for the confirmation of the appointment of Rob Steinberg as a member of the St. Botolph Architectural Conservation District Commission, for a term expiring June 20, 2026.

These matters were sponsored by Mayor Michelle Wu and were referred to the Committee on July 9, 2025.

Docket #1412, Message and order for the confirmation of the appointment of Celina Barrios-Millner as a Member of the Zoning Board of Appeal, for a term expiring May 1, 2028.

This matter was sponsored by Mayor Michelle Wu and was referred to the Committee on August 6, 2025.

#### Summary of Legislation

**Docket** #1353 is an Order regarding the reappointment of Norm Stembridge of 27 Gaston Street, #1, Boston, Massachusetts 02121, as a member of the Zoning Board of Appeal for a term expiring May 1, 2028, provided that members may continue to serve until a replacement member is appointed. Norm Stembridge is a neighborhood mayoral appointee and will serve as a primary member.

**Docket** #1354 is an Order regarding the appointment of Rob Steinberg of 246 W. Newton Street, Apt. 1, Boston, MA 02116 as a member of the St. Botolph Architectural Conservation District Commission for a term expiring June 20, 2026.

**Docket #1412** is an Order regarding the appointment of Celina Barrios-Millner of 66 Crest Street, Boston, MA 02132, as a member of the Zoning Board of Appeal for a term expiring May 1, 2028, provided that members may continue to serve until a replacement member is appointed Celina Barrios-Millner is an at-large mayoral appointee and will serve as an alternate member.

#### Information Received at Hearing

The Committee held a hearing on Thursday, October 23, 2025 to discuss Dockets #1353-1354 and #1412. The Chair explained that these dockets were for various appointments to the Zoning Board of Appeal and the St. Botolph Architectural Conservation District Commission. The Chair introduced Norm Stembridge, Rob Steinberg, and Celina Barrios-Millner who provided testimony regarding their appointments.

Mr. Stembridge stated that he hopes that his reappointment is a way to continue his service to the City of Boston as a neighborhood mayoral appointee and it would be an extension of the volunteer work that he has done in the neighborhood of Roxbury combatting the negative impacts of urban renewal and displacement. He stated that he will stay clear of any conflicts real or perceived, and will listen strongly to the Inspectional Services Department, the City of Boston Planning Department, residents, and advocates to come to the best decisions that he and the board can make. When asked to describe his philosophy on zoning and land use in Boston, Mr. Stembridge highlighted the need for zoning reform and ongoing neighborhood rezoning efforts to combat the City's housing and affordability crisis. Regarding granting zoning variances, he stated that he will very carefully consider all factors involved especially where it will have impacts in neighborhoods that have historically experienced disinvestment.

Mr. Steinberg discussed his possible appointment to the St. Botolph Architectural Conservation District Commission by showing his appreciation to serve the City by enhancing the livability of the St. Botolph neighborhood while protecting historical preservation through the Commission. He stated that he graduated from the Massachusetts Institute of Technology obtaining a Masters Degree in Construction Management and a Masters in Business Administration. He has spent more than a dozen years as a construction project manager and discussed his understanding of the building trades and architectural cohesion. Mr. Steinberg discussed St. Botolph's history and architectural characteristics by highlighting the impressive artisanal mason work of the buildings in the neighborhood and the importance of preserving these characteristics.

Ms. Barrios-Millner discussed her possible appointment by emphasizing her past professional and advocacy work in the City of Boston. As a resident of Boston for the past 23 years, Ms. Barrios-Millner started her career as a community organizer which has brought her to all corners of the city and shined a light on Boston's rich resources and opportunities as well as disparities and uneven access to those resources. Following this work, she joined the City of Boston in various capacities including in the Office of Immigrant Advancement, Director of Equity and Inclusion under the Office of Economic Development implementing the City's Supplier Diversity program, and oversaw the Boston Employment Commission. Currently she is serving in the Urban Institute, a public research institution that is based in Washington D.C., stating that through this work she can bring insights of what other municipalities are doing through zoning efforts and inclusionary practices. She also serves on the Boston Landmarks Commission and the Highland Park District Architectural Commission. Ms. Barrios-Milner stated she will not only bring her own vision and values from her lived experience in the City of Boston but will also strongly take into account recommendations from the City's zoning and building experts as well as from the community.

#### Committee Chair Recommended Action

As Chair of the Committee on Planning, Development, and Transportation, I recommend moving the listed docket from the Committee to the full Council for discussion and formal action. At this time, my recommendation to the full Council will be that this matter **OUGHT TO PASS**.

**WHEREAS**, the MA Executive Office of Labor and Workforce Development and Economic Development & Industrial Corporation of Boston, are being petitioned for the issuance of funds to the OYEO Admin; and

# ORDINANCE CODIFYING THE OFFICE OF YOUTH ENGAGEMENT AND ADVANCEMENT

- **WHEREAS,** The City of Boston is committed to encouraging and upholding a diverse and welcoming community for all its residents, especially youth; *and*
- **WHEREAS,** The City of Boston recognizes that empowering the city's youth with opportunities for self-advocacy not only ensures the needs of youth are met, but also encourages youth to see themselves as part of Boston's community; *and*
- **WHEREAS,** The City has faced issues with difficulty allowing more youth to get involved or access materials to benefit themselves and allow themselves to grow; *and*
- WHEREAS, Recognizing the necessity of these resources, Mayor Wu established The Office of Youth Engagement and Advancement in January 2023 to effectively provide and support young residents with opportunities to shape City policy, and to provide services for residents ages 14-25 throughout Boston to gain access to opportunities and resources needed to thrive; and
- **WHEREAS,** The Office of Youth Engagement and Advancement additionally provides a platform for youth-serving professionals and organizations to receive support and resources to better serve their youth communities across the city; *and*
- **WHEREAS,** Enhancing and expanding the reach of the Office of Youth Engagement and Advancement will improve the safety and civic empowerment of Boston's youth; and
- **WHEREAS,** The Office of Youth Engagement and Advancement is dedicated to combating the social and institutional discrimination that youth residents and visitors face, guaranteeing the voices of the Boston youth and experiences within youth communities are heard, supported, and prioritized; and
- WHEREAS, The experiences of the Office of Youth Engagement and Advancement are shaped by: prioritizing the active engagement of young people in decision-making processes, providing resource programs and opportunities that implement

personal and professional growth, and acting as a link between youth and available services and opportunities across different City departments and community organizations; *and* 

- **WHEREAS,** Given the large impact of the Office of Youth Engagement and Advancement, and the growing request for services and community partnerships, it is imperative to institutionalize its purpose, powers, and duties; *and*

#### **SECTION 1**

# 15-15 CREATION OF THE OFFICE OF YOUTH ENGAGEMENT AND ADVANCEMENT

#### **15-15.1** *Established*

There shall be established in the City of Boston an office known as the Office of Youth Engagement and Advancement (hereafter the "Office"), which shall be under the charge of an Executive Director, appointed by the Mayor and who shall have the powers and duties of a department head with respect to execution of contracts and matters of personnel management within said Office.

## **15-15.2** *Purpose*

This Ordinance is to establish the Office of Youth Engagement and Advancement in the City of Boston to promote and guarantee a consistent and institutionalized role for young people to shape City policy, programs, and resource allocation that directly impacts the youth. By codifying the Office of Youth Engagement and Advancement, it ensures clear responsibilities, and oversight mechanisms allowing the office to stay accountable for youth in the Boston community. As Boston is an extremely diverse community, the Office shall ensure youth from all backgrounds have a seat at the table when making decisions regarding City policy. When youth see their City government commit to their futures with long-term policy, it creates trust in local government, and encourages leadership, civic engagement, and innovation.

#### **15-15.3** *Powers and Duties*

The Office shall serve as the principal entity responsible for supporting, engaging, and empowering youth ages 14 to 25 throughout the City of Boston. The Office shall advance youth

development by amplifying youth voices in municipal policy-making processes and facilitating equitable access to opportunities across City departments and partner organizations.

In fulfillment of its duties, the Office of Youth Engagement and Advancement shall:

- a. administer and oversee youth leadership and civic engagement initiatives, including but not limited to, the Mayor's Youth Council and Youth Lead Change, a participatory budgeting program through which youth allocate municipal funds to citywide priorities
- b. operate YouthLine, a centralized resource hub connecting young people to local services and opportunities
- c. coordinate professional development and capacity-building programming for youth workers and service providers
- d. convene citywide events such as the Mayor's Youth Summit
- e. manage the Youth Partner Network, a collaborative of professionals representing youth-serving organizations
- f. conduct and maintain Youth Speaks Boston, a citywide youth survey used to assess and respond to the needs and experiences of Boston's youth
- g. manage Boston After Dark, a seasonal initiative that provides evening programming to promote youth safety and prevent violence during the summer months.

Through these initiatives and other activities, the Office of Youth Engagement and Advancement shall promote leadership development, community engagement, safety, and opportunity for Boston's young people, and serve as a liaison between youth, City government, and community stakeholders.

The Office, under the charge of the Executive Director, shall have the powers necessary to carry out the above duties. The Office shall have the necessary staff to accomplish these aims. City departments, agencies, commissions, and offices are encouraged to make their services reasonably available to the Office to support its duties.

### **SECTION 2**

The provisions of this Ordinance are severable, and if any provision, or portion thereof, should be held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such unconstitutionality or invalidity will not affect the remaining provisions, which will remain in full force and effect.

#### **SECTION 3**

The provisions of this Ordinance shall take effect immediately upon passage.

ORDINANCE REGARDING THE SAFETY AND EFFICACY OF COMMERCIAL AUTONOMOUS VEHICLE OPERATIONS RELATIVE TO WORKERS, EMERGENCY FIRST RESPONDERS, AND RESIDENTS IN THE CITY OF BOSTON

- **WHEREAS,** The City of Boston is committed to a conscientious approach to the introduction of new technologies that prioritizes the well-being and safety of its residents, the strength of its local economy, and the security of its essential workforce; *and*
- WHEREAS, The introduction of Commercial Autonomous Vehicle Operations in the City of Boston without substantial regulation could have significant negative impacts on the local economy by displacing thousands of commercial drivers, and rideshare drivers whose labor and vehicle investments have been instrumental in creating the passenger transportation network industry in Boston over the past decade; and
- **WHEREAS,** The introduction of Commercial Autonomous Vehicle Operations in the City of Boston without substantial regulation could have significant negative impacts on the local economy by disrupting the hundreds of small businesses that serve the rideshare driver community; *and*
- WHEREAS, A comprehensive, public, and participatory study is required to determine whether the introduction of Commercial Autonomous Vehicle Operations in the City of Boston will serve to benefit its residents, local economy, and rideshare drivers, who would be most directly impacted by such operations. NOW, THEREFORE

#### Be it ordained by the City Council of Boston as follows:

That the City of Boston Code, Ordinances, is amended by adding the following new sections and subsections:

#### **SECTION 1.** Purpose & Scope

The purpose of this Ordinance is to establish rules and regulations governing the operations of Commercial Autonomous Vehicle Operations within the City of Boston in furtherance of the public interest, safety, and convenience.

#### **SECTION 2.** Definitions

When used in this section, unless the context otherwise requires, the following terms shall have the following meanings:

"Autonomous Vehicle" means any vehicle equipped with technology that has been integrated into that vehicle that meets the definition of Level 3, Level 4, or Level 5 of SAE International's "Taxonomy and Definitions for Terms Related to Driving Automation Systems for On-Road Motor Vehicles, standard J3016 (APR2021)," as may be revised.

"Commercial Autonomous Vehicle Operations" means the use of Autonomous Vehicles for commercial purposes, including but not limited to transporting passengers or goods.

**SECTION 3.** *Commercial Autonomous Vehicle Operations in the City of Boston*No entity shall operate Commercial Autonomous Vehicle Operations in the City of Boston until the study set forth in Section 5 below is completed and operational permit requirements are established by the Mayor of the City of Boston in accordance with the provisions of this ordinance.

# **SECTION 4.** Commercial Autonomous Vehicle Operations Labor and Small Business Impact Advisory Board

The Mayor shall establish a Commercial Autonomous Vehicle Operations Labor and Small Business Impact Advisory Board to evaluate the introduction of Commercial Autonomous Vehicle Operations in the City of Boston and provide advice and guidance to the Mayor. The Board shall include the Chief of the Worker Empowerment Cabinet as Chair, and the following officials or their designees as members: the Commissioner of the Boston Police Department, the Chief Technology Officer, the Commissioner of the Department of Transportation, the Director of Small Business, and appointees at the discretion of the Mayor, included but not limited to, representatives from the Greater Boston Labor Council, the App Drivers Union, the International Brotherhood of Teamsters, and the United Food and Commercial Workers Local 1445.

#### **SECTION 5.** Commercial Autonomous Vehicle Operations Study and Permit Process

a. The Commercial Autonomous Vehicle Operations Labor and Small Business Impact Advisory Board shall enlist an independent research institution with expertise in ridehail labor economics to conduct a comprehensive review of Commercial Autonomous Vehicle Operations and evaluate its potential deployment in the City of Boston. Such review shall include, but not be limited to: an independent economic impact study conducted to determine the short- and long-term effects of Commercial Autonomous Vehicle Operations on rideshare drivers, commercial drivers; including workforce displacement projections; economic impacts on Transportation Network Drivers; impacts on the effectuation of M.G.L. ch. 150F; avoidance of preemption under M.G.L. ch. 159A1/2; reemployment pathways for displaced rideshare drivers, commercial drivers; economic displacement impacts on businesses that serve commercial drivers, rideshare drivers; and financial impacts on the City of Boston, including those due to reductions in tax revenues to the Commonwealth. b. The Commercial Autonomous Vehicle Operations Labor and Small Business Impact Advisory Board shall also examine the potential for Commercial Autonomous Vehicle Operations to interfere with the operations of first responders, an evaluation of the ability of Autonomous Vehicles to navigate the City of Boston's unique streets and roads, and an assessment of the congestion impacts of Commercial Autonomous Vehicle Operations.

c. The Board shall hold a series of public hearings to obtain testimony from rideshare drivers, commercial drivers and members of the public. Following the release of preliminary findings, there shall be a public comment period of no fewer than thirty (30) days.

d. By July 1, 2026, the Board shall publish a final review report on a publicly-accessible website, which shall include recommendations to the Mayor on whether Commercial Autonomous Vehicle Operations should be permitted to operate in the City of Boston, and regarding requirements for a potential permit process for Commercial Autonomous Vehicle Operations.

#### **SECTION 6.** Human Safety Operator

Any permit process must include the following requirements: (a) an Autonomous Vehicle operating in the City of Boston shall not transport passengers or goods unless a human safety operator is physically present in the vehicle and has the ability to monitor the performance of the vehicle and intervene if necessary, including but not limited to taking over immediate manual control of the vehicle or shutting off the vehicle; and (b) that Autonomous Vehicles and human safety operators must meet all applicable local, state and federal requirements.

#### **SECTION 7.** Enforcement

The provisions of this section may be enforced by all enforcement mechanisms authorized, including but not limited to the noncriminal disposition process of M.G.L. c. 40, § 21D, and, if applicable, by seeking to restrain a violation by injunction.

#### **SECTION 8.** Severability

The provisions of this Ordinance are severable and if any provision, or portion thereof, should be held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect the remaining provisions which shall remain in full force and effect.

#### **SECTION 9.** Effective Date

The provisions of this Ordinance shall take effect immediately upon passage.

#### LIVING WAGE ORDINANCE FOR CITY EMPLOYEES

- WHEREAS, Boston has long been a leader in promoting fair pay and economic justice, including through its Boston Jobs and Living Wage Ordinance, which requires that people working on City contracts earn enough to live and raise a family in our city; and
- **WHEREAS,** The same values that guide how Boston treats contracted workers should also guide how the City treats its own employees, many of whom are the first point of contact for residents and the face of city government in neighborhoods across Boston; and
- **WHEREAS,** A small but meaningful number of Boston's municipal employees earn less than the City's current Living Wage, often in entry-level positions in departments such as Parks, Public Works, and Facilities; and
- **WHEREAS,** Ensuring that every City employee earns at least the Living Wage would improve recruitment and retention, reduce turnover, and strengthen the quality of public services residents rely on every day; and
- **WHEREAS,** Low-wage City employees often struggle to afford housing, transportation, and childcare in the very city they serve, which undermines Boston's commitment to being an equitable and inclusive employer; and
- **WHEREAS,** Raising the pay of Boston's lowest-wage employees would have a modest fiscal impact but a significant human impact, helping families achieve greater stability and reinforcing the principle that public service should not come at the cost of financial hardship; and
- **WHEREAS,** This ordinance respects the City's collective bargaining process and Mayor's executive authority ensuring a responsible and thoughtful phased approach that can be implemented through the Mayor's Office of Human Resources; and
- **WHEREAS,** By aligning the City's own pay practices with the Living Wage standard it already expects of its vendors, Boston can lead by example and demonstrate that a just wage is both achievable and essential; **NOW, THEREFORE**

#### Be it ordained by the City Council of Boston as follows:

#### Section 1: General

The City of Boston Code, Ordinances, *Chapter XXIV: Boston Jobs, Living Wage and Prevailing Wage Ordinance*, is hereby amended by the following sections:

#### Section 2: Title and Purpose

In § 24-1, after the last sentence, insert:

"It is further the purpose of this Chapter to ensure that employees of the City of Boston are compensated at no less than the Living Wage established herein, in order to promote fair and equitable compensation for municipal service consistent with fiscal prudence and applicable collective bargaining and budgetary requirements."

#### Section 3: Definitions

In § 24-2, <u>insert</u> the following new definition in alphabetical order:

*'CITY EMPLOYEE.'* A person employed by the City of Boston whose compensation is paid directly by the City and subject to federal or state tax withholding by the City of Boston.

#### Section 4: Exemptions

<u>Insert</u> new paragraph (E) to § 24-3.2 as follows:

- (E) The Living Wage requirement, as applied to City Employees, shall not apply to:
  - (1) Positions compensated solely by stipends, including board and commission stipends;
  - (2) Youth employment programs, including those funded or administered as "Youth Programs;"
  - (4) Internships, volunteer or unpaid positions.

#### Section 5: Applicability

<u>Insert</u> new sub-section(B) through (E) in § 24-6.1 as follows:

- § 24-6.1 Applicability.
- (A) Covered vendors shall pay no less than the Living Wage to covered employees.
- (B) The City of Boston shall pay no less than the Living Wage to all City Employees,

except as provided in § 24-3.2(E).

- (C) The Office of Human Resources shall ensure that any City pay schedule, step, or rate of compensation falling below the Living Wage is adjusted to comply with this Chapter on the effective date of each annual Living Wage revision established pursuant to § 24-6.2.
- (D) Nothing in this section shall be construed to preclude the negotiation of wages above the Living Wage through collective bargaining or to diminish any rights afforded under M.G.L. c. 150E.
- (E) Notwithstanding any other provision of this Chapter, the Living Wage shall apply to City Employees who are not covered by a collective bargaining agreement. For City Employees covered by a collective bargaining agreement, the Living Wage shall apply only as and when compliance with its terms is incorporated into a successor agreement negotiated after the effective date of this ordinance.

#### Section 6: Implementation

- (A) The Office of Human Resources, in consultation with the Office of Workforce Development and the City Auditor, shall prepare and transmit to the City Council a written implementation plan detailing administrative procedures, fiscal implications, and timelines necessary to effectuate this ordinance.
- (B) Said plan shall be submitted to the City Council within sixty (60) days prior to the effective date of this ordinance.
- (C) Nothing contained herein shall be deemed or construed to authorize any expenditure, payroll adjustment, or obligation in excess of appropriations duly made, or in contravention of Massachusetts General Laws Chapter 44 or other applicable provisions of law.
- (D) The Mayor, through the Office of Human Resources, shall retain executive authority for administration and execution of this ordinance consistent with the City Charter and budgetary appropriations.

#### Section 7: Severability

The provisions of this ordinance are severable and if any provision, or portion thereof, should be held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect the remaining provisions, which remain in full force and effect.

#### Section 8: Effective Date

This ordinance shall take effect on July 1, 2026, and shall apply to wages paid on and after said date.

#### **HOME RULE PETITION**

- **WHEREAS,** The City of Boston has used property tax as its largest source of revenue for decades, with it accounting for \$3.47 billion of its projected revenue, 72 percent, in FY26, and \$3.3 billion of its revenue, 70 percent, in FY25; and
- **WHEREAS,** Declining commercial values and rising residential values led to residents paying their largest share of property taxes in at least four decades in FY25, according to Boston Municipal Research Bureau; *and*
- WHEREAS, A temporary shift in the tax burden on commercial properties from 175 percent to 181 percent, and an increase in the residential homeowners exemption from 35 percent to 40 percent have both been floated as worthy short-term solutions to the shifting tax burden problem; and
- **WHEREAS,** A long-term solution in Boston's property tax code that works within the state's current Proposition 2.5 rules should emphasize fairness and protect homeowners and the majority of renters; *and*
- **WHEREAS,** Under current tax code, large multi-family rental properties are financed, transacted, and assessed using income-based methods typical of commercial assets, yet are currently billed at the residential rate; and
- WHEREAS, An example of this is a 307-unit apartment building in Seaport that is assessed at \$124 million, pays \$1.4 million in annual taxes, amounting to \$4,560 per unit despite asking for an average of \$9,000 per unit in monthly rent, while a 2-bedroom unit owned by a small landlord in South Boston pays \$11,510 in annual taxes on that unit despite its monthly rent being \$4,000; and
- WHEREAS, Charging large apartment buildings with 30 units or more a commercial rate and giving them a housing exemption of 10 percent would cause the above 307-unit building to pay \$3.25 million in taxes, about \$10,586 per unit, and the small landlord's tax burden would be lowered to \$10,228 for the above 2-bedroom unit; and
- **WHEREAS,** By reclassifying large apartment buildings, corporate landlords in the City of Boston would be more equitably taxed, and the result would be that residential

rates would be lowered across the city as a greater burden of the fixed Proposition 2.5 property tax revenue would fall on corporate landlords rather than on small landlords or homeowners; *and* 

- **WHEREAS,** Further creating a supplemental affordable housing exemption for corporate landlords who offer 80% of units at rents lower than those set for 80% of AMI individuals would incentivize landlords to keep rents lower than the market might otherwise dictate; and
- WHEREAS, Tax rates classified by apartment building size are already used in cities such as New York, Washington, D.C., Chicago (Cook County), Providence, Minnesota and Colorado while cities such as Austin, Texas, which has a property tax of \$46 per \$1,000 valuation, show that high property taxes don't have an effect on rent nor on housing production; and
- **WHEREAS,** Even if property taxes had an effect on rental prices, the majority of tenants in the city would see the taxes their landlords pay decrease under this plan because the majority of apartment units are located in buildings of 30 units or fewer; and
- **WHEREAS,** Boston should also petition to give out 7-year tax agreements reflective of the residential rate on any new housing of 100 units or more to ensure this tax plan doesn't hamper housing production across the city; *and*
- **WHEREAS,** Boston already led the way in housing production in the prior decade, even compared to cities such as Austin when accounting for the size of the two cities on a per-square mile basis, with Boston adding 2.4 times more housing per square mile than Austin from 2010 to 2020; and
- WHEREAS, The City of Boston must explore changes to the tax code, categorizing large apartments as commercial properties, offering corporate landlords a housing exemption, and additionally incentivizing rents to be lower than 80% of the AMI through a supplemental affordable housing exemption; and
- WHEREAS, This petition will do the following: 1. Reclassify large apartment buildings with 30 or more units as Class Three "commercial residential"; 2. Establish a 10% housing exemption to all Class Three "commercial residential," similar to the residential homeowners exemption, which will be absorbed within Class Three; 3. Create a supplemental 50% affordable housing exemption to all affordable Class Three "commercial residential" similar to the residential homeowners exemption, which will be absorbed within Class Three; 4. Shorten standard tax agreements from 15 years to 7 years; 5. Phase in any property tax increases by allowing for an increased housing exemption in the first two fiscal years, to offset any property tax increases for all newly classified Class Three "commercial residential" buildings; and
- WHEREAS, This petition will effectively lower the residential tax rate and stabilize the commercial tax rates while remaining tax levy-neutral; NOW, THEREFORE BE

**ORDERED:** That a petition to the General Court, accompanied by a bill for a special law relating to the City of Boston to be filed with an attested copy of this Order be, and hereby is, approved under Clause One (1) of Section Eight (8) of Article Two (2), as amended, of the Amendments to the Constitution of the Commonwealth of Massachusetts, to the end that legislation be adopted precisely as follows, provided that the Legislature may reasonably vary the form and substance of the requested legislation within the scope of the general public objective of this petition:

# PETITION FOR A SPECIAL LAW RE: AN ACT RELATIVE TO REDEFINING COMMERCIAL AND RESIDENTIAL DEFINITIONS, AND CREATING FURTHER EXEMPTIONS

<u>SECTION 1.</u> Section 2A of chapter 59 of the Massachusetts General Laws is hereby amended by inserting "Except in the City of Boston" at the beginning of line eleven.

#### SECTION 2.

Notwithstanding General Law Chapter 59, Section 2A, or any General or special law to the contrary, in the City of Boston, the assessors shall determine the fair cash valuation of real property according to section thirty-eight; and if certified by the commissioner pursuant to subsection (c) shall classify such real property according to the following uses:—

"Class one, residential", property used or held for human habitation containing one or more dwelling units including rooming houses with facilities designed and used for living, sleeping, cooking and eating on a non-transient basis, including a bed and breakfast home with no more than three rooms for rent. Such property includes accessory land, buildings or improvements incidental to such habitation and used exclusively by the residents of the property or their guests. Such property shall include: (i) land that is situated in a residential zone and has been subdivided into residential lots; and (ii) land used for the purpose of a manufactured housing community, as defined in section thirty-two F of chapter one hundred and forty. Such property shall not include hotels, motels, or property used or held for the production of income providing 30 or more dwelling units for rent. Such property may be exempt from taxation under other provisions of law.

"Class two, open-space", land which is not otherwise classified and which is not taxable under the provisions of chapters sixty-one, sixty-one A or sixty-one B, or taxable under a permanent conservation restriction, and which land is not held for the production of income but is maintained in an open or natural condition and which contributes significantly to the benefit and enjoyment of the public. In the event that the City of Boston has elected to adopt section 2A of chapter 61, section 4A of chapter 61A or section 2A of chapter 61B, class two, open-space shall include land taxable under chapter 61, 61A or 61B.

"Class three, commercial", property used or held for use for business or investment/income purposes and not specifically excluded from or includible in another class, including but not limited to any commercial, business, retail, trade, service, recreational, agricultural, artistic, sporting, fraternal, governmental, educational, medical

or religious enterprise, for non-profit purposes. Property used or held for the production of income and providing 30 or more dwelling units for rent shall be included within this class, and referred to hereafter as "Class Three commercial residential" parcels.

"Class four, industrial", property used or held for use for manufacturing, milling, converting, producing, processing or fabricating materials; the extraction or processing of materials unserviceable in their natural state to create commercial products or materials; the mechanical, chemical or electronic transformation of property into new products and any use that is incidental to or an integral part of such use, whether for profit or non-profit purposes; and property used or held for uses for the storage, transmitting and generating of utilities regulated by the department of public utilities or the department of telecommunications and cable. Such property may be exempt from taxation under other provisions of law.

Where real property is used or held for use for more than one purpose and such uses result in different classifications, the assessors shall allocate to each classification the percentage of the fair cash valuation of the property devoted to each use according to the guidelines promulgated by the commissioner.

Real property which is exempt from taxation under section five shall be classified according to said guidelines.

(c) Classification of real property shall not be implemented in the City of Boston until the commissioner has certified in writing to the assessors of the City of Boston that the assessments on the real property that they propose to make are at full and fair cash valuation as required by section thirty-eight and that a majority of its assessors are qualified to classify its property.

<u>SECTION 3.</u> The City of Boston shall ensure the total property taxes owed by a Class Three commercial residential property increase less than 33%, year over year, for each of the first two fiscal years after this law has gone into effect.

<u>SECTION 4.</u> Section 5C of chapter 59 of the Massachusetts General Laws is hereby amended by inserting "This section shall apply to each city and town within the Commonwealth, except the City of Boston." before the first line.

SECTION 5. Notwithstanding Chapter 59, Section 5C, or any general or special laws to the contrary, With respect to each parcel of real property classified as Class One, residential, in the City of Boston, certified by the commissioner to be assessing all property at its full and fair cash valuation, and at the option of the mayor, with the approval of the city council, as the case may be, there shall be an exemption equal to not more than 35 per cent of the average assessed value of all Class One, residential parcels and Class Three commercial residential parcels, within the City of Boston; provided, however, that such an exemption shall be applied only to the principal residence of a taxpayer as used by the taxpayer for income tax purposes. This exemption shall be in addition to any exemptions allowable under section five; provided, however, that in no instance shall the taxable valuation of such property after all applicable exemptions be reduced below ten per cent of its full and fair cash valuation, except through the applicability of clause Eighteenth of section five. Where, under the provisions of section five, the exemption is based upon an amount of tax rather than on valuation, the reduction of taxable valuation for purposes of the preceding sentence shall be computed by dividing the said amount of tax by the residential

class tax rate of the City of Boston and multiplying the result by one thousand dollars. For purposes of this paragraph, "parcel" shall mean a unit of real property as defined by the assessors in accordance with the deed for such property and shall include a condominium unit.

With respect to each parcel of real property classified as Class Three commercial residential, in the City of Boston, certified by the commissioner to be assessing all property at its full and fair cash valuation, and at the option of the mayor, with the approval of the city council, there shall be an exemption equal to not more than 10 per cent of the tax bill for parcels that are defined as Class Three commercial residential. For each of the first two fiscal years after this law has gone into effect, the City of Boston shall be empowered to increase said exemption to not more than 50 per cent, at the option of the mayor, with the approval of the city council. This exemption must be applied for before the first day of the fiscal year of which it will be applied. This exemption shall be in addition to any exemptions allowable under section five; provided, however, that in no instance shall the taxable valuation of such property after all applicable exemptions be reduced below ten per cent of its full and fair cash valuation, except through the applicability of clause Eighteenth of section five. For purposes of this paragraph, "parcel" shall mean a unit of real property as defined by the assessors in accordance with the deed for such property.

With respect to each parcel of real property classified as Class Three commercial residential and that has offered 80% of its units at the same level of rent as 80% AMI rent or lower for the preceding year, as certified by the City of Boston by Sept. 1 of the following fiscal year, certified by the commissioner to be assessing all property at its full and fair cash valuation, and at the option of the mayor, with the approval of the city council, there shall be an exemption equal to not more than 50% of that following year's tax bill. This exemption shall be in addition to any exemptions allowable under section five; provided, however, that in no instance shall the taxable valuation of such property after all applicable exemptions be reduced below ten per cent of its full and fair cash valuation, except through the applicability of clause Eighteenth of section five. For purposes of this paragraph, "parcel" shall mean a unit of real property as defined by the assessors in accordance with the deed for such property.

In the event in which exemptions are made available hereunder, a taxpayer aggrieved by the failure to receive such exemptions may apply for such exemptions to the assessors, in writing, on a form approved by the commissioner, on or before the deadline for an application for exemption under section 59.

A timely application filed hereunder shall, for the purposes of this chapter, be treated as a timely filed application pursuant to section fifty-nine.

For purposes of this section, with respect to real property owned by a cooperative corporation, as defined in section 4 of chapter 157B, that portion which is occupied by a member pursuant to a proprietary lease as such member's domicile and is used as such member's principal residence for income tax purposes shall be deemed to be real property owned by such member for purposes of this section, provided that the portion of the real estate is represented by the member's share or shares of stock in the cooperative corporation and the percentage of such portion to the whole is the percentage of such member's shares in the cooperative corporation to the total outstanding stock of the corporation, including shares owned by the corporation. Such portion of such real property shall be eligible for exemption from taxation pursuant to this section if such member

meets all requirements for such exemption. Any exemption so provided shall reduce the taxable valuation of the real property owned by the cooperative corporation; provided, however, that the reduction in taxes realized thereby shall be credited by the cooperative corporation against the amount of such taxes otherwise payable by or chargeable to such member. Nothing in this paragraph shall be construed to affect the tax status of any manufactured home or mobile home under this chapter, but shall apply to the land on which such manufactured home or mobile home is located if all other requirements of this paragraph are met. This paragraph shall take effect in the City of Boston upon its acceptance by the City of Boston.

#### SECTION 6.

Section 10 of chapter 121A of the Massachusetts General Laws is hereby amended by inserting "and in the City of Boston, for a period of 7 years" in the first sentence of the first paragraph after "fifteen years"

Section 10 of chapter 121A of the Massachusetts General Laws is hereby amended by inserting "and in the City of Boston, for a period of 7 years" in the first sentence of the third paragraph after "fifteen years"

Section 10 of chapter 121A of the Massachusetts General Laws is hereby amended by inserting "and in the City of Boston, for a period of 7 years" in the first sentence of the sixth paragraph after "fifteen years"

Section 10 of chapter 121A of the Massachusetts General Laws is hereby amended by inserting "or in the City of Boston, the 7 year period" in the first line of the tenth paragraph after "fifteen year period"

Section 10 of chapter 121A of the Massachusetts General Laws is hereby amended by inserting "or in the City of Boston, for a 7 year period" in the third line of the tenth paragraph after "fifteen year period"

Section 10 of chapter 121A of the Massachusetts General Laws is hereby amended by inserting "or in the City of Boston, for a 7 year period" in the first sentence of the sixteenth paragraph after "fifteen year period"

#### SECTION 7

The provisions of this act are severable and if any provision, or portion thereof, should be held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect the remaining provisions, which remain in full force and effect.

#### **SECTION 8.**

This act shall take effect at the start of the next fiscal year after its passage.

# ORDER FOR A HEARING REGARDING PARKING ACCESS FOR TRAVELING BOSTON PUBLIC SCHOOLS EMPLOYEES

WHEREAS, Many Boston Public Schools (BPS) employees—including special education teachers, related service providers, specialists, and support staff—travel to multiple school sites throughout the city each day as part of their professional responsibilities; and

**WHEREAS**, These traveling employees play a vital role in providing equitable access to education, ensuring that students across neighborhoods receive the specialized instruction and services they need; and

**WHEREAS**, Currently, BPS provides a limited number of parking passes to employees who must travel between school sites, but reports indicate that the number of available passes is insufficient to meet the needs of all eligible staff; and

WHEREAS, Some employees have incurred significant parking fines and personal costs while performing their official duties due to a lack of available parking or the inability to access a valid parking permit; and

**WHEREAS**, The absence of a consistent, transparent system for allocating or renewing parking passes creates inequities among staff and may disproportionately burden educators and specialists who already serve in high-need or hard-to-staff areas; and

WHEREAS, Supporting traveling educators with equitable access to parking is an important part of the City's broader efforts to recruit and retain highly qualified teachers and staff, particularly in critical service areas such as special education and student support; and

**WHEREAS**, The City Council has a responsibility to review how interdepartmental policies—including those of Boston Public Schools and the Boston Transportation Department—affect employees' ability to perform their duties efficiently and safely;

**NOW, THEREFORE BE IT ORDERED:** That the appropriate committee of the Boston City Council hold a hearing to review the current parking policies and supports for traveling Boston

Public Schools employees, evaluate the process for distributing parking passes, and identify potential solutions to ensure equitable and accessible parking options for all eligible staff.

# RESOLUTION RECOGNIZING OCTOBER AS PEDESTRIAN SAFETY MONTH IN THE CITY OF BOSTON

- WHEREAS, Since 2015, incidents reported to Boston EMS of pedestrians struck by vehicles have broadly decreased, signaling initial success with pedestrian safety initiatives, but since the start of this year, 207 pedestrians have been struck, demonstrating the need for continued improvements to pedestrian safety measures; and
- **WHEREAS,** In 2017, the City of Boston changed the default speed limit from 30 mph to 25 mph to help make the City safer for people of all ages and abilities and to meet the goals set forth in Vision Zero Boston; *and*
- **WHEREAS,** Despite a national decline in pedestrian deaths, Massachusetts saw a 16 percent increase in pedestrian fatalities in 2024 with Boston accounting for the most pedestrian deaths by motor vehicles; *and*
- WHEREAS, Crafting streets with robust pedestrian safety infrastructure—including but not limited to speed humps, raised crosswalks and intersections, narrowed streets, lights, and signage—is a key part of keeping streets safe for commuters of all modes; and
- **WHEREAS,** Community members, civic organizing groups, and elected officials have called for continued pedestrian safety improvements from changes in infrastructure, changing how we manage traffic, and enforcement of existing traffic laws often neglected by commuters; *and*
- **WHEREAS,** Recognizing Pedestrian Safety Month demonstrates that the Boston City Council is committed to pursuing roads that are safe for all commuters, especially pedestrians who are the most vulnerable; **NOW, THEREFORE BE IT**
- **RESOLVED:** That the Boston City Council express its support for continued and additional investments in pedestrian safety infrastructure, that Bostonians look out for their neighbors traveling Boston on foot, and that the Boston City Council hereby recognize October as Pedestrian Safety Month in the City of Boston.

#### RESOLUTION RECOGNIZING NOVEMBER 2025 AS YOUTH AND YOUNG ADULT HOMELESSNESS AWARENESS MONTH

- **WHEREAS,** 1 in 30 youth ages 13 to 17, and 1 in 10 young adults ages 18 to 25 in the United States will experience some form of homelessness this year; *and*,
- **WHEREAS,** Many factors contribute to youth and young adults experiencing homelessness, including neglect, lack of housing security, being kicked out after coming out or being outed as LGBTQIA+, transitioning out of the foster care system, intergenerational poverty, abuse, and lack of employment; *and*,
- **WHEREAS,** Nationally, the number of unaccompanied youth experiencing homelessness increased by 10% between 2023 and 2024, with a 14.4% increase in major cities, and increased prevalence reported in 33 states and the District of Columbia (Boston 44th Annual Homeless Census); *and*,
- **WHEREAS,** With every day that a youth or young adult experiences homelessness, the likelihood of future homelessness increases by 2%; and,
- WHEREAS, In Massachusetts, amongst unaccompanied youth and young adults under the age of 25 who are unstably housed or experiencing homelessness, 65% identify as BIPOC, and 26% identify as LGBTQ+ (Massachusetts Youth Count 2024); and,
- WHEREAS, Youth and young adults with intersectional identities are often at greater risk of poverty and homelessness; amongst LGBTQ+ youth of color in Greater Boston, 32.7% are unemployed, 15.5% are unstably housed, and 30.9% are food insecure (Williams Institute); and,
- **WHEREAS,** LGBTQ+ youth are 120% more likely to experience homelessness than their cisgender heterosexual counterparts (True Colors United), and 28% of LGBTQ+ youth reported experiencing homelessness or housing instability at some point in their lives (The Trevor Project); and,

- WHEREAS, Transgender youth report the highest prevalence of homelessness, as well as the highest levels of discrimination within the shelter system, compared to cisgender heterosexual and cisgender LGBTQ+ youth (Deal, Doshi, and Gonzales 2023), and there was a 28% increase in transgender youth homelessness in just one year from 2022 to 2023 (Housing and Urban Development); and,
- WHEREAS, Data collection and reporting on youth and young adults experiencing homelessness tends to underestimate the scale of the problem due to a lack of a national standard for defining unaccompanied youth, as well as overlooking housing instability like couch surfing and sleeping in cars, and there is often a particular lack of LGBTQIA+ respondents to surveys due to exclusion, fear, or denial, so the number of youth and young adults who are impacted is likely even larger than existing data reveals (MA Commission on LGBTQ+ Youth FY2025 Recommendations); and,
- WHEREAS, Nationally, amongst unaccompanied homeless youth between ages 13 and 25, 29% have spent time in foster care, compared to approximately 6% of all children, and 46% have spent time in juvenile detention, jail, or prison (HUD Voices of Youth Count); and,
- **WHEREAS,** More than 5,000 Boston Public Schools students, comprising 10% of the district, were homeless at some point during the 2023-2024 school year; *and*,
- **WHEREAS,** Nationally in 2021, high school students experiencing homelessness were nearly twice as likely to have seriously considered suicide or made a suicide plan, and more than 3 times as likely to have made a suicide attempt within the past year; and,
- **WHEREAS,** A 2019 national study found the high school graduation rate for students experiencing homelessness was 68%, compared to 80% for low-income students and 85.5% for all students; *and*,
- WHEREAS, The January 31, 2024 Boston Annual Homelessness Census identified 132 unaccompanied youth up to age 24, a 17.9% increase from 2023, as well as 1,150 families, a 1.7% increase from 2023, who were sleeping on the street or staying in emergency shelter, transitional housing, or domestic violence shelter programs; and,
- **WHEREAS,** Youth and young adults experiencing homelessness in Massachusetts identify transportation as one of the most significant barriers to accessing shelter and long-term housing (Massachusetts 2024 Youth Count); *and*,

WHEREAS, Since 2007, November has been officially recognized by the United States Congress as National Youth and Young Adult Homelessness Awareness Month, to elevate awareness of the causes and potential solutions of youth and young adult homelessness, and to uplift the experiences and needs of the young people who experience homelessness; NOW, THEREFORE BE IT

#### **RESOLVED:** That the Boston City Council:

- (1) Commits itself to ensuring continued awareness year-round by both the Council and the public about the causes and impacts of youth and young adult homelessness in Boston, and further dedicates itself to the pursuit of solutions;
- (2) Commends and supports the many organizations and volunteers who work tirelessly to prevent youth and young adult homelessness in Boston, and who support Boston's young people experiencing homelessness, including but not limited to BAGLY, Boston CASA, Boston Youth Action Board, Breaktime, Bridge Over Troubled Waters, Home for Little Wanderers, More than Words, Roca, St. Mary's Center for Women and Children, Y2Y, and the Boston Public Schools Homeless Education Resource Network (HERN) and Re-Engagement Center (REC);
- (3) Recognizes the month of November 2025 as Youth and Young Adult Homelessness Awareness Month to support and further encourage such efforts.

Sixty Day Orders<sup>1</sup>

#### <sup>1</sup>Section 17E of Chapter 452 of the Acts of 1948 (as amended):

The mayor from time to time may make to the city council in the form of an ordinance or loan order filed with the city clerk such recommendations as he may deem to be for the welfare of the city. The City Council shall consider each ordinance or loan order so presented and shall either adopt or reject the same within sixty days after the date when it is filed as aforesaid. If such ordinance or loan order is not rejected within sixty days, it shall be in force as if adopted by the city council unless previously withdrawn by the mayor.

Section 15 of Chapter 190 of the Acts of 1982 (as amended by Section 2 of Chapter 701 of the Acts of 1986) The city council shall take definite action on any supplementary appropriation order and any order for a transfer of appropriations by adopting, reducing or rejecting it within sixty days after it is filed with the city clerk; and in the event of their failure to do so, such supplementary appropriation order or transfer as submitted by the mayor shall be in effect as if formally adopted by the city council.



#### <sup>2</sup>Section 17F of Chapter 452 of the Acts of 1948 (as amended):

The city council may at any time request from the mayor specific information on any municipal matter within its jurisdiction, and may request his presence to answer written questions relating thereto at a meeting to be held not earlier than one week from the date of the receipt of said questions, in which case the mayor shall personally, or through a head of a department or a member of a board, attend such meeting and publicly answer all such questions. The person so attending shall not be obliged to answer questions relating to any other matter.



#### <sup>3</sup>Section 22 of Chapter 190 of the Acts of 1982:

Every order of the city council approving a petition to the general court pursuant to Clause (1) of Section 8 of Article 2 of the amendments to the Constitution of the Commonwealth shall be presented to the mayor who shall forthwith consider the same, and, within fifteen days of presentation, either approve it, or file with the city council a statement in detail of his reasons for not approving the same, including any objection based on form, on content, or both; provided, that no such order shall be deemed approved or in force unless the mayor affixes his signature thereto.

The following matters were previously filed with the City Council and have been referred to a committee. Matters in committee can be brought back before the City Council pursuant to City Council Rule 24. The following *definitions* describe different types of matters in committee:

*Ordinances*: Local laws enacted by the Boston City Council and the Mayor that become part of the City Code of Ordinances.

**Loan Orders:** Authorization for the City of Boston to incur debt and expend money for projects, purchases, or other obligations.

*Orders*: Directives that authorize action. Orders are legally binding but are not part of the City Code of Ordinances.

Council and Mayor, as well as passage by the state legislature.

*Order for a Hearing*: A formal request sponsored by a councilor that a committee of the Boston City Council conduct a hearing about a particular

matter, issue, or policy that impacts the City of Boston. An Order for a Hearing is not a law and is not voted on by the City

Council. The only action concerning an Order for a Hearing that can be taken at a City Council meeting is the administrative

action of placing it on file.

Legislative Resolution: A recommendation concerning policy issues that may urge action on particular matters. Legislative resolutions have no legal

effect. Legislative resolutions represent a particular position or statement by a Councilor, Councilors, or the City Council as

a whole.
