Dear Councilors:

I transmit herewith for your approval an Order to confirm the following named persons on the attached Order as Constables of the City of Boston pursuant to City of Boston Code, Chapter 2, Section 2-7.2.

Confirmation of these persons as Constables of the City of Boston will authorize such constables to serve civil process upon the filing of bond for the period commencing May 1, 2026 and ending on April 30, 2029. Due to additional requirements imposed upon constables by the *Act Relative to Justice, Equity and Accountability in Law Enforcement in the Commonwealth*, these appointments do not include the power to execute an arrest unless and until such constable obtains a certification from the Peace Officer Standards and Training Commission pursuant to Massachusetts General Laws Chapter 6E.

I urge your Honorable Body to adopt this Order so that the following named persons may be confirmed as Constables for the City of Boston.
