A regular meeting of the City Council of the City of Boston was held in the Christopher A. Iannella Chamber, City Hall on Wednesday, November 15, 2023 at 12:00 P.M.

President Flynn in the Chair. Absent, Councilors Fernandes Anderson and Mejia.

City Clerk Alex Geourntas, delivered the invocation and the meeting was opened with the pledge of allegiance to the flag.
