I hereby transmit for your approval an Order amending City of Boston Code, Ordinances, Section 9-9.12, *Inspection of Exterior Walls and Appurtenances of Buildings Requiring Periodic Inspection*. This Ordinance provides the Inspectional Services Department (“ISD”) with an important tool to ensure the ongoing safety and professional inspection of building facades across the City of Boston. Adopted in 1995, this Ordinance has allowed ISD to certify structural soundness and Building Code compliance for thousands of buildings, old and new, in the City. This Order to amend the Ordinance will modernize the language to reflect advancements in building inspection technologies, provide more detailed analysis of the structures themselves, and give ISD greater enforcement capabilities through updated violations and fines.

I urge your Honorable Body to adopt this Order expeditiously, so that the City can continue to ensure the safety of our built environment and the safety of the people who live and work in, and visit the City of Boston.

AN ORDINANCE AMENDING THE CITY OF BOSTON CODE, ORDINANCES, SECTION 9-9.12 - INSPECTION OF EXTERIOR WALLS AND APPURTENANCES OF BUILDINGS REQUIRING PERIODIC INSPECTION.

Be it ordained by the City Council of Boston as follows:

SECTION 1: City of Boston Code, Ordinances, Section 9-9.12, is hereby amended by striking said section in its entirety and replacing it with the following:

9-9.12 Inspection of Exterior Walls and Appurtenances of Buildings Requiring Periodic Inspection.

a. **Definitions.**

Certificate of Occupancy. A document issued by the Department pursuant to 780 CMR 111.

Commissioner. Commissioner of the Inspectional Services Department or a designee.

Department. City of Boston Inspectional Services Department.

Exterior walls and appurtenances. Exterior walls and appurtenances shall mean (1) any exterior wall of a building over seventy (70') feet in height; or classified as a high rise structure, or (2) any exterior wall of an unoccupied building, of over thirty-five thousand (35,000) cubic feet and excluding residential buildings that are classified as three family, two family, or single family except as required by the Commissioner.

Exterior Wall Affidavit. An affidavit submitted by a building owner along with an exterior wall inspection report, on a form provided by the Department.

Exterior Wall Certificate. A certificate issued by the Commissioner certifying that an Exterior Wall Inspection Report and Affidavit has been submitted to the Department by a building owner showing proof of inspection and that the building is in a safe condition.

Exterior Wall Inspection Report. A written report by a registered professional certifying the results of the examination clearly documenting the condition of the exterior walls and appurtenances thereto. The report shall include a record of all significant deterioration, Unsafe Conditions and movement observed as well as a statement regarding the water tightness of the exterior surfaces, as described in subsection (e) of this Section. Such report must be signed by, or bear the professional seal of, the registered architect or engineer.

Registered Professional. A Commonwealth of Massachusetts licensed Professional Engineer experienced in the practice of structural engineering or a licensed Registered Architect knowledgeable in the design, construction, and inspection of building facades.

Safe. A condition of a building wall or any appurtenance thereto that is neither an Unsafe condition nor Safe with a Repair and Maintenance Program.

Safe with a Repair and Maintenance Program. A condition of a building's exterior wall or any appurtenance thereto or any part thereof that the Registered Professional does not consider Unsafe at the time of inspection, but requires repairs or maintenance within a time period designated by the Professional in order to prevent its deterioration into an Unsafe condition.

Substantial Improvement. Alterations or repairs to be made to a structure and its facade within any period of twelve (12) months, if such alterations or repairs cost more than fifty percent (50%) of the physical value of the structure or structures. Physical value shall be based on the assessed value, as recorded on the assessment rolls of the City as of the January 1 preceding the date of the filing of an application for a building permit with the Inspectional Services Department.

Unsafe Condition. A condition of a building's exterior wall or any appurtenance thereto or part thereof that is dangerous to persons or property and requires prompt remedial action.

b. Periodic Inspections, Reports Required.

Every exterior wall defined above shall be inspected in the case of an occupied structure at least once every five (5) years and in the case of an unoccupied structure at least once a year. Provided, however, that any building that has been substantially improved within the preceding five (5) years, shall not be required to be inspected for the purpose of complying with this Section 9-9.12, for ten (10) years following the issuance of a Certificate of Occupancy by the Department.

The inspection shall be made and a report thereon prepared by a Registered Professional and shall be filed with the Commissioner together with a fee in the amount of two hundred (\$200.00) dollars within thirty (30) days of the inspection.

The Commissioner shall issue an exterior wall certificate only after having received satisfactory proof of inspection and the inspection report of the Registered Professional that said exterior wall is deemed to be in a safe condition. No structure referenced in said section shall be occupied without such certificate. Prior to issuing a certificate the Commissioner may in the Commissioner's discretion require inspection by the Department at a charge of two hundred (\$200.00) dollars which must be paid prior to issuance of the certificate.

Upon the filing of an inspection report indicating the existence of an Unsafe Condition, the Commissioner shall affix the appropriate violation on the structure and the owners, or agent, shall immediately commence repairs to remedy the violation and obtain all necessary permits for such repair work.

c. Compliance and Interaction with Other Laws.

The exterior wall certificate required under this Section is in addition to, and not in lieu of, any other permits or licenses which may be required by the Inspectional Services Department or other public authority concerning occupation or operation of the building or structure.

d. Inspection Procedures.

i. Before proceeding with inspection of a building falling under the requirements of this Section, the Registered Professional shall review previous reports, inspections, and evidence of repairs made in the past five (5) year period, including confirmation that all areas previously determined to require remediation in less than five (5) years (as noted in any previous report) have been addressed.

ii. The inspection shall be conducted by or under the supervision of the Registered Professional, and performed to the best of his/her knowledge and belief. The Registered Professional shall determine the extent of the inspection required, based upon the known history of the building, the nature of the materials used, and the conditions observed. The Registered Professional shall determine methods employed in the inspection, but need not be physically present at the location where the inspection is made.

iii. The methods used to inspect a building shall permit a physical, hands-on inspection of the building. The Registered Professional may use other methods of inspection as deemed appropriate, including the use of digital imaging, video and drone technology appropriate to complete a comprehensive inspection, except that a physical inspection from a scaffold or other observation platform is required for a representative sample of the exterior wall. The Registered Professional shall determine what constitutes a representative sample.

iv. The Registered Professional shall employ the appropriate professional standard of care to detect distressed and questionable structural conditions such as delaminating, separating, splitting or fracturing of material or components as well as movement or displacement indicative of unsound facade materials or loss of structural support. If a distressed condition is identified, the Registered Professional shall order any other inspections and/or tests that may be required to determine the significance and probable cause of the observed distress.

v. During the course of the inspection, photographs shall be taken and/or sketches made to properly document the location of all conditions observed that are either Unsafe or Safe with a Repair and Maintenance Program.

vi. Upon discovery of any Unsafe Condition the Registered Professional shall immediately notify the owner of the building by electronic mail; and shall, within twelve (12) hours of discovery, notify the Commissioner in writing and in an electronic format determined by the Commissioner.

e. Report Requirements.

The report shall include, on the front page, the name and license number of the Registered Professional and shall be signed, sealed and dated by the Registered Professional in accordance with the professional registration laws of the Commonwealth of Massachusetts, and shall include:

- i. The address and the location from the nearest intersection.
- ii. The name, mailing address, telephone number and email address of the owner of the building and of the owner's agent or person in charge, possession or control of the building, if any.
- iii. A description of the building, including number of stories, height, plan dimensions, usage, age and type of exterior wall construction, and system of water management.
- iv. A brief history of any settlements, repairs, revisions to exterior enclosures, if available.
- v. The date of the start and completion of the inspection, a detailed description of the procedures used in making the inspection, and the extent and location of all physical inspections performed.
- vi. A report of all conditions including but not limited to significant deterioration and movement observed as well as a statement concerning the apparent water-tightness of the exterior surfaces, and the deleterious effect of exterior appurtenances, including exterior fixtures, flagpoles, signs, parapets, copings, guard rails, window frames (including hardware and lights), window guards, window air conditioners, flower boxes, and similar items. The report shall classify each such condition as Safe, Unsafe, or Safe with a Repair and Maintenance Program.
- vii. The probable causes of the reported conditions.
- viii. The status of the exterior maintenance.
- ix. For any conditions listed in the previously filed report (if any), whether such conditions have been repaired and/or maintained as recommended in that report.
- x. Recommendations for repairs or maintenance, if appropriate, including the recommended time frame for the repairs or maintenance to be performed.
- xi. The classification of the building according to the following scheme:
 - a. "Unsafe", if there is at least one Unsafe Condition.
 - b. "Safe with a Repair and Maintenance Program", if there is a condition that is "Safe with Repair and Maintenance Program" and there are no Unsafe conditions.
 - c. "Safe", in all cases other than (a) or (b).
- xii. Photographs and/or sketches documenting the locations of any conditions that are either Unsafe or Safe with a Repair and Maintenance Program.
- xiii. A statement by the Registered Professional indicating which repairs and/or maintenance require the obtaining of work permits prior to their commencement.
- xiv. A statement signed by the owner or agent of the building, acknowledging receipt of a copy of the report and acknowledging all required repairs and/or maintenance (if any) and the recommended time frame for performing such repairs and/or maintenance.

xv. The Registered Professional's certification that the physical inspection was performed in accordance with applicable rules and regulations and within the appropriate professional standard of care.

xvi. The Registered Professional's seal and signature.

xvii. Such other matters as the Commissioner may by regulation require.

The Registered Professional may submit an amended report within thirty (30) days of the initial submission. The amended report shall clearly indicate any change from the initial report and all reasons for such changes.

f. Unsafe Conditions.

Within twenty-four (24) hours of being notified of an Unsafe Condition by a Registered Professional, the owner of a building shall take any actions necessary to protect public safety, such as erecting sidewalk sheds, fences, and/or safety netting. Such actions shall be considered as an effort to remedy an emergency situation and appropriate permit applications shall be submitted within the next three (3) days to the Commissioner.

Within ten (10) days of the receipt or filing of a report identifying an Unsafe Condition, the owner of a building shall commence work to correct the condition and work shall continue without interruption until the Unsafe Condition has been corrected, unless there has been an unforeseen delay (e.g. weather, labor strike). Work to correct an Unsafe Condition shall take priority over any other permitted work at the building. Within two weeks after the Unsafe Condition has been corrected, the Registered Professional shall reinspect the building and file with the Commissioner a detailed amended report stating the condition of the building.

g. Conditions That Are Safe with a Repair and Maintenance Program.

The owner of the building is responsible for ensuring that the conditions described in the report as "Safe with a Repair and Maintenance Program" are repaired and the actions identified by the Registered Professional are completed within the time frame designated by the Registered Professional or by such time necessary to prevent a condition from becoming an Unsafe Condition, whichever is sooner.

h. Violations.

Any person or entity being the assessed owner (which shall include any trustee of a trust) or being the person in control of a structure requiring an exterior wall certificate who shall fail to have the structure inspected or fail to file the inspection report with the required fee or who shall suffer

occupancy of such a structure without a valid certificate shall be punished by a fine of three hundred (\$300.00) dollars. Each day that such violation exists shall constitute a separate offense.


Any Unsafe Condition that results from failure to follow a maintenance plan recommended by the Registered Professional shall constitute a violation of this Section and shall be punishable by a fine of three hundred (\$300.00) dollars. Each day that such violation exists shall constitute a separate offense.

The provisions of this section may be enforced in accordance with the noncriminal disposition process of M.G.L. c. 40, s. 21D, and, if applicable, by seeking to restrain a violation by injunction.

The provisions of this section may also be enforced according to M.G.L. Chapter 40U as accepted by the City of Boston, also known as the "Green Ticket" law.



The Boston City Council's Committee on Planning, Development and Transportation to which was referred the following:

Docket #0376 – Message and order authorizing the City of Boston to accept and expend the amount of Four Hundred Ninety Two Thousand Two Hundred Eighty Six Dollars (\$492,286.00) in the form of a grant, Accelerating Clean Transportation For All, awarded by Massachusetts Clean Energy Center to be administered by the Transportation Department.

The grant will fund the launch of an e-cargo bike delivery pilot, which will include supporting local businesses to join the program.

This matter is sponsored by the Mayor and was referred to the Committee on Planning, Development and Transportation on March 16, 2022.

The Committee on Planning, Development and Transportation held a public hearing on May 6, 2022, to take testimony and consider the same.

The hearing was chaired by Councilor Michael Flaherty at the request of the Committee Chair - Councilor Frank Baker

Councilors Present: Chair - Councilor Michael Flaherty, Councilor Ruthzee Louijeune and Councilor Julia Mejia

Letters of support were read into the record from Council President Ed Flynn and Councilor Liz Breadon

Vineet Gupta, Director of Planning - Boston Transportation Department and Harper Mills, E-Cargo Bike Project Manager - Boston Transportation Department, made a presentation on the particulars of this grant and responded to questions from Councilors.

The presentation of the Boston Transportation Department included:

Boston Delivers is a neighborhood delivery service pilot program. This service will make deliveries to and from local businesses in Allston and the surrounding area. Instead of motor vehicles, packages will be delivered by electric cargo bikes. The Boston Transportation Department will partner with a third party operator that will provide the electric cargo bikes, make the deliveries, and coordinate delivery logistics. Deliveries can take place between:

- **A participating local business and their customer**
- **A participating local business and another business**
- **A supplier to a participating small business**

Deliveries may be made up to 3-5 miles away from the participating business. There is potential for this program to expand into other neighborhoods.

The goals of the Pilot Program are to:

- **Support local businesses. The City will provide financial and technical support to participating businesses. This program will help businesses provide a free delivery service where they may not already offer one. It will also encourage consumers to buy goods locally.**
- **Reduce pollution. This pilot program will reduce GHG emissions by replacing motor vehicle trips with e-cargo bike trips. The rise in the use of on-demand delivery services has led to more vehicles delivering fewer goods per trip. These vehicles are increasing pollution, noise, and congestion - using e-cargo bikes for last mile delivery may be a solution.**
- **Improve safety on our streets. The City aims to improve safety by reducing the size, speed, and environmental impacts of commercial delivery vehicles. The number of delivery vehicles has grown significantly. This has led to more conflicts between pedestrians, cyclists and vehicles, which has increased the potential for serious injury and death.**
- **Reduce urban congestion. The City aims to right-size delivery vehicles to better fit Boston's streets. Many of Boston's streets were not originally designed to accommodate large vehicles. Often, delivery vehicles stop in bus, bike, and vehicle travel lanes. This results in congestion that affects the whole transportation network.**

Funding for this Pilot has been budgeted as follows by Mass CEC but they are flexible on exact numbers:

- **\$128,352 for a BTM Program Manager for approximately 20-24 months. The City would be responsible for benefits.**
- **\$76,934 for services provided by MAPC**
- **\$287,000 to hire a vendor to implement the E-Cargo Bike pilot in Allston Brighton which includes the \$30K set aside for Allston Village Main Streets. We are in the middle of an RFP process to select our vendor.**

Based on the testimony and information presented at the hearing and having considered the same I respectfully recommend that this matter ought to Pass.

- WHEREAS,* He played drums and guitar, was an avid woodworker, loved the outdoors, and was deeply involved with the Boston Latin School Junior Classical League, making history while demonstrating his knowledge of Latin classics and achieving the highest levels at Certamen tournaments; *and*
- WHEREAS,* Jairam was a Field Team Member of Branching Out, a career development and educational program hosted by the Olmsted Center for Landscape Preservation, where he contributed to the stewardship of the National Park System in the Northeast; *and*
- WHEREAS,* A member of Youth on Board and the Boston Student Advisory Council's Climate Justice Team, Jairam provided powerful testimony at a Boston City Council hearing in March 2019 on the urgent policy changes needed to address climate change while centering young people in the climate justice movement; *and*
- WHEREAS,* He is remembered as a young disruptive thinker with a free spirit guided by relentless passion for his pursuits, especially environmental advocacy; *and*
- WHEREAS,* An Annual Lecture on Environmental Racism/Justice and the "Jairam Miguel Rodrigues Rao Prize for Work on Environmental Racism and Justice" were established by the Environmental Studies Program at the College of the Holy Cross to honor his dedication toward environmental activism from an early age; *and*
- WHEREAS,* Jairam lived every day as if it were his last, fighting urgently against climate change and environmental degradation, dedicating his life to making the world a better place, while touching the lives and hearts of many; *NOW THEREFORE BE IT*

ORDER FOR A HEARING ON WORKFORCE DEVELOPMENT HOUSING FOR CITY OF BOSTON EMPLOYEES

- WHEREAS,** The City of Boston Code Section 5-5.3 states that “ Every person first employed by the City of Boston on or after July 1, 1976, shall be a resident of the City of Boston, and shall not cease to be a resident of the City of Boston during his employment by the City;” *and*
- WHEREAS,** Boston is the third most expensive city in the United States to rent in, according to a recently released report by digital home renting service Zumper, with the median rent price for a 1-bedroom in Boston at \$2,660, up by slightly over 27% in one year and the median rent for a 2-bedroom in the city at \$2,990, up by 15% in the past year; *and*
- WHEREAS,** In 2020, the Department of Health and Human Services set the federal poverty level at \$27,750 for a family of four, and the Boston Planning and Development Agency states that 70% of the Area Median Income, the ceiling at which most affordable units are designated, is \$84,550; *and*
- WHEREAS,** Data from the 2021 Employee Earnings Report finds that roughly 7500 individuals on the city’s payroll earned a yearly wage between the poverty wage of \$27,750 and the Area Median Income of 70% at \$84,550; *and*
- WHEREAS,** In a time when housing prices are increasing beyond the means most people can afford, and many residents are choosing to leave the city to find affordable homes elsewhere, city employees are forced to find subsidized or substandard housing to keep their jobs with the city; *and*
- WHEREAS,** Cities and towns across the United States are creating housing subsidies or building units explicitly designated for city and county employees; *and*
- WHEREAS,** Teton County, Wyoming, currently owns 24 employee rental units, which they rent out to public servants. The Residences at Government Center in Washington D.C. was built on previously vacant county-owned land and is open to low- to moderate-income county and private-sector employees; *and*

WHEREAS, The City of Boston has a hardworking and dedicated workforce who deserve to have access to resources and housing that allows them to stay in the City of Boston; ***NOW THEREFORE BE IT***

ORDERED:

That the appropriate committee of the Boston City Council holds a hearing to discuss workforce development housing for City of Boston employees, representatives from the City of Boston, including the Office of Fair Housing and Equity, the Mayor’s Office of Housing, the Office of Workforce Development, and the Boston Housing Authority, in addition to housing advocates and members of the public are encouraged to attend.

SPENDING FOR ENGLISH LANGUAGE LEARNERS**

WHEREAS, One of the fundamental responsibilities of the Boston City Council to to ensure that there is accountability, transparency, and accessibility in all city business, including the appropriation of funds to Boston Public Schools; *and*

WHEREAS, In 2022 Boston Public Schools (BPS) enrolls over 17,000 English Learner students, representing 31% of the District’s total student population; *and*

WHEREAS, A December 2021 report submitted to the Department of Justice (DOJ) from Boston Public Schools found that of more than 11,000 English learners in BPS, 30 percent are not receiving enough of the right instruction, with a certified teacher surrounded by the right group of students; *and*

WHEREAS, In Boston, there are roughly 4,000 English Learners with disabilities who often have to choose between receiving support for their disability or their language needs; *and*

WHEREAS, The Boston School Committee and the Boston Public Schools state that access to native language is a priority, BPS has not yet developed strategic operational plans to implement access to native language as enabled by the LOOK Act either for English Learners or for English Learners with Disabilities; *and*

WHEREAS, According to a letter written by the BPS office of English Language Learners, addressed to the English Language Learners Task Force in 2021 there were only 2 full-time positions to support English Learners with disabilities and “were looking forward to filling both roles” to ensure that this group of students is receiving the services and targeted support to attend to both the needs of language acquisition and the disability; *and*

WHEREAS, According to a BPS report on 2021 MCAS results for English Learners (October 2021) presented to the ELL Task Force, the outcomes for these students raise huge concerns among parents, advocates, community and school leaders as 94% of English Learners fail the state English Language Arts MCAS exam in grades

3-8 and more than 96% of English Learners with Disabilities in those grades fail MCAS; the comparable figures for 10th grade are a 97% failure by English Learners and a nearly 98% failure rate for English Learners with Disabilities; *and*

WHEREAS,

According to that same letter written by the BPS office of English Language Learners, addressed to the English Language Learners Task Force in 2021, BPS has some of the lowest levels of data entry compliance in the past 6 years, and about 12% of ELs (~2,000) have no data entry in Aspen SIS, Boston Public Schools' main student information system used by teachers, parents, and students; *and*

WHEREAS,

While data is collected around educator diversity in terms of racial background, very little information is known or collected around language diversity amongst our educators; *and*

WHEREAS,

BPS received an investment of \$10 million in federal relief money over two years to expand programs that teach students in Spanish and other languages. The funding would pay for hiring and training teachers and developing curriculum; *and*

WHEREAS,

The Boston City Council has an obligation to ensure accountability, transparency, accessibility, and oversight over Boston Public Schools and city spending, especially in regards to large amounts of funding allocated towards solving a major issue in the schools; ***NOW THEREFORE BE IT***

ORDERED:

That the appropriate committee of the Boston City Council holds a hearing regarding government transparency and accessibility of service provision and return on investment of spending for English Language students and English Language Learners with disabilities in the City of Boston. Representatives from the Boston Public Schools, the Boston School Committee, the English Language Learners Task Force, in addition to advocates, individuals with lived experiences, and members of the public are encouraged to attend.

- WHEREAS,** Since March 14, 1958, the United States has maintained the most enduring trade embargo against Cuba in our nation's history; *and*
- WHEREAS,** On December 17, 2014, U.S. President Barack Obama and former Cuban President Raul Castro executed an agreement to re-establish diplomatic relations and cooperation between the two countries on issues of mutual interest; *and*
- WHEREAS,** Despite executive decisions by President Obama easing some restrictive regulations, the central portions of the embargo affecting trade and travel continue in force; *and*
- WHEREAS,** Full restoration of trade and travel between the two countries would be of great benefit to both, particularly in the areas of economic opportunities, education, health care, tourism, the arts, music, and sports, along with medical and biotechnological research, especially in relationship to COVID-19; *and*
- WHEREAS,** Boston institutions have had many collaborations and exchanges with Cuba, including Massachusetts General Hospital, Boston Medical Center, Tufts Medical Center, Boston University, Harvard Medical School, the Harvard School of Public Health, and the Massachusetts College of Pharmacy and Health Sciences; *and*
- WHEREAS,** The City of Boston, the home of some of the leading medical, public health, and academic institutions in the United States, would greatly benefit from the restoration of trade with Cuba by permitting the scientific, biopharmaceutical, medical, and public collaboration, and exchange, including the importation of Cuban products useful to Boston such as life-saving medicines Herberprot-p and CIMAvax; *and*
- WHEREAS,** There is an ongoing national awareness and work towards similar Cuban collaborative efforts in over 30 other cities, states, and unions, including the City of Cambridge and Brookline, calling for the lifting of the embargo on Cuba and collaborating on scientific and medical research and exchange; **NOW,**
THEREFORE BE IT

RESOLVED: That the Boston City Council hereby finds that the embargo and travel restrictions are prejudicial to the interests of the citizens of this city, the United States, and Cuba as a violation of the rights of United States citizens and residents to travel to Cuba for educational research and cultural exchange; **AND BE IT FURTHER**

RESOLVED: That the City Council urge the immediate restoration of engagement with Cuba as initiated by President Barack Obama by promptly rescinding restrictive regulations and allowing the restoration of staffing to the Cuban embassy in Washington DC, as well as the U.S. embassy in Havana; **AND BE IT FURTHER**

RESOLVED: That the Boston City Council encourage local medical, health care, scientific, academic, and pharmaceutical institutions to actively explore collaboration with their Cuban counterparts in knowledge transfer and collaboration in public health prevention methods, innovation treatments, and the development of new treatments, vaccines, and protocols; **AND BE IT FURTHER**

RESOLVED: That the Boston City Council appeal to the Massachusetts State Legislature and the Governor to actively pursue such exchanges, knowledge transfers, and collaboration, including but not limited to efforts to further joint development of drugs and treatment protocols in pursuit of the COVID-19 virus and other infectious diseases; **AND BE IT FURTHER**

RESOLVED: That the Boston City Council and the Massachusetts State Legislature strongly urge the Massachusetts Representatives and Senators in the United States Congress to promulgate and pass legislation that will finally end the unsuccessful and harmful 59-year-old economic, financial, and commercial embargo, as well as the travel restrictions on U.S. citizens and residents to Cuba, and Cuban citizens to the United States.

RESOLUTION RECOGNIZING MAY 6-12, 2022 AS “NATIONAL NURSES WEEK”

- WHEREAS*, On March 25th, 1982, President Ronald Reagan signed a proclamation declaring “National Recognition Day for Nurses” to be May 6, 1982; *and*
- WHEREAS*, In 1990, the American Nurses Association expanded the recognition of nurses to a week-long celebration of “National Nurses Week” for 1991 beginning on May 6th with “National Nurses Day,” through May 12, the birthday of Florence Nightingale, the founder of modern nursing; *and*
- WHEREAS*, As of 1998, May 8th is designated as “National Student Nurses Day,” and as of 2003, “National School Nurse Day” is celebrated on the Wednesday within “National Nurses Week” each year; *and*
- WHEREAS*, Nurses represent the largest single component of the healthcare profession, with an estimated population of more than 4,000,000 registered nurses in the country; *and*
- WHEREAS*, Nurses are public health heroes who make our communities safer and healthier, and contribute to our community as community advocates, educators, and providers of critical health services; *and*
- WHEREAS*, On the frontline of the COVID-19 pandemic, nurses are the cornerstone of our public health infrastructure, promoting healthy lifestyles, educating communities on disease prevention and health promotion, and providing critical care in a variety of settings; *and*

2 - Section 17F of Chapter 452 of the Acts of 1948 (as amended):

The city council may at any time request from the mayor specific information on any municipal matter within its jurisdiction, and may request his presence to answer written questions relating thereto at a meeting to be held not earlier than one week from the date of the receipt of said questions, in which case the mayor shall personally, or through a head of a department or a member of a board, attend such meeting and publicly answer all such questions. The person so attending shall not be obliged to answer questions relating to any other matter.

Home Rule Petitions Not Responded to by the Mayor³

³*Section 22 of Chapter 190 of the Acts of 1982:*

Every order of the city council approving a petition to the general court pursuant to Clause (1) of Section 8 of Article 2 of the amendments to the Constitution of the Commonwealth shall be presented to the mayor who shall forthwith consider the same, and, within fifteen days of presentation, either approve it, or file with the city council a statement in detail of his reasons for not approving the same, including any objection based on form, on content, or both; provided, that no such order shall be deemed approved or in force unless the mayor affixes his signature thereto.

Matters in Committee

The following matters were previously filed with the City Council and have been referred to a committee. Matters in committee can be brought back before the City Council pursuant to City Council Rule 24. The following *definitions* describe different types of matters in committee:

- Ordinances:*** Local laws enacted by the Boston City Council and the Mayor that become part of the City Code of Ordinances.
- Loan Orders:*** Authorization for the City of Boston to incur debt and expend money for projects, purchases, or other obligations.
- Orders:*** Directives that authorize action. Orders are legally binding but are not part of the City Code of Ordinances.
- Home Rule Petitions:*** Requests for special acts that concern a particular municipality. Home Rule Petitions require approval of the Boston City Council and Mayor, as well as passage by the state legislature.
- Order for a Hearing:*** A formal request sponsored by a councilor that a committee of the Boston City Council conduct a hearing about a particular matter, issue, or policy that impacts the City of Boston. An Order for a Hearing is not a law and is not voted on by the City Council. The only action concerning an Order for a Hearing that can be taken at a City Council meeting is the administrative action of placing it on file.
- Legislative Resolution:*** A recommendation concerning policy issues that may urge action on particular matters. Legislative resolutions have no legal effect. Legislative resolutions represent a particular position or statement by a Councilor, Councilors, or the City Council as a whole.
