

March 15, 2023

A regular meeting of the City Council of the City of Boston was held in the Christopher A. Iannella Chamber, City Hall on Wednesday March 15, 2023 at 12:09 P.M.

President Flynn in the Chair. All Councilors present.

Sister Pat Andrews, C.S.J., Sisters of St. Joseph, delivered the invocation and the meeting was opened with the pledge of allegiance to the flag.

President Flynn moved to adopt the minutes from the March 8, 2023 meeting. Motion prevailed.
