

May 10, 2023

A regular meeting of the City Council of the City of Boston was held in the Christopher A. Iannella Chamber, City Hall on Wednesday, May 3, 2023 at 12:42 P.M.

President Flynn in the Chair. All Councilors Present.

Reverend Michael Della Penna, Saint Leonard's Church, delivered the invocation and the meeting was opened with the pledge of allegiance to the flag.

President Flynn moved to adopt the minutes from the May 3, 2023 meeting. Motion prevailed.

- **0893** Message and order authorizing the City of Boston to accept and expend the amount of One Million Five Hundred Twenty-Five Thousand Three Hundred Eighty Dollars and Seventy-Seven Cents (\$1,525,380.77) in the form of a grant, for the Federal FY23 Nutrition Services Incentive Program, awarded by the United States Department of Health and Human Services, passed through the MA Executive Office of Elder Affairs, to be administered by the Age Strong Commission. The grant will fund the Age Strong Commission's nutrition program that delivers meals to homes of older adults and congregate sites in the City of Boston. Referred to the Committee on Strong Women, Families, and Communities.
