In accordance with Chapter 6 of the Ordinances of 1979, I hereby notify you of the following actions taken by the Mayor with regard to the papers acted upon by the City Council at its meeting of, October 26, 2022, viz.

Message and order for your approval an Order to reduce the FY23 appropriation for the Reserves for Collective Bargaining by Thirty One Million, Seventy Two Thousand, Twenty Nine Dollars (\$31,072,029.00) to provide funding for the Boston Public Schools for the FY23 cost contained within the collective bargaining agreements between the Boston School Committee and the Boston Teachers Union (BTU), Local 66, AFT Massachusetts.

### Approved by the Mayor October 31, 2022

Message and order for a supplemental appropriation Order for the Boston Public Schools for FY23 in the amount of Thirty Seven Million Six Hundred Seventy Four Thousand Three Hundred Thirty Seven Dollars (\$37,674,337.00) to cover the FY23 cost items contained within the collective bargaining agreements between the Boston School Committee and the Boston Teachers Union (BTU), Local 66, AFT- Massachusetts. The terms of the contracts are September 1, 2021 through August 31, 2024. The major provisions of the contracts include base wage increases of 2.5% in September 2022, September 2023, as well as other cost items including inclusion reform implementation.

The grant will fund peer support services for Boston Police Department sworn and civilian personnel, particularly civilians working in 911 Operations and Forensics.

Message and order authorizing the City of Boston to accept and expend the amount of One Hundred Six Thousand Dollars (\$106,000.00) in the form of a grant, for the FY22 Community Mitigation, awarded by the Massachusetts Gaming Commission to be administered by the Police Department. The grant will fund investigations that are coordinated between the BPD Human Trafficking Unit and other law enforcement entities, along with traffic safety patrols and accident reconstruction.

### GENERAL CHARACTERISTICS OF THE SITE:

The Bond-Hampton House is historically and architecturally significant at the local, state, and national levels for its handsome execution of the Regency/Greek Revival style; as a rare surviving example of the early suburban development of Roxbury; and for its associations with Richard Bond and Henry Hampton. The prominent architect Richard Bond was a prolific designer of public buildings in Massachusetts. Maine, and America's Northwest Territory in the early nineteenth century. His work represents significant achievements in architectural design, especially in the Greek Revival period. Bond was also instrumental in the establishment and elevation of architecture as a profession in the United States. In the twentieth century, the Bond-Hampton House also became significant for its association with the nationally acclaimed filmmaker, Henry Hampton (1940-1998) and his film production company Blackside, Inc., founded in 1968. Hampton is best known for his landmark documentary television series of 1987, Eyes on the Prize, about the history of the civil rights movement in the United States. Produced by Blackside, Inc., Eyes on the Prize tells the definitive story of the civil rights era from the point of view of the ordinary Black men and women whose extraordinary actions launched a movement that changed the fabric of American life, and embodied a struggle whose reverberations continue to be felt today. On October 25, 2022, the Boston Landmarks Commission unanimously voted to designate the Bond-Hampton House in Roxbury as a Landmark under the provisions of Chapter 772 of the Acts of 1975, as amended.

The Bond-Hampton House at 88 Lambert Avenue was built ca. 1834 as a single-family home; the design is attributed to Richard Bond, an architect and the first occupant. The Bond-Hampton House is historically and architecturally significant at the local, state, and national levels for its handsome execution of the Regency/Greek Revival style; as a rare surviving example of the early suburban development of Roxbury; and for its associations with Richard Bond and Henry Hampton.

The prominent architect Richard Bond was a prolific designer of public buildings in Massachusetts, Maine, and America's Northwest Territory in the early nineteenth century. His work represents significant achievements in architectural design, especially in the Greek Revival period. Bond was also instrumental in the establishment and elevation of architecture as a profession in the United States. 


# 01Demographic Characteristics



### In 2020, Boston had approximately 90,000 Black/African American male residents, including those who identified as Afro-Latino or multiracial.






In 1970, Boston's Black/African American population was largely concentrated in Roxbury and Dorchester.

By 2020, Boston's Black/African American population had increased in other neighborhoods as well, especially Mattapan and Hyde Park.






Black/African-American males make up a third of the population of Mattapan and over 20% of the populations of Roxbury, Dorchester, and Hyde Park














### BPS 4-year graduation rates have improved for all students, but remain lower for Black/African-Americans and for male students





### Before the pandemic, 56% of Black/African American males worked full time - similar to the rate for all Boston adults
























Figure 13. Denial Rates by Race and Ethnicity, 2009-2020







#### **National Net Worth of Non-Hispanic Black Families**



2019 DTI Ratios, by Race or Ethnicity









In Boston, Black residents and male residents have had the highest rates of mortality from COVID-19.




COVID-19 Mortality Rates by City and Gender





Note: Indigenous population and traffic stop percentages are absent due to small demographic share (less than 1%).



#### General

#### Reports and Dashboards

The State of Black Males in Boston: This comprehensive report created by the Office of Black Male Advancement in partnership with Boston Planning and Development Agency's (BPDA) Research Division. Using data gathered from a number of different peer-reviewed sources, the report is meant to help guide the Office's efforts to adequately address the systemic barriers to the advancement of Black Males in Boston.

City of Boston Funding Dashboard: These dashboards were created by the Office of Black Male Advancement in partnership with the Department of Innovation & Technology. These dashboards aim to increase transparency and provide insight into how the city is allocating grant funding, which allows the community to better understand the city's true investment in local Boston-based community-based organizations (CBOs) and nonprofits. The information will be posted on Analyze Boston.


#### **Programs Launched**

<u>Black Men and Boys Commission</u>: The 21-member Black Men and Boys Commission helps to advise the Mayor and the City of Boston on issues pertaining to Black men and boys.

My Brother's Keeper Boston (Revamped and Relaunched): My Brother's Keeper (MBK) Boston was established in partnership with the Obama Foundation and former Mayor Walsh's office, as the official Boston-chapter of the National MBK Alliance. The mission of the program is to dismantle the societal, economic, and educational barriers to the advancement of young persons of color in Boston. Now, under the purview of the Office of Black Male Advancement and with a sole focus on Black Boys, MBK Boston aims tackle these challenges through the concentration of policy, resources, and efforts within Higher Education, Mentorship, Science, Technology, Engineering, Arts, Math (STEAM), and External Funding. MBK Boston partners with local community based organizations, BPS schools, nonprofits and Colleges & Universities that serve Black Boys (ages 8-24) in Boston, and focus on the National MBK Alliance Milestones.

Black Men Lead Boston: Black Men Lead Boston is a program by the Office for Black Male Advancement for Black Men in Boston who wish to take more civic ownership and become leaders in the community. The program is a multi-week course for Black Male residents of Boston, prioritizes introducing participants to key City of Boston officials and learning how to effectively navigate local government.

Project Opportunity: Project Opportunity is a pilot initiative that aims to create equitable opportunities for Boston residents with CORIs. Taken over by the Office of Black Male Advancement in October, 2022, the program (1) connects residents with free legal consultation for sealing or expunging records; (2)




convenes panel discussions to address challenges and solutions for residents with CORIs; (3) connects residents with key resources for well-being; and (4) trains City departments to meet the needs of residents with CORIs.

Small Grant Fund: The fund allows community-based organizations serving the Black male community in Boston to apply for between \$2,500 to \$7,500 in grants. \$100,000.00 was distributed across 25 Boston CBO's the spring-summer '22 cycle.

Office of BMA Intake Form: This intake form was created to connect Black Male residents to resources that they are in need of.

#### **Policy Recommendations**

#### Mayor's Office

Gaps in Violence Prevention, Intervention and Response (Macro): All of the City's violence prevention and intervention efforts should be revamped to better align with Mayor Wu's mission of reimagining and grounding public safety in public health. Using this idea as a backdrop, we suggest: "(1) Assessment: There needs to be an assessment done that focuses on the current layout of resources. (2) Coordination across the City: The City of Boston should consider hiring a coordinator that is tasked with both the internal and external coordination of resources related to violence intervention, prevention and trauma response. (3) **Distribution of Funding**: Both the SSYI and Shannon Grant Oversight should be under the purview of the Mayor's Office or BPHC." (4) Specialized Working Groups: Based on the sub-populations that are involved in the community violence, the various providers should be assigned to a specialized working group or groups to ensure that all persons are equally prioritized in the City's plan. (5) Audit of both internal and external (city-funded) violence prevention, intervention & response programming: The city should audit all of the internal departments and external agencies that receive funding to do violence prevention, intervention and response.

#### ■ BPHC

- Provide peer-to-peer Trauma support trainings for students in every BPS High School before end of 2022 School Year
- Economic Opportunity & Inclusion
  - Black Male Advancement Generational Wealth Program (UBI Proposal): "The Black Male Advancement Generational Wealth Pilot Program provides a guaranteed base income through monthly payments per individual to Boston residents. The targeted recipients of the pilot program are low and moderate-income working Black males. In partnership with the Mayor's Office of Financial Empowerment, participants will be required to complete a generational wealth building program consisting of financial literacy, credit counseling, homebuyer education, individualized coaching and post evaluation prior to receiving monthly payments. Monthly payments can be used for wealth building through investing in homeownership, stocks and bonds, retirement, life insurance or debt repayment. This pilot program seeks to address the racial wealth gap through financial empowerment and wealth building."

#### Human Services

 Violence Prevention, Intervention, and Response: "All of the City's violence prevention, intervention and response efforts should be revamped to better align



with Mayor Wu's mission of reimagining and grounding public safety in public health. As a backdrop to address the current structure of SOAR Boston, we recommend that the model be revamped into a more comprehensive model that mirrors\_New York's Crisis Management Network. The New York Crisis Management network deploys teams of credible messengers (street outreach staff) who mediate conflicts on the street and connect high-risk individuals to services that can reduce the long-term risk of violence. The Crisis Management System worked to reduce shootings by 40% between 2010 and 2019. Wrap around supportive services are also a priority, as the system is also comprised of School Conflict Mediation, Employment Programming, Therapeutic Mental Health Services, Legal Services, and an Anti-Gun Violence Employment program. Beyond anything else, the model should be comprehensive and multi-faceted with a clear program direction. The aim should be to centralize the resources available to persons directly affected by gang and gun activity in Boston."

• Youth Engagement and Employment (YEE): To boost the number young people employed by the city during the summer months, YEE should (1) host summer job fair with application support in every BPS High School before end of 2022 school year; and (2) simplify the application documentation process for youth jobs (e.g. all BPS students should be able to work without submitting extensive documentation)

#### Worker Empowerment


• Create workforce development programming and trainings in languages other than English (e.g. Haitian Creole, Cape Verdean Creole, Somali) or offer translation services for programming and trainings that already exist. Black Male Advancement is currently working with the Equity & Inclusion Cabinet, Language & Communications Access Department & and Mayor Wu's Senior Advisor for Labor Policy on this.

#### ■ Boston Police Department

- Remove Shannon and SSYI Grant oversight and personnel from the Boston Police Department (have Senior Advisor for Public Safety oversee it)
- End Asset Forfeiture OR place the oversight of funds with the Senior Advisor for Public Safety

#### ■ Boston Public Schools

- Require all students complete a course in Financial Literacy before high school graduation
- Require all students complete a course in Black/Africana Studies before high school graduation





ORDER FOR A HEARING TO DISCUSS THE CREATION OF A CIVILIAN CONSTRUCTION DETAILS PROGRAM

- **WHEREAS,** Structural racism in Boston creates conditions of economic precarity and poverty and erodes Black Bostonians' human and civil rights, such as experiencing high rates of police surveillance, stops, and searches for example, Black people make up 25.2% of the Boston population but were the subjects of 62.3% of Boston Police Department Field Interrogation and Observation reports in 2020; and
- WHEREAS, Black residents are disproportionately likely to be incarcerated due to structural racism and, according to a report by the Brennan Center for Justice, formerly incarcerated people earn 52% less than people who have not been incarcerated, and formerly incarcerated people earn an average of \$484,000 less over the course of their working life than people who have not been incarcerated; and
- WHEREAS, The current rate of unemployment among Black people in Boston is 6.8%, and over the past four decades, Black people in the United States have experienced nearly double the rate of unemployment compared to white people moreover, Black people have been disproportionately impacted by job loss during the COVID19 crisis, with unemployment rates that peaked at 16.9% versus 12.8% among white people; and
- **WHEREAS,** Massachusetts became the last state in the country to legalize civilian construction details in 2008; and
- WHEREAS, Boston Police officers are the only city employees who work construction details, and the Police Department does not have the capacity to fulfill all requests for construction details, as officers declined to work 42.71% of details in 2020, up from 32% of details unworked in 2017 representing 135,959 more hours that residents could have worked; and
- *WHEREAS*, Private companies requested an average of 117,066 details for construction sites in Boston annually between 2017 and 2020, representing \$71,557,762 each year in potential wages for Boston residents or 740 full-time positions at \$70,000 plus benefits; *and*
- WHEREAS, Boston Police officers are among the highest-paid city employees, and the average salary of a Boston Police officer in 2020 was \$132,487.61, and without working construction details, the average salary would have been \$115,558.94, of which \$30,975.28 was overtime pay; and

- **WHEREAS,** The Boston Police Department reported that in FY20, 32 sworn officers and five civilians worked to administer the details system with a cumulative salary cost of \$3,787,763, representing the potential to hire 41 full-time employees at the median income rate to administer a new civilian construction detail office in addition to hundreds of full-time positions to work the details; and
- **WHEREAS,** A civilian construction detail office could operate on an annual budget of tens of millions of dollars with a mission of gender and racial justice and equity to employ hundreds of residents most harmed by state violence, over-policing, and mass incarceration; and
- **WHEREAS,** Creating a civilian construction detail office would create hundreds of union jobs at prevailing wages with benefits for Boston residents, particularly residents who have been excluded from the economy and struggled to provide for themselves and their families because of their CORI; and
- **WHEREAS,** A civilian construction detail office could address profound racial disparities and discrimination against formerly incarcerated people in the labor market by increasing access to stable, salaried employment with benefits which is essential to thriving communities and growing the city's economy; and
- **WHEREAS,** Residents who represent diverse cultures and speak multiple languages, and have pride in their communities could staff a civilian construction detail office with a mission of racial and gender justice to promote safety, well-being, and prosperity in neighborhoods across the city; and
- WHEREAS, The Regional & Community Outreach department of the Federal Reserve Bank of Boston acknowledges the "inextricable link between the economy and racial equity—which we define as just and fair inclusion in an economy in which all can participate, prosper, and reach their full potential" and the opportunity to "seize the important opportunity arising from this simultaneous awakening alongside an urgent need for the U.S. to rethink our economy as we work toward rebuilding it in the wake of the pandemic and current recession"; and
- **WHEREAS,** Residents of Boston have been engaged in a sustained, city-wide conversation about police spending since the murder of Mr. George Floyd and are seeking creative, reparative solutions to address the generational harm caused by systemic racism and economic insecurity and have raised the possibility of civilian construction detail office as one such solution; **NOW, THEREFORE BE IT**
- ORDERED: That the appropriate committee of the Boston City Council hold a hearing to discuss the creation of a new department for civilian construction details dedicated to providing stable, union jobs to people in the city that have been most affected by incarceration and policing. Representatives from the Mayor's Offices of Returning Citizens, Workforce Development, Resilience and Racial Equity, Police Accountability and Transparancy, Boston Police Department, and community advocates from Families for Justice as Healing, formerly incarcerated people, and other interested parties are invited to testify.

#### CITY OF BOSTON

#### AN ORDINANCE AMENDING THE CITY OF BOSTON CODE RELATED TO CLOSED CAPTIONING ON PUBLIC FACING TELEVISIONS

Be it ordained by the City Council of Boston, as follows:

**WHEREAS:** The lack of communication access to the audio content on TVs in public places has always existed as a barrier for individuals with certain disabilities; and

**WHEREAS:** During the COVID-19 pandemic TV programming played a critical role in conveying information from public health experts and government officials to the public during the state of emergency; and

WHEREAS: This new necessity of watching/listening to TV during the COVID-19 pandemic to receive critical public health information and guidance highlighted the striking inequity that exists in communication access for those in the disability community and beyond who have no access to audible TV content when they are in public places; and

**WHEREAS:** TVs audible content has not been accessible to persons with these types of disabilities: Deaf/deaf, Hard of Hearing, hearing loss due to age or illness, developmental disabilities, sensory disabilities, non-native English speakers, and others; and

**WHEREAS:** When businesses enable the "open captions" function on their TVs, a live transcript of the program's audio content is shown scrolling across the bottom of the screen; and

WHEREAS: Visible captions would eliminate a significant communication barrier for people with hearing loss and other disabilities by providing access to the information being given by speakers on TV programming in all of Boston's public places; and

**WHEREAS:** Visible captions would also increase access to information for the general public, because TVs are often located in crowded and noisy commercial spaces where everybody may have difficulty hearing;

NOW THEREFORE,

Be it Ordained by the City Council of Boston as follows:

City of Boston Code Chapter 12 subsection 4 is hereby amended by adding at the end thereof, the following new sections and subsections.

#### 12-4.10 Closed Captioning Activation

a. *Purpose*. The purpose of this ordinance is to expand accessible communication in places of public accommodation.

#### b. Definitions

When used in this section, unless the context otherwise requires, the following terms shall have the following meanings:

- 1. "Closed captioning" means a transcript or dialog of the audio portion of a television program that is displayed on the bottom portion of a television receiver screen when the user activates the feature.
- "Closed captioning television receiver" means a receiver of television programming that
  has the ability to display closed captioning, including but not limited to a television,
  digital set top box, and other technology capable of displaying closed captioning for
  television programming.
- 3. "Public area" means any part of a public facility that is open to the general public.
- 4. "Public facility" shall have the same meaning as "public accommodation and service", as defined in CBC 12-9.2.
- 5. "Public entertainment venue" means a place that is open to the public for mass gathering for entertainment, regardless of whether or not a ticket or payment of any type is required for admission. The term includes, but is not limited to, cinemas, theaters, concert halls, sports centers, and festivals.
- 6. "Regular hours" means the hours of any day in which a Public Facility is generally open to members of the general public.

#### c. Activating Closed Captioning

1. Any person owning or managing a public facility in the City of Boston must activate closed captioning on closed captioned television receivers in use in any public area during regular hours.

- 2. Exception. -- This section does not require public entertainment venues to activate closed captioning on closed captioned television receivers.
- 3. This section does not require a public facility to make closed captioning available in a public area of the public facility if:
  - (a) no television receiver of any kind is available in the public area; or
  - (b) the only public television receiver available in the public area is not a closed-captioning television receiver.
- 4. Nothing in this ordinance shall be construed to imply an exemption from state and federal requirements, such as those for effective communication and reasonable accommodations required under the Americans with Disabilities Act.

#### d. Enforcement

- 1. If a violation of Section 12-4.10 occurs, individuals can file a complaint with the Mayor's Commission for Persons with Disabilities ('Disabilities Commission').
- 2. The Disabilities Commission shall have the authority to investigate complaints brought before it, including but not limited to conducting unscheduled inspections of public facilities, holding mediation sessions with public facilities and other interested parties, and providing guidance for bringing public facilities into compliance.

#### ORDER FOR A HEARING TO DISCUSS RENAMING THE ROXBURY BRANCH OF THE BOSTON PUBLIC LIBRARY TO THE NUBIAN LIBRARY.

- **WHEREAS,** The library located at 149 Dudley Street in Roxbury has been serving the community since 1978 when it replaced and consolidated the Mount Pleasant Branch library and Fellowes Athenaeum; *and*
- **WHEREAS,** The Roxbury Library is located in Nubian Square, which is a commercial and transportational hub of Roxbury and serves as a center for the Black community; and
- **WHEREAS,** The area around the Roxbury Library has a rich and diverse history going back to the foundation of Boston when it served as the only entrance to the City on the mainland side of the Shawmut Peninsula; *and*
- **WHEREAS,** Starting in the mid twentieth century, 'white flight' paired with urban renewal and planned highways decimated and defunded most of Roxbury and significantly impacted the area surrounding Roxbury Library; and
- **WHEREAS,** Over half of Roxbury is comprised of Black residents and the area in which the Roxbury Library is located is the most racially and culturally diverse commercial center in Boston; *and*
- WHEREAS, Nubian Square was known as Dudley Square until residents in and around the area overwhelmingly voted to change the name of the area to Nubian Square in 2019, in honor of the Nubian kingdoms in Africa, which were some of the earliest and most prosperous civilizations known to man, as well as to recognize the important establishment A Nubian Notion, a vital business operated in the district for nearly fifty years by the Abdal-Khalaq family; and
- WHEREAS, The name Dudley Square was not only changed due to former Governor Thomas Dudley's connection to the slave-trade and decimation of the Native Americans who inhabited Massachusetts, but also to connect to Black history and social significance in this primarily Black community through the usage of the Nubian name, and to give a sense of cultural identity to Nubian Square after decades of disinvestment; and

- **WHEREAS,** The Roxbury Library was formerly known as the Dudley Library, and the name was changed in 2020 after the Dudley name was stripped from the area; *and*
- **WHEREAS,** Roxbury and Nubian Square serve as Black Boston's center for economic and cultural activity, and furthermore, Roxbury is over 50 percent Black, which is 30 percentage-points higher than Boston's Black population as a whole; *and*
- **WHEREAS,** The most recent renovation of the library, which involved great input from the community, reflects design elements and art from African culture, including a section dedicated to African American literature; and
- **WHEREAS,** The Boston City Municipal Code, chapter III, section 8-11 exclusively designates the authority to name municipal buildings to the Public Facilities Commision; *and*
- WHEREAS, In order to best reflect the communities wishes, the Black history of Nubian Square and Roxbury, the community commitment to the Roxbury library, and the benefits the Roxbury Library provides Nubian Square, the name of the Roxbury Library should be renamed to the Nubian Library: NOW, THEREFORE BE IT
- **ORDERED:** That the appropriate committee of the Boston City Council hold a hearing with the Boston Public Facilities Commission, any relevant offices, and community members and organizations in the Nubian Square area, to discuss and expedite the process of renaming the library to the Nubian Library.

ORDER FOR A HEARING TO DISCUSS HOW BOSTON PUBLIC SCHOOLS ARE ADDRESSING THE NEEDS OF THE PARENTS OF ENGLISH LANGUAGE LEARNER STUDENTS.

- WHEREAS, Students who speak English as a second language or English Language Learners (ELL) are one of the fastest growing groups of students in Massachusetts' schools with approximately 32 percent of all Boston Public School (BPS) students being ELL; and
- WHEREAS, ELL students need more specialized educational assistance in order to meet Massachusetts educational standards, and are eight percentage-points less likely to enroll in college compared to college applicants who speak English as their primary language; and
- **WHEREAS,** Parents of ELL students, for the most part, do not speak English proficiently, or at all, which leads to language barriers between parents of BPS students, negatively impacting their ability to assist their children in the realm of pedagogy; and
- WHEREAS, Parental language barriers significantly relate to the use of community resources, and parents that are positioned within historically marginalized and disenfranchised groups in the school or community are often connected to other parents, nor are they perceived to have the socio-economic status to be seen as equals by school staff; and
- **WHEREAS,** Studies show that the most highly reported barriers to parental involvement for parents of ELL students are language barriers, lack of knowledge about the U.S. educational system, not wanting to interfere with how teachers do their jobs, and stress from other responsibilities; *and*
- **WHEREAS,** Parental educational involvement has been widely studied as one of the most important predictors of school success, and parental involvement in leadership and policy-related activities depends on parents' perceived sense of voice or empowerment; *and*
- **WHEREAS,** All parents of Boston Public School students with limited English proficiency have the right to receive essential school information in their preferred language of communication; *and*

- **WHEREAS,** The BPS system should do all that is in their capacity to ensure that ELL students, or English as second language students are able to succeed in their educational endeavors at the same rate as their peers whose primary language is English; *and*
- **WHEREAS**, Boston Public Schools have several programs and committees related to assisting parents of ELL students; *and*
- WHEREAS, In order for all students to realize their full potential, their parents or guardians need to participate in their education, so BPS needs to be effectively assisting parents or guardians of English language learner students and empowering their voice to ensure that ELL students can fully take advantage of their education:

  NOW THEREFORE BE IT
- **RESOLVED:** That the appropriate committee of the Boston City Council hold a hearing to discuss how the Boston Public School system is effectively addressing the needs of the parents of students whose primary language is not English, and that the appropriate representative of Boston Public Schools, the Chief of Equity and Inclusion, the Mayor's Senior Advisor for Youth and Schools, the Executive Director of the Department of Language and Communication Access, the Executive Director of the Department of Immigrant Advancement, and any other relevant entities, community stakeholders, and others, be invited to participate in said hearing.

The following details are requested without name or any other personal identifying information:
  - a. a list of properties currently or previously owned, occupied, held, managed, or inventoried the office per year, including;
    - i. size of the property in square feet;
    - ii. size of any buildings or structures on the property by square feet;
    - iii. value of the property, including any structures or buildings;
    - iv. the amount the property was sold, leased, or rented out for by the office;
  - b. a list of any and all occupants of the properties, including;
    - i. racial demographics;
    - ii. yearly income broken down by race, gender, and age;
    - iii. average length of time occupants spend in properties held by the office broken down by age, race, income, disability, and immigration status;

- iv. the number of family occupants, broken down by number of children, number of parents, parental and child disability status, and race;
- v. the city, state, and zip-code in which the occupants resided while immediately preceding renting, leasing, applying for residence in, or otherwise occupying a property;
- c. a list of any and all owners, opporators, occupants, tenants, lessees, or any other landholders or users from which the right to use or own the land in any capacity was granted to them by the office or associated entity, regardless of use or status.

Requesting that the Mayor's Office of Housing, through the Mayor, provide any and all information that is available regarding this matter.

#### 2 - Section 17F of Chapter 452 of the Acts of 1948 (as amended):

The city council may at any time request from the mayor specific information on any municipal matter within its jurisdiction, and may request his presence to answer written questions relating thereto at a meeting to be held not earlier than one week from the date of the receipt of said questions, in which case the mayor shall personally, or through a head of a department or a member of a board, attend such meeting and publicly answer all such questions. The person so attending shall not be obliged to answer questions relating to any other matter.

Every order of the city council approving a petition to the general court pursuant to Clause (1) of Section 8 of Article 2 of the amendments to the Constitution of the Commonwealth shall be presented to the mayor who shall forthwith consider the same, and, within fifteen days of presentation, either approve it, or file with the city council a statement in detail of his reasons for not approving the same, including any objection based on form, on content, or both; provided, that no such order shall be deemed approved or in force unless the mayor affixes his signature thereto.

### **Matters in Committee**

The following matters were previously filed with the City Council and have been referred to a committee. Matters in committee can be brought back before the City Council pursuant to City Council Rule 24. The following *definitions* describe different types of matters in committee:

Ordinances: Local laws enacted by the Boston City Council and the Mayor that become part of the City Code of Ordinances.

Loan Orders: Authorization for the City of Boston to incur debt and expend money for projects, purchases, or other obligations.

*Orders*: Directives that authorize action. Orders are legally binding but are not part of the City Code of Ordinances.

Home Rule Petitions: Requests for special acts that concern a particular municipality. Home Rule Petitions require approval of the Boston City

Council and Mayor, as well as passage by the state legislature.

Order for a Hearing: A formal request sponsored by a councilor that a committee of the Boston City Council conduct a hearing about a particular

matter, issue, or policy that impacts the City of Boston. An Order for a Hearing is not a law and is not voted on by the City

Council. The only action concerning an Order for a Hearing that can be taken at a City Council meeting is the administrative

action of placing it on file.

Legislative Resolution: A recommendation concerning policy issues that may urge action on particular matters. Legislative resolutions have no legal

effect. Legislative resolutions represent a particular position or statement by a Councilor, Councilors, or the City Council as

a whole.
