TO THE BOSTON CITY COUNCIL

Dear Councilors:

I am writing to provide you with an update following the November 5, 2024 state election. As you are aware, during the election, a number of precincts were not supplied with a sufficient number of ballots, which led to some voting locations running out of ballots for a period of time. The ballot shortages were exacerbated by technical issues with the voting machines and communication systems issues, which hindered reporting of issues and delayed timely delivery of additional ballot supplies.

After the election, the Secretary of the Commonwealth appointed an investigator, who met with and received information from the City. As a result of this investigation, the Secretary's Office issued a Report and Order in February, which contained the investigator's findings and laid out the terms the City is required to meet for compliance, including several deliverables to ensure smooth administration of elections moving forward. The Order is attached and can be found [here](#).

The Order lays out the directives regarding updates to the Department's operations and procedures, including collaboration with the State's appointed Designee, as follows:

- The Election Department shall deliver ballots equal to the number of voters to each precinct and shall submit a plan for doing so to the Secretary for approval.
- The Election Department shall create and get approval for a plan to ensure real-time communication between poll workers and the Election Department.
- The Election Department shall create and get approval for a plan for contacting every precinct throughout election day to get information about turnout, ballot supply, and machine issues.
- The City, in consultation with the Secretary, will develop and revise its comprehensive poll worker training program.

- The City, in consultation with the Secretary, will provide a comprehensive plan for pre-election, election day, and post-election preparation and administration.
- The “Secretary shall appoint, after consultation with the City, an individual or individuals ([] the ‘Secretary’s Designee’) to assist the Boston Election Department in the preparation and administration of elections through and including the election cycle held 2026.”
- After the 2026 state election cycle the Secretary will conduct a review of whether the Agreement and Order shall be extended.

The Secretary recently appointed a Designee, Michael J. Sullivan, previously the Director of the Office of Campaign and Political Finance and City Clerk in Newburyport. We look forward to working with Mr. Sullivan, given his experience and expertise, along with other staff from the Secretary of the Commonwealth’s Election Division.

Since November, with guidance from the Secretary’s Office, the City has been taking short, mid, and long-term actions to implement operational improvements in the Elections Department. This has included drafting internal and external communication plans and protocols for ballot quantity decisions, and will also include city-wide departmental engagement plans, updated poll worker and volunteer training materials, amongst other things. In the event that there is a special election in District 7, the Elections Department will prepare to administer that election consistent with the steps laid out in the following paragraphs, the timing of any vacancy, and applicable law.

We have made some structural changes within the City organizational chart to help provide the Elections Department the executive attention, change management expertise, and resources it needs to be successful. The Department has moved from reporting to the Law Department and now sits under the City’s People Operations and Administration Cabinet, where it has direct organizational support and management from the Commissioner of City Records, Paul Chong. The Commissioner of City Records oversees other key administrative and operational functions of the City including public records and the Registry, and has expertise in organizational change management within complex regulatory and operational environments. The Law Department will continue to provide legal guidance and support as it does for every City department.

Furthermore, the City hired a Process Improvement Manager dedicated to the Elections Department by re-purposing an existing role. This additional resource has been helping to document and standardize processes within the department, and will assist in implementing operational changes needed to modernize and improve the functioning of elections in Boston.

This February, the City hired The Elections Group (TEG), a nationally recognized, non-partisan consulting firm to provide the City with on the ground support and short-term recommendations that can be implemented over the next few months. With

their help, we have begun to analyze and implement structural, organizational changes to ensure the Elections Department has additional administrative and operational expertise.

TEG has spent the last two months working both onsite and remotely, meeting with stakeholders within the Elections Department and across City agencies. The Elections Department and TEG have already worked together to develop standard operating procedures to address the two key issues from the November 2024 election: protocols for ballot delivery and communication between precincts and the Elections Department. The Elections Department is exploring leveraging existing City technology and protocols for rapid citywide communication during municipal elections. Additionally, we are exploring the procurement of other new technology tools to aid these processes. Consistent with the Secretary's Order, the Elections Department, along with the other departments and outside experts identified above, alongside the Secretary's Office and Designee, is working diligently to develop concrete and effective communication plans to address the issue of unanswered calls from poll workers, which will be finalized, trained on, and shared publicly prior to the election.

As we continue to implement the approved plans for organizational, technology, and process improvements, the Elections Department will continue to work with the Secretary's Designee to ensure clear coordination in following through with the Order. The Elections Department will also make regular reports on this progress at public meetings of the Boston Election Commission, the materials from which will also be shared publicly. Additionally, we look forward to providing updates to the City Council at a hearing for Docket #0585, and we will continue to share any significant updates as they arise. Effective, transparent, and smooth elections are critical to Boston's healthy democracy. We look forward to your continued collaboration as we make these improvements to our Elections Department and voting experience for voters across the city.

ORDER FOR A HEARING TO DISCUSS ESTABLISHING A DRONE POLICY IN THE CITY OF BOSTON

- WHEREAS:** Unmanned aircraft systems (UAS), also known as drones, are pilotless flying devices or aircraft. In the past two decades, rapid advancements in technology have enabled the widespread use of drones, including in the military, agriculture, construction sectors, search and rescue operations, deliveries, law enforcement, journalism and recreation. As the usage of drones have become more common, public safety and privacy concerns have risen; *and*
- WHEREAS:** On October 22, 2024, a drone crashed into a light pole and fell into the crowd at Boston City Hall Plaza during a Celtics Watch Party, injuring two people. The drone was controlled by a CNN employee with valid FAA credentials; *and*
- WHEREAS:** In December 2024, two men were arrested and charged for flying drones in “hazardous air space” close to Logan Airport - a prohibited airspace for drones. Similar arrests have been made across the country, where drones were spotted too close to airports; *and*
- WHEREAS:** The Federal Aviation Administration (FAA) has several regulations on who can use drones, and how. Drone users must register their drones, and for commercial use, they must pass the FAA’s Aeronautical Knowledge Test to obtain a Remote Pilot Certificate. For recreational use, drone users are required to pass the The Recreational Unmanned Aircraft System Safety Test (TRUST), and restrictions include flying below 400 ft and registering the drone if it is over .55 lbs; *and*
- WHEREAS:** In Massachusetts, drones are allowed for commercial and recreational use, subject to the FAA UAS regulations. However, as it stands, local law enforcement is unable to enforce FAA regulations. There is currently only one state law - the Code of Massachusetts Regulations Title 302 (302 CMR 12.04) - concerning the operation of drones, which prohibits the use or operation of any air propelled power craft or hovercraft on or over any land or waterways of the Department of Conservation and Recreation (DCR); *and*
- WHEREAS:** Massport has also installed over 200 “No Drone Zone” signs around Boston Logan International Airport, other Massport locations and over 50 parks. They continue to work with other municipalities to install signage along flight paths; *and*
- WHEREAS:** In the Massachusetts State House, Representative Bruce J. Ayers of Quincy is currently leading the effort on regulating drones over airports and flight paths (H.

1585 *An Act Relative to Air Traffic Safety*) as well as a no fly zone over the airspace of all school facilities in the Commonwealth (H. 3618 *An Act regulating the flight of unmanned aircraft/drones in the airspace over all early early, elementary, and secondary education facilities in the Commonwealth*); *and*

WHEREAS: In the City of Boston, under the Surveillance Oversight Ordinance, there are rules governing how the Boston Police Department (BPD) can use UAS technologies for surveillance. However, the City does not have any regulations or guidance on the individual use of drones/UAS technologies; *and*

WHEREAS: In January this year, a Canadian company “Draganfly” announced that it secured a waiver from the FAA that enables its small unmanned aircraft (sUA) to conduct operations over human beings and moving vehicles. The permissions cover a prescribed flight route over the city of Boston, and the FAA waiver “allows flights over individuals who are not direct participants in the UAV operation”, and “enables UAV operations over moving traffic, which is critical for urban deployment scenarios”; *and*

WHEREAS: Across Massachusetts, there are a handful of towns and municipalities that have implemented drone regulations. This includes the City of Belchertown, the City of Chicopee, the Town of Holyoke, who require a permit, written permission, and/or have an ordinance utilizing existing land use regulations to control drone operations; *and*

WHEREAS: Drones can pose a significant threat to airplanes, those aboard, and public safety, especially in busy urban settings. They can also create noise disturbances, cause physical harm to residents, and violate privacy. There are over a million drones registered with the FAA across the country, however, there are also many illegal and unregistered drones. It is critical that stronger regulations are put in place to protect residents from this emerging technology; *and*

NOW THEREFORE BE IT ORDERED:

That the appropriate committee of the Boston City Council holds a hearing to discuss establishing a Drone Policy in the City of Boston. Representatives from the Boston Police Department, Boston Parks Department, Massport, Massachusetts Department of Conservation and Recreation, and other relevant and interested parties shall be invited to attend.

ORDER FOR A HEARING TO DISCUSS INFRASTRUCTURE CHANGES AND REPAINTING OF SUMMER STREET AS THE BUS LANE PILOT ENDED IN SEPTEMBER 2024

- WHEREAS:** In the Fall of 2023, Boston Transportation Department made street design changes for the Summer Street Multimodal Corridor Pilot to include a bus and truck lane between South Boston and South Station, with signs and paint that were visibly placed on the street in September 2023. However, due to a lack of clear communication, the official launch of the Pilot subsequently took place in December 2023; *and*
- WHEREAS:** Prior to installation, an overwhelming number of residents in South Boston called attention to the potential for unintended consequences of the Pilot and its overall fit for the entire corridor at community meetings, including serious concerns on the impacts to the Boston Convention & Exhibition Center, Conley Terminal, the Flynn Marine Industrial Park, and surrounding hotels and businesses. During the Pilot, residents continued to provide significant feedback regarding increased unpredictability on the road and traffic times, along with the creation of areas of congestion that did not previously exist. This included traffic backing up while waiting for turns at Summer Street and D Street in several directions, as well as blocked intersections; *and*
- WHEREAS:** In September 2024, the City announced abruptly that the Summer Street Bus Lane Pilot had ended due to it not working as intended, and that the bus lane had only improved peak bus trips by 15-30 seconds. It has been over 8 months since the Summer Street Bus Pilot has ended, however, the painting on the street and solid white lines still remain, and many constituents remain confused about the status with "Bus Only" still painted at Summer Street and Dorchester Avenue near the United States Post Service (USPS) office. *and*
- WHEREAS:** Residents continue to question whether the bus lane Pilot has officially ended, and if it is illegal to turn right from Summer Street onto Melcher Street because of the lines and the bus lane. Moreover, others continue to post on social media about whether new MBTA regulations aimed at bus lane enforcement, with fines up to \$125, will be applicable to Summer Street, despite the Pilot having ended in September of 2024; *and*
- WHEREAS:** Despite initial conversations with Boston Transportation when the Summer Street Bus Pilot ended, BTM has not provided an update with regard to the repainting of Summer Street since. Given these issues, the Summer Street Bus Lane should be repainted to minimize any confusion for residents and visitors; *and*

NOW THEREFORE BE IT ORDERED:

That the appropriate committee of the Boston City Council holds a hearing to discuss repainting the Summer Street Bus Lane in South Boston. Representatives from the Boston Transportation Department, Boston Planning Department, and other relevant and interested parties shall be invited to attend.

SECTION 17F RELATIVE TO WHITE STADIUM**

WHEREAS: There are concerns that the City of Boston, specifically the Parks and Recreation Commission, is out of compliance with state law and the Massachusetts Constitution where it executed the “BPS Stadium Usage Agreement” dated December 23, 2024 (the “Usage Agreement”), which purports to authorize (i) the disposition of City of Boston parkland in Franklin Park for utility purposes, (ii) the disposition of existing park roads in Franklin Park for commercial purposes, and, (iii) the disposition of land in Franklin Park for the creation of a new roadway which will be used for commercial purposes, all outside of the 14 acres owned by the George Robert White Trust (the “White Fund Parcel”), and on parkland that is unquestionably protected by Article 97, without a prior unanimous vote of the Parks Commission; *and*



WHEREAS: The Usage Agreement between the City of Boston and Boston Unity Stadco, LLC (the “Soccer Team”), signed by the Parks Commissioner, states that the Parks Department under Section 4.2 (a) ii.: “hereby provides to the Team, and the Team hereby accepts, a license for pedestrian (and vehicular to the extent of any paved roads intended for vehicular use) ingress and egress to and from the Stadium through such portions of Franklin Park abutting the Stadium Parcel that are identified in the TAPA, which ingress and egress the City hereby acknowledges must be sufficient to accommodate the Team’s use of the Stadium for Team Events and the year round operation of the Grove as contemplated herein and in the Cooperation Agreement.”; *and*

WHEREAS: The Parks Commissioner has stated, and the Massachusetts Executive Office of Environmental Affairs’ Natural Resource Site Evaluation Map has affirmed, all of Franklin Park outside of the White Fund Parcel, including Pierpont Road and Playstead Road, is protected parkland under Article 97 of the Massachusetts Constitution; **NOW THEREFORE BE IT**

ORDERED: That under the provisions of section 17F of Chapter 452 of the Acts of 1948, as amended, and any other applicable provision of law, Her Honor, the Mayor, be,

and hereby is, requested to obtain and deliver to the City Council, within one week of the receipt hereof, the following information relative to:

1. Given that the above-quoted language authorizes the use of roads in Franklin Park identified in the “TAPA”, i.e., Transportation Access Plan Agreement between the Soccer Team and the Boston Transportation Department, and that to this point, the TAPA has not been agreed to and executed, precisely which paved roads intended for vehicular use did the Parks Commission vote on April 28, 2025 authorize the use of for private commercial purposes?
2. Does the Parks Commission vote on April 28, 2025 to approve the plan for White Stadium as proposed by the Boston Public Schools and the Soccer Team grant the team an irrevocable license to use the Parks Department's Playstead Road and Pierpont Road, or any other new or existing park roads in Franklin Park, for private commercial purposes for the duration of the 10-to-30-year Usage Agreement?
3. Does the Parks Commission vote also represent a vote to approve the easement required to unearth the parkland by Walnut and Seaver Streets on the north side of White Stadium in Franklin Park in order to install a new utility system into White Stadium as laid out in the renovation plans?
4. Does the vote include a vote to approve the commercial use and dispositions of protected land for the utility work needed and use of the protected parkways, Playstead and Pierpont Roads (or any other roads in Franklin Park) for commercial purposes?
5. Please provide the findings of any appraisals that were conducted regarding the commercial value of the pedestrian and vehicular access and egress rights and utility rights granted under Section 4.2(a)(ii) of the Usage Agreement. If none were done, please explain why not.
6. Exhibit D to the Usage Agreement (attached and annotated), and the attached site map included in the latest revised transportation plan, appear to show a new paved roadway through protected parkland from Pierpont Road to the northwest portion of the White Fund Parcel and the new stadium. (Please see the area highlighted in yellow in the attached site map.) It appears to be the only vehicular access to the White Fund Parcel, which has no frontage on any roadway. What is the purpose of the new roadway? Did the Parks Commission vote to allow the construction of this new roadway through protected parkland for private commercial purposes?



Requesting that the appropriate department or departments, through the Mayor, provide any and all information that is available regarding this matter.

WHEREAS, Asthma is defined as a chronic lung disease that inflames and narrows airways resulting in recurring periods of wheezing, chest tightness, shortness of breath, and chronic coughings; *and*

WHEREAS, According to the Centers for Disease Control and Prevention (CDC), over 21 million adults and over 4.2 million children in the United States have asthma. In Massachusetts, about one out of every eleven people currently has asthma, which accounts for approximately 10.2% of adults and 12.9% children; *and*

WHEREAS, In 2021 13.1 percent of Boston adult residents reported having asthma, according to the City's Health of Boston 2023 Asthma Report. These percentages increase exponentially in neighborhoods with higher populations of Black and brown residents, including Mattapan, Roxbury, Dorchester, and East Boston; *and*

WHEREAS, A Logan Airport Health Study conducted by the Massachusetts Department of Public Health Bureau of Environmental Health in 2014 found that children in neighborhoods near Logan Airport, like East Boston, are four times more likely to exhibit signs of asthma compared with children in other areas and adults are twice as likely to show signs of chronic obstructive pulmonary disease (COPD). The study suggests a significant link between pollutants and respiratory problems like asthma and wheezing; *and*

WHEREAS, In an effort to raise awareness and improve asthma care throughout the world, advocates annually celebrate the first Tuesday of May as "World Asthma Day." This occasion encourages individuals to focus on daily asthma management and to identify allergens and irritants that can lead to and worsen asthma attacks; *and*

WHEREAS, A recent report from the American Lung Association found that 46 percent of Americans live in places with unhealthy levels of ozone or particle pollution. The same report found that the Boston–Worcester–Providence metro area was ranked the 61st worst for high ozone days out of 228 metropolitan areas and 110th worst for annual particle pollution out of 208 metropolitan areas; *and*

WHEREAS, The Trump administration recently announced cuts to federal grants administered by the Environmental Protection Agency (EPA), which will negatively impact efforts in Massachusetts to address high asthma rates; *and*

WHEREAS, By recognizing “World Asthma Day” in Boston, we are supporting those who suffer from asthma and amplifying the need for resources to study and tackle this chronic disease; ***NOW, THEREFORE BE IT***

RESOLVED: The Boston City Council recognizes May 6, 2025 as World Asthma Day in the City of Boston and commits itself to working towards clean air justice for all communities in Boston.

RESOLUTION IN SUPPORT OF ADULT DAY HEALTH (ADH)
PROGRAMS

WHEREAS: Adult Day Health (ADH) Programs are community and site-based day programs that provide high quality health care, wellness, and support services in a structured group setting to over 13,000 seniors and adults with disabilities in Massachusetts. ADH programs provide a six-hour day for seniors, including registered nursing care, health and medication management, social and nutritional services, personal care, recreational and therapeutic activities, and door to door transportation; *and*

WHEREAS: Adult Day Health services keep seniors and adults with disabilities physically and mentally active and help prevent social isolation. There are 140 ADH programs across Massachusetts, and these programs are licensed by the Department of Public Health (DPH) and are reviewed and approved by MassHealth and other authorities; *and*

WHEREAS: In Boston, there are a number of non-profits that offer Adult Day Health Programs, such as the Greater Boston Chinese Golden Age Center, Rogerson Communities, Senior Place Adult Day Health, and Blue Hill Adult Day Health Center; *and*

WHEREAS: Effective July 1, 2025, MassHealth is planning to cut the Adult Day Health (ADH) reimbursement rate from the current basic level of service rate of \$106.32 a day to \$99.49 a day. The current \$106.32/day reimbursement rate, implemented in July 2023, was based on Governor Healey’s recommendation to “address workforce challenges and to ensure access to day programs for eligible MassHealth members.” The new rate change will have a devastating impact to ADH programs and scale back services for seniors; *and*

WHEREAS: During the COVID-19 pandemic, 35 ADH programs closed and more than 8000 people lost ADH services. With the new reimbursement rates, 24 programs reported that they are at serious risk of closure; *and*

WHEREAS: At the Massachusetts State House, Representative Thomas M. Stanley of Waltham, sponsored an amendment (Amendment #203) to current Bill H.4000, *An Act making appropriations for the fiscal year 2026 for the maintenance of the departments, boards, commissions, institutions, and certain activities of the Commonwealth, for interest, sinking fund, and serial bond requirements, and for certain permanent improvements* to maintain the current ADH reimbursement rates. On April 28, 2025, Amendment #203 was adopted as part of Consolidated Amendment “B” to Bill H.4000; *and*

WHEREAS: Many of our seniors and adults with disabilities rely on the important ADH programs for physical, mental and social wellbeing. It is critical that we support Bill H.4000 to maintain the current level of reimbursement rates for ADH Programs so that our seniors can continue to access vital services; *and*

NOW THEREFORE BE IT RESOLVED:

That the Boston City Council supports the passage of H.4000 “*An Act making appropriations for the fiscal year 2026 for the maintenance of the departments, boards, commissions, institutions, and certain activities of the commonwealth, for interest, sinking fund, and serial bond requirements, and for certain permanent improvements*”, which supports Adult Day Health Programs and maintains the current reimbursement rate of \$106.32/day for Adult Day Health services in Massachusetts.

WHEREAS, Despite much civil rights progress to celebrate, including Massachusetts' critical role as the first U.S. state to legally license and recognize same-sex marriage on May 17, 2004; the repeal of the discriminatory "Don't Ask, Don't Tell" law made effective on September 20, 2011; and the U.S. Supreme Court rulings on June 26, 2015 leading to nationwide marriage equality, and on June 15, 2020 leading to the prohibition of employment discrimination based on sexuality or gender identity, the LGBTQIA+ community continues to face rapidly accelerating legislative and physical attacks by the federal government and throughout the U.S., particularly targeting the transgender, nonbinary, gender nonconforming, and BIPOC members of the LGBTQIA+ community, including threatening their basic rights to exist freely; *and,*

WHEREAS, The LGBTQIA+ community continually demonstrates strength and resilience, but should not have to stand alone; in these times especially, it is critical that the City of Boston stays resolutely committed to the fight for the safety, freedom, and joy of our LGBTQIA+ community; ***NOW, THEREFORE BE IT***

Message and order a supplemental appropriation order for the Boston Public Schools for FY25 in the amount of Thirty-Three Million Two Hundred Sixty Two Thousand Four Hundred Sixty-Six Dollars (\$33,262,466.00) to cover the impact of FY25 cost items contained within the collective bargaining agreement between the Boston School Committee and the Boston Teachers Union. The term of the contract is September 1, 2024 - August 30, 2027. The major provisions of the contract include general wage increases of 2.5%, 2%, and 2% in September of 2024, 2025, and 2026. The Paraprofessionals and ABAs will also receive market rate adjustments. **(Docket #0941)**

¹Section 17E of Chapter 452 of the Acts of 1948 (as amended):

The mayor from time to time may make to the city council in the form of an ordinance or loan order filed with the city clerk such recommendations as he may deem to be for the welfare of the city. The City Council shall consider each ordinance or loan order so presented and shall either adopt or reject the same within sixty days after the date when it is filed as aforesaid. If such ordinance or loan order is not rejected within sixty days, it shall be in force as if adopted by the city council unless previously withdrawn by the mayor.

Section 15 of Chapter 190 of the Acts of 1982 (as amended by Section 2 of Chapter 701 of the Acts of 1986) *The city council shall take definite action on any supplementary appropriation order and any order for a transfer of appropriations by adopting, reducing or rejecting it within sixty days after it is filed with the city clerk; and in the event of their failure to do so, such supplementary appropriation order or transfer as submitted by the mayor shall be in effect as if formally adopted by the city council.*

²**Section 17F of Chapter 452 of the Acts of 1948 (as amended):**

The city council may at any time request from the mayor specific information on any municipal matter within its jurisdiction, and may request his presence to answer written questions relating thereto at a meeting to be held not earlier than one week from the date of the receipt of said questions, in which case the mayor shall personally, or through a head of a department or a member of a board, attend such meeting and publicly answer all such questions. The person so attending shall not be obliged to answer questions relating to any other matter.

³**Section 22 of Chapter 190 of the Acts of 1982:**

Every order of the city council approving a petition to the general court pursuant to Clause (1) of Section 8 of Article 2 of the amendments to the Constitution of the Commonwealth shall be presented to the mayor who shall forthwith consider the same, and, within fifteen days of presentation, either approve it, or file with the city council a statement in detail of his reasons for not approving the same, including any objection based on form, on content, or both; provided, that no such order shall be deemed approved or in force unless the mayor affixes his signature thereto.

Matters in Committee

The following matters were previously filed with the City Council and have been referred to a committee. Matters in committee can be brought back before the City Council pursuant to City Council Rule 24. The following *definitions* describe different types of matters in committee:

- Ordinances:*** Local laws enacted by the Boston City Council and the Mayor that become part of the City Code of Ordinances.
- Loan Orders:*** Authorization for the City of Boston to incur debt and expend money for projects, purchases, or other obligations.
- Orders:*** Directives that authorize action. Orders are legally binding but are not part of the City Code of Ordinances.
- Home Rule Petitions:*** Requests for special acts that concern a particular municipality. Home Rule Petitions require approval of the Boston City Council and Mayor, as well as passage by the state legislature.
- Order for a Hearing:*** A formal request sponsored by a councilor that a committee of the Boston City Council conduct a hearing about a particular matter, issue, or policy that impacts the City of Boston. An Order for a Hearing is not a law and is not voted on by the City Council. The only action concerning an Order for a Hearing that can be taken at a City Council meeting is the administrative action of placing it on file.
- Legislative Resolution:*** A recommendation concerning policy issues that may urge action on particular matters. Legislative resolutions have no legal effect. Legislative resolutions represent a particular position or statement by a Councilor, Councilors, or the City Council as a whole.


