## ORDER FOR A HEARING REGARDING BIANNNUAL REVIEW OF THE BOSTON EMPLOYMENT COMMISSION AND BOSTON RESIDENTS JOBS POLICY

- *WHEREAS:* In 1983, Mayor White and the Council enacted the Boston Residents Jobs Policy Ordinance requiring that on any city financed construction project, a minimum of 50% of the work hours trade by trade, be performed by Boston Residents, 25% by people of color, and 10% by women; and
- *WHEREAS:* In 1986, Mayor Flynn and the Council amended the ordinance, establishing the Boston Employment Commission to enforce the policy, and broadened the scope of the ordinance to cover private projects of 100,000 square feet; and
- WHEREAS: In 2017, Mayor Walsh and the Council approved a revised Boston Residents Job Policy Ordinance raising the standards for minimum hours worked by Boston workers to fifty one percent; raising the minimum hours worked by workers of color to forty percent; and raising the minimum number of hour worked by women to twelve percent; and
- WHEREAS: Chapter 8, Section 8.9 of the municipal code requires the Boston City Council to hold biannual hearings in April and October on reports from the Boston Employment Commission specifying number of compliance determinations, contractors or developers out of compliance, sanctions received, sanctions by trade, work hours by trade and total hours performed by Boston workers, women and people of color; and
- *WHEREAS*: Chapter 8, Section 8.9 of the municipal code requires the Boston Employment Commission to furnish data as requested by the council to evaluate future increases to the goals for people of color or women worker hours; and
- *WHEREAS:* In order to ensure regular and uninterrupted review of the Boston Residents Jobs Policy, the City Council and the Boston Employment Commission shall review policy and data pertinent to the BRJP; *THEREFORE BE IT*
- *ORDERED*, That the appropriate committee of the Boston City Council hold a hearing on the implementation of the revised Boston Residents Jobs Policy and data from the Boston Employment Commission from the preceding six and twelve months, and as necessary, for the biannual reviews of the BRJP.

## AN ORDER REGARDING A TEXT AMENDMENT TO THE BOSTON ZONING CODE WITH RESPECT TO PARKING MINIMUMS FOR AFFORDABLE HOUSING

- *WHEREAS*: The City of Boston confronts an affordable housing crisis, with 49.6% of Boston area renters "rent-burdened" by devoting more than 30% of their income to housing costs, more than 50,000 families on the waiting list for a Boston Housing Authority public housing unit, and far too many homeless families in shelter; *and*
- *WHEREAS*: A number of recent efforts have either prevented the construction of affordable housing or added considerable delay and expense to efforts to build affordable housing in the City of Boston by objecting to the issuance of a variance to the off-street parking minimums required by the Boston Zoning Code; *and*
- *WHEREAS*: These objections are being raised both at the Zoning Board of Appeals and in courts of law, most recently in regard to proposed projects at 3377 Washington St., 3371 Washington St., and 37 Wales St.; *and*
- *WHEREAS*: Such efforts are too often a cynical ploy to extract concessions for private interests or to frustrate a critical public need for more affordable housing for the sake of those private interests, at the expense of the most vulnerable members of our society; *and*
- *WHEREAS*: The State's recently-passed Housing Choice law includes a provision which will go some way towards reducing certain frivolous lawsuits against housing developments by requiring filers to post a significant bond, but the opportunity for such lawsuits could be most effectively reduced by altering the provisions of the Boston Zoning Code most often being used as their pretext; *and*
- *WHEREAS:* The "Perfect Fit Parking Initiative: Phase II Report" published by the Metropolitan Area Planning Council in July 2019 found that the parking built as part of multifamily housing development across Boston and the region is going largely underutilized; *and*
- *WHEREAS:* Every parking space built or acquired for an entirely affordable housing development diminishes the funds available for additional affordable housing units; *and*

WHEREAS:	Affordable housing built in the City of Boston is typically accessible by mass transit, whether by bus, subway, or light rail, and transit-oriented development without parking is critical to meeting Boston's climate goals; <i>and</i>
WHEREAS:	Our first duty is to build a city for people, not for the storage of vehicles; <i>NOW THEREFORE BE IT</i>
ORDERED:	That the Boston City Council, by and through Councilors Kenzie Bok and Matt O'Malley, submits a petition to amend the text of the Boston Zoning Code.

† or, in the case of residential housing entirely for persons of low-income, no off-street parking shall be required. Residential housing entirely for persons of low-income shall be considered to describe those projects where all proposed residential units are income-restricted at or below the maximum income level permitted for affordable units under the requirements of the City of Boston's Inclusionary Development Policy.

## AN ORDINANCE AMENDING CITY OF BOSTON CODE, CHAPTER XXIV, BOSTON JOBS AND LIVING WAGE ORDINANCE

- *WHEREAS*, The City of Boston must continue to lead by example and provide good wages and benefits to our custodial and building security service workers, and ensure they are paid the prevailing wage rate and have strong job protections; *and*
- *WHEREAS*, We must continue to update and advance the Boston Jobs and Living Wage Ordinance to keep pace with the changing conditions of employment; *and*
- *WHEREAS*, The Boston Jobs and Living Wage Ordinance should be expanded to cover all contracts and subcontracts in city owned buildings, and not only large contracts; *and*
- *WHEREAS*, The prevailing wage ordinance for custodial and security services was filed on July 10th, 2018, but later withdrawn; *and*
- *WHEREAS*, An executive order on June 10th, 2021, set forth a prevailing wage for custodial and security wages in contract services, however executive orders must be formally codified to ensure lasting legal protections for workers and contracts; *and*
- *WHEREAS*, We must continue a tradition of fair and just pay today, as almost 25 years ago Boston was one of the first cities in the country to pass a living wage ordinance to ensure that City resources were used in a way that would promote the financial well-being of workers who were employed under City contracts; *NOW*, *THEREFORE*

Be it ordained by the City Council of Boston as follows:

#### Section 1.

City of Boston Code, Ordinances, Chapter XXIV, Section 24-1, is hereby amended in the first sentence by striking the words "Boston Jobs and Living Wage Ordinance" and inserting in place thereof the words "Boston Jobs, Living Wage, and Prevailing Wage Ordinance".

#### Section 2.

City of Boston Code, Ordinances, Chapter XXIV, Section 24-1, is hereby further amended in the second sentence by inserting after the words "poverty level" the words ", and to ensure that City dollars are not used to undercut the prevailing standards that have been attained by building service workers".

#### Section 3.

City of Boston Code, Ordinances, Chapter XXIV, Subsection 24-2(c), is hereby amended by inserting after the words "service contract" the words "or covered building service contract".

#### Section 4.

City of Boston Code, Ordinances, Chapter XXIV, Subsection 24-2(d), is hereby amended in the first sentence by inserting after the words "covered vendor" the words ", other than a covered building service employee,".

#### Section 5.

City of Boston Code, Ordinances, Chapter XXIV, Subsection 24-2(e), is hereby amended in the first sentence by inserting after the words "not-for-profit employer" the words ", other than a covered building service vendor,".

#### Section 6.

City of Boston Code, Ordinances, Chapter XXIV, Subsection 24-2(m), is hereby amended in the first sentence by inserting after the words "shall mean any contract" the words ", other than a covered building service contract,".

#### Section 7.

w. *Standard compensation* shall mean the hourly rate of pay, benefits, and paid leave that shall be provided to a covered building service employee pursuant to the formula set forth in Subsection 24-7.6 of this Chapter.

x. *Covered lessor* shall mean any non-governmental person or entity that enters into a covered lease with the City of Boston.

y. *Covered lessee* shall mean any non-governmental person or entity that contracts for, leases, or rents space in covered City-owned property from the City of Boston.

b) Notification for Covered City-Owned Property:

Before entering into a lease as the lessor of covered City-owned property, the City of Boston shall specifically state that all requirements of this Chapter applicable to leases of covered City owned property, including enforcement mechanisms, are applicable to the lease and incorporated by reference, and require, as a condition of the lease, a contractual commitment from every covered lessee that, if the lessee enters into a contract with a vendor to provide building services at the covered City-owned property: (i) each covered building service employee, whether or not he or she is directly employed by the covered lessee, shall be provided with standard compensation in accordance with the provisions of this Chapter; (ii) any contract or subcontract entered into by the covered lessee for the provision of building service work, any contract or subcontract entered into by the covered lessee for property management, and any lease with any tenant shall contain the following provision: "The wages paid on an hourly basis to any person providing building services, as defined in City of Boston Code, Ordinances, Chapter XXIV, and the amount of payment or contribution paid or payable on behalf of each such person to cover benefits and the paid leave to be provided to each such person, shall be at a rate greater or equal to the 'standard compensation' as defined in City of Boston Code, Ordinances, Chapter XXIV. A violation of this requirement shall constitute a breach of contract."; and (iii) the covered lessee shall produce for inspection and copying certified payroll records pertaining to any and all covered building service employees for the prior three (3) year period upon request.

c) Notification for Covered Leases:

Before entering into a covered lease, or extension, renewal, amendment, or modification thereof, the City of Boston shall specifically state that all requirements of this Chapter applicable to covered leases, including enforcement mechanisms, are applicable to the lease and incorporated by reference into the lease, and require, as a condition of the lease, a certification, executed under penalty of perjury, that all covered building service employees employed in or around the building to which the lease pertains will be provided with standard compensation for the term of the lease. Such certification shall be certified by the chief executive or chief financial officer of

the covered lessor, or the designee of any such person. The certification shall be annexed to a part of any covered lease. The certification shall 'state that a violation of any provision of the

certification shall constitute a violation of the covered lease and of this Chapter. In the certification, the covered lessor shall agree to provide certified payroll reports pertaining to covered building service employees for the prior three (3) year period upon request.

The expired or terminated covered building service vendor shall, within fifteen (15) days after receipt of such notice, provide to the successor covered building service vendor the name, address, date of hire, and employment occupation classification of each covered building service employee employed at the site or sites covered by the building service contract at the time of receiving said notice. The expired or terminated covered building service vendor shall also provide this information to the City and to any collective bargaining representative of the vendor's employees. At the same time, the expired or terminated vendor shall provide each affected employee with notice of his or her right to obtain employment with the successor covered building service vendor.

A successor covered building service vendor or subcontractor where applicable shall retain for a 90-day transitional employment period all covered building service employees who were employed by the expired or terminated covered building service vendor and its subcontractors at the location(s) covered by the expired or terminated contract. This requirement shall not apply in the event the City chooses to employ building service employees directly.

If at any time the successor covered building service vendor determines that fewer employees are required to perform the new service contract than had been performing such services under the expired or terminated contract, the successor covered building service vendor shall retain the covered building service employees by seniority within job classification. Except for such layoffs, during the 90-day transition period, the successor covered building service vendor shall not discharge without cause a covered building service employee pursuant to this section. During the 90-day transition period, the successor covered building service vendor shall maintain a preferential hiring list of those covered building service employees not retained from which the successor vendor or its subcontractors shall hire additional employees. At the end of the 90-day transition employment period, the successor covered building service vendor shall perform a written performance evaluation for each covered building service employee retained pursuant to this Ordinance. If a covered building service employee's performance during such 90-day period is satisfactory, the successor covered building service vendor or subcontractor

shall offer the covered building service employee continued employment under the terms and conditions established by the successor covered building service vendor or subcontractor or as required by law.

24-7.6 Provision of Standard Compensation to Covered Building Service Employees

a. All covered building service vendors shall provide all covered building service employees with no less than standard compensation. All covered lessors shall ensure that all covered building service employees employed in or around the building to which the relevant lease pertains are provided with no less than standard compensation for the term of the lease. All covered lessees that enter into a contract with a vendor to provide building services at a covered City-owned property shall ensure that all covered building service employees are provided with no less than standard compensation for the term of the lease.

b. The City of Boston shall maintain a list of covered leases, leases of covered City-owned property, and covered building service contracts. The list shall include the addresses of: properties that are the subject of covered leases, City-owned property, and locations covered by covered building service contracts.

c. Calculation of Standard Compensation

Standard compensation shall include, for the relevant classification:
 the standard hourly rate of pay, 2) standard paid leave, and 3) standard benefits.

i. The "standard hourly rate of pay" for covered building service employees other than unarmed or armed security guards shall be the greatest of the following:

 The Living Wage rate as defined in 24-6.2; or (2) the prescribed rate of wages as determined by the Director of the Department of Labor Standards pursuant to section 27H of the Massachusetts General Laws.

ii. The "standard hourly rate of pay" for unarmed security guards shall be the greatest of the following:

(1) The Living Wage rate as defined in 24-6.2; or (2) the prescribed rate of wages as determined by the Director of the

Department of Labor Standards pursuant to section 3 of chapter 195 of the Massachusetts Acts of 2014.

iii. The "standard hourly rate of pay" for armed security guards shall be the greatest of the following:

(1) The rate established by the Federal Department of Labor for the Guard II classification in the Area Wage Determination applicable to work performed within the County of Suffolk under the Federal Service Contract Act (41 U.S.C. 351, et seq.); or (2) the prescribed rate of wages as determined by the Director of Labor Standards pursuant to the State Prevailing Wage Law, section 3, Chapter

195 of the Acts of 2014.

iv. The "standard hourly rate of pay" for covered building service employees other than for unarmed or armed security guards shall be annually adjusted to be no less than the greatest of the following:

> The current Living Wage rate as defined in 24-6.2; or (2) the current prescribed rate of wages as determined by the director of the department of labor standards pursuant to section 27H of chapter 149 of the General Laws of Massachusetts.

v. The "standard hourly rate of pay" for unarmed security guards shall be annually adjusted to be no less than the greatest of the following:

(!) The current Living Wage rate as defined in 24-6.2; or (2) the current prescribed rate of wages as determined by the director of the department of labor standards pursuant to section 3 of chapter 195 of the Massachusetts Acts of 2014.

vi. The "standard hourly rate of pay" for armed security guards shall be annually adjusted to be no less than the greatest of the following:

(1) The current rate established by the Federal Department of Labor for the Guard II classification in the Area Wage Determination applicable to work performed within the County of Suffolk under Federal Service Contract Act (41 U.S.C. 351, et seq.); or (2) the current prescribed rate of wages as determined by the Director of Labor Standards pursuant to the State Prevailing Wage Law, Section 3, Chapter 195 of the Acts of 2014. vii. "Standard paid leave" for covered building service employees other than for unarmed or armed security guards shall be equal to the greatest of the following:

(1) Annual paid leave required under applicable local, state, or federal law; or (2) the paid leave provided under the prescribed rate of wages as determined by Director of the Department of Labor Standards pursuant to section 27H of chapter 149 of General Laws of Massachusetts.

viii. "Standard paid leave" for unarmed or armed security guards shall be equal to the greatest of the following:

 Annual paid leave required under applicable local, state, or federal law; (2) the paid leave provided under the prescribed rate of wages as determined by the Director of the Department of Labor Standards pursuant to section 3 of chapter 195 of the Acts of the Massachusetts Acts of 2014.

ix. The "standard benefits" for covered building service employees other than for unarmed or armed security guards shall be an hourly supplement furnished by a covered building service employer to a covered building service employee in one of the following ways:

(1) in the form of health and other benefits (not including paid leave) that cost the covered building service employer the entire required hourly supplemental amount;

(2) by providing a portion of the required hourly supplement in the form of health and other benefits (not including paid leave) and the balance in cash; or (3) by providing the entire supplement in cash. The required hourly supplemental rate for covered building service employees other than for unarmed or armed security guards shall be equal to the monetary value of the

xi. The "standard benefits" for armed security guards shall be an hourly supplement furnished by a covered building service employer to a covered building service employee in one of the following ways:

(1) in the form of health and other benefits (not including paid leave) that cost the covered building service employer the entire required hourly supplemental amount; 2) by providing a portion of the required hourly supplement in the form of health and other benefits (not including paid leave) and the balance in cash; or 3) by providing the entire supplement in cash.

The required hourly supplemental rate for armed security guards shall be equal to the greatest of the following:

(1) The monetary value established by the Federal Department of Labor for the Guard II classification in the Area Wage Determination applicable to work performed within the County of Suffolk under Federal Service Contract Act (41 U.S.C. 351, et seq.); or (2) the monetary value of the health and other benefits (not including paid leave) provided under the prescribed rate of wages as determined by the director of the department of labor standards pursuant to section 3 of chapter 195 of the Massachusetts Acts of 2014.

xii. The "standard benefits" for building service workers other than unarmed or armed security guards shall be adjusted annually to be no less than equal to the current monetary value of the health and other benefits (not including paid leave) as determined by the director of the department of labor standards pursuant to section 27H of chapter 149 of the General Laws of Massachusetts.

xiii. The "standard benefits" for unarmed security guards shall be adjusted annually to be no less than equal to the current monetary value of the health and other benefits (not including paid leave) provided under the prescribed rate of wages as determined by the

Director of the Department of Labor Standards pursuant to section 3 of chapter 195 of the Massachusetts Acts of 2014.

xiv. The "standard benefits" for armed security guards shall be adjusted annually to be no less than equal to the value of the greatest of the following: (1) The current monetary value established by the Federal Department of Labor for the Guard II classification in the Area Wage Determination applicable to work performed within the County of Suffolk under Federal Service Contract Act (41 U.S.C. 351, et seq.); or (2) the current monetary value of the health and other benefits (not including paid leave) provided under the prescribed rate of wages as determined by the director of the department of labor standards pursuant to section 3 of chapter 195 of the Massachusetts Acts of 2014.

2. For the purposes of this Chapter, "benefits" shall not include workers compensation or other legally mandated insurance, nor shall it include the value of any benefit for which the covered building service employee is eligible, but for which no payment is actually made by a covered building service employer to the covered building service employee or to any other party on the covered building service employee's behalf because the covered building service employee either does not actually utilize or does not elect to receive the benefit for any reason.

# ORDER FOR A HEARING TO DISCUSS INVESTMENTS IN ELECTRIC VEHICLE CHARGING INFRASTRUCTURE & ELECTRIFYING THE CITY OF BOSTON'S VEHICLE FLEET

- **WHEREAS**: Climate change is increasing the frequency of extreme temperature events, intense precipitation, and cyclones; and contributing to rising sea levels that we have witnessed in recent years in the City of Boston; *and*
- **WHEREAS:** In order to slow the progress of climate change, the City of Boston has committed to becoming carbon neutral by 2050. Transportation accounts for nearly a third of Boston's total GHG emissions, 65 percent of which comes from personal vehicles; *and*
- **WHEREAS:** To reach carbon neutrality, the City seeks to incentivize the use of zero-emission vehicles, ensuring that 23 percent of new car purchases in the City are electric vehicles by 2025, and that every household is within a 10-minute walk of an EV car share facility or a publicly accessible charging station by 2030; *and*
- **WHEREAS:** The City of Boston not only intends to encourage the adoption of personal EVs, but is adopting EVs to replace its own municipal fleet. Under the City's Electric Vehicle Readiness Policy, all vehicles purchased for the Central Fleet must be EVs or zero emission vehicles (ZEV), or best in class if an appropriate ZEV is not available, with the goal of having a fully emissions free fleet by 2060; *and*
- WHEREAS: The available charging infrastructure does not meet current demand and is insufficient to further encourage a transition to EVs. As of 2019, there were 658 Level 2 and 51 Direct Current Fast Charging (DCFC) publicly accessible chargers within Boston, the equivalent of one charger for every 1,000 residents; *and*
- WHEREAS: To address this shortage, the City of Boston mandated in 2020 that development projects that require the Boston Transportation Department's TAPA approval and/or the Article 80 Large Project Review must equip 25 percent of their total parking spaces to be Electric Vehicle Supply Equipment (EVSE)-Installed and the remaining 75 percent of the total spaces to be EV-Ready; and
- **WHEREAS:** Aside from building EV charging stations at private developments, the city should also discuss and provide an update regarding expansion of EV infrastructure at
facilities such as at our BCYF centers, Boston Public School parking lots, and other municipal buildings & parking lots; *and* 

**WHEREAS:** In the most recent bipartisan infrastructure bill by the Biden Administration, there is a proposed \$7.5 billion in funding to build EV charging stations across the country, which presents an unprecedented opportunity for our city to expand our EV infrastructure; *and* 

## NOW THEREFORE BE IT ORDERED:

That the appropriate Committee of the Boston City Council holds a hearing to discuss measures to further invest in EV infrastructure. Representatives from the Boston Planning and Development Agency, Boston Transportation Department, the Office of Neighborhood Services, as well as other relevant and interested parties shall be invited to attend.

## ORDER FOR A HEARING REGARDING EMERGENCY HOUSING TRANSFERS FOR THOSE FACING COMMUNITY-BASED VIOLENCE

- **WHEREAS**: Victims of community-based violence such as shootings or stabbings include the individual victims as well as their family members and it is often difficult for these members of our community to continue to feel safe in their home after a violent incident takes place; *and*
- *WHEREAS*: The emergency housing process is often long and bureaucratic, and reimagining the application and approval approach could go a long way in supporting residents in need of emergency housing due to community-based violence; *and*
- **WHEREAS:** A process to reimagine the application and approval process for emergency housing could include a review of the amount of 'proof' of trauma required and a reduction to the number of officials currently required to read and approve each application; *and*
- **WHEREAS:** The Department of Housing and Urban Development provides a Public Housing Occupancy Guidebook to assist public housing agencies (PHAs) and outlines that a transfer may be used to: Alleviate a verified medical condition of a life-threatening nature; Alleviate a threat assessed by a law enforcement professional; or Protect members of the household from criminal activity at the property or in the neighborhood; *and*
- *WHEREAS*: There is a large disparity in resources provided to residents experiencing displacement resulting from community violence or a broader definition of violence and transitional resources available to homeless or recovering populations are extensive, with most resources for violence centering on domestic violence survivors; *and*
- **WHEREAS:** The City of Boston recently dedicated \$200,000 from the American Rescue Plan (ARP) for the purpose of "providing housing solutions for families impacted by violence" and relevant departments have been engaging with stakeholders about a permanent and sustainable infrastructure and source of funding; *and*
- **WHEREAS:** Currently our city's service providers working to support victims of violence and their families, including our hospitals and community-based organizations like the

Peace Institute, work urgently to secure emergency housing on a case-by-case basis with the City's Department of Neighborhood Development and housing service providers; *and* 

- *WHEREAS*: In addition to the challenge of funding the city is facing the challenge of low to non-existent housing inventory particularly because we do not set aside housing or have community-based violence qualify for prioritization; *NOW THEREFORE BE IT*
- **ORDERED**: That the appropriate committee of the Boston City Council hold a hearing to discuss the challenges and opportunities as it relates to emergency housing transfers for victims of community-based violence and that representatives from social service organizations, healthcare institutions and the public be invited to testify.

- *WHEREAS*, The first national "Co-op Month" was celebrated in 1964 by the U.S. Department of Agriculture and has been celebrated every October in the United States of America; *and*
- *WHEREAS*, Co-operatives are businesses that are locally owned by everyday people who join together to achieve shared goals, solve a challenge or meet a community need, together; *and*
- *WHEREAS*, Co-operatives are recognized in the laws and statutes of Massachusetts as member or user-owned, user-governed and user-benefiting enterprises, giving people a real stake in their economic destiny and the future of their communities; *and*

*WHEREAS,* Co-operatives enable people to meet a wide variety of needs, goals and aspirations including healthy food, employment, farm products, financial services (credit unions), electric, telephone and cable services, and health care, housing, and insurance; *and* 

*WHEREAS,* In the United States, there are about 65,000 co-operatives, and one out of every three people is a member of at least one co-op or credit union; *and* 

*WHEREAS,* Around the world, there are about 3 million co-operatives, and about 12% of the human population are members of a co-op, and about 10% of the world's population, or around 280 million people, are employed by co-ops; *and* 

*WHEREAS,* The Commonwealth of Massachusetts has 6 food co-ops: Franklin Community Co-op in Greenfield and Shelburne, Leverett Village Food Co-op of Leverett, Old Creamery Co-op of Cummington, Quabbin Harvest Food Co-op in Orange, River Valley Co-op in Easthampton & Northampton and Wild Oats Co-op Market in Williamstown; and the state of Massachusetts has 3 start up initiative food co-ops: Assabet Co-op Market in Maynard, Common Share Food Co-op in Amherst and Dorchester Food Co-op in Dorchester, which collectively are owned by over 21,580 local members, together, employing more than 340 people, generating over \$49 million in annual revenue, and selling more than \$11.5 million in local products; *and* 

*WHEREAS*, Last year, more than 1,315 people in Massachusetts joined our member food co-ops in our Commonwealth, sharing in the ownership of their local co-operative grocery store; *and* 

*WHEREAS,* Co-operatives play a major role in the regional economy of Boston, Massachusetts; *and* 

*WHEREAS*, The co-operative philosophy of working together for the common good has promoted community, well-being and improved the quality of life for citizens of Dorchester and Boston; *and* 

**WHEREAS,** Dorchester Food Co-op is joining with other members of the Neighboring Food Co-op Association in endorsing the Co-op Month 2021 theme established by the National Co-operative Business Association / CLUSA International, as "*BUILD BACK FOR IMPACT*," emphasizing the manner in which co-operative enterprises are helping our communities rebuild from the pandemic in a more inclusive, resilient and sustainable manner; *and*

The City Council shall consider each ordinance or loan order so presented and shall either adopt or reject the same within sixty days after the date when it is filed as aforesaid. If such ordinance or loan order is not rejected within sixty days, it shall be in force as if adopted by the city council unless previously withdrawn by the mayor.

#### 2 - Section 17F of Chapter 452 of the Acts of 1948 (as amended):

The city council may at any time request from the mayor specific information on any municipal matter within its jurisdiction, and may request his presence to answer written questions relating thereto at a meeting to be held not earlier than one week from the date of the receipt of said questions, in which case the mayor shall personally, or through a head of a department or a member of a board, attend such meeting and publicly answer all such questions. The person so attending shall not be obliged to answer questions relating to any other matter.

### <sup>3</sup>Section 22 of Chapter 190 of the Acts of 1982:

Every order of the city council approving a petition to the general court pursuant to Clause (1) of Section 8 of Article 2 of the amendments to the Constitution of the Commonwealth shall be presented to the mayor who shall forthwith consider the same, and, within fifteen days of presentation, either approve it, or file with the city council a statement in detail of his reasons for not approving the same, including any objection based on form, on content, or both; provided, that no such order shall be deemed approved or in force unless the mayor affixes his signature thereto.

## **Matters in Committee**

The following matters were previously filed with the City Council and have been referred to a committee. Matters in committee can be brought back before the City Council pursuant to City Council Rule 24. The following *definitions* describe different types of matters in committee:

Ordinances:	Local laws enacted by the Boston City Council and the Mayor that become part of the City Code of Ordinances.
Loan Orders:	Authorization for the City of Boston to incur debt and expend money for projects, purchases, or other obligations.
Orders:	Directives that authorize action. Orders are legally binding but are not part of the City Code of Ordinances.
Home Rule Petitions:	Requests for special acts that concern a particular municipality. Home Rule Petitions require approval of the Boston City Council and Mayor, as well as passage by the state legislature.
Order for a Hearing:	A formal request sponsored by a councilor that a committee of the Boston City Council conduct a hearing about a particular matter, issue, or policy that impacts the City of Boston. An Order for a Hearing is not a law and is not voted on by the City Council. The only action concerning an Order for a Hearing that can be taken at a City Council meeting is the administrative action of placing it on file.

Legislative Resolution: A recommendation concerning policy issues that may urge action on particular matters. Legislative resolutions have no legal effect. Legislative resolutions represent a particular position or statement by a Councilor, Councilors, or the City Council as a whole.
